POST-POLLS VIOLENCE

Over 1,000 sued, 25 BNP men held in Nabiganj

Police sued over 1,000 people after Wednesday's post polls violence in Nabiganj municipality of Habiganj district and arrested 25 BNP and JCD men yesterday in connection with the inci-

At least 40 people, including eight policemen, were injured in post-election violence in the municipality.

Police were trying to disperse a crowd that gathered to bring out a procession protesting alleged irregularities in Tuesday's polls in which BNP-backed mayoral candidate Abdus Shahid Golap lost to the Awami League-backed candidate by 112 votes.

A clash broke out and police used 30 rubber bullets and lobbed 15 tear-gas canisters.

Locals said a police contingent led by the officer-incharge of Nabiganj Police Station went to Hajari Community Centre around 4:00pm and asked the protesters to stop their rally and marching in a procession.

At one stage police resorted to charging truncheons.

The protesters vandalised a police van and had the contingent of police pinned down.

On information, another contingent of police reached the scene and fired about 30 people were injured and 12 Sarkar Shahid at Natun rubber bullets to free the shops ransacked in post Bazar on Tuesday evening. surrounded policemen. Husband's brutality turns her maimed

Seriously injured by husband for protesting his alleged illicit relation, a young housewife is groaning in pain at Dinajpur Medical College and Hospital (DJMCH).

The victim, Mahfuza Begum, 25, received stab injuries on different parts of body by her husband Masud Rana, 30, who also severed her left ankle joint with a sharp weapon at his Haldibari-Mondolpara village house in Parbatipur upazila of Dinajpur district

Medical College Hospital.

on Wednesday afternoon, said the victim's family members.

Mahfuza, daughter of late Mahbub Alam of Chowdhurypara village in Gaibandha Sadar upazila, has three children including a girl reading in class III.

"Masud, a rickshaw puller working in Dhaka, returned home about two weeks ago. All the time he remained busy talking over mobile with a woman, raising my suspicion. As I protested, Masud got angry and engaged in a bitter argument with me on Wednesday afternoon. He started stab-

bing me indiscriminately. At one stage, he slashed my left ankle joint and severed it by chopping," said Mahfuza lying on the floor at orthopaedic department of DJMCH.

neighbours came to her rescue and took her to Parbatipur Upazila Health Complex in a critical condition. Following doctors' suggestion, profusely bleeding Mahfuza was admitted to Dinajpur Medical College and Hospital at 7:40pm the same day.

Doctors of DJMCH conducted a six-hour-long surgery at the night and she required at least 160 stitches

at different parts of body. Locals handed over Masud Rana to Parbatipur police on Wednesday evening and Mahfuza's Hearing her scream, the mother Jamila Begum filed a case accusing him, said Nuruzzaman Chowdhury, officer in charge of Parbatipur

police station. "What will happen to my three children? My husband has so far neglected his duty to them. Nobody will give me job as I have become maimed," said

Mahfuza.

Stalker injures college girl

An alleged stalker seriously injured a college girl by hitting her with his motorcycle in Shibchar upazila of the district yesterday.

The victim is Amena Akter, 17, an HSC student of Nurul Amin University College in the upazila.

Amena along with her classmates was going to attend a cultural programme at GC Academy in nearby Bhadrasan area. As they came closer to the academy stalker Mizan along with two friends hit Amena with motorcycle from behind, leaving her seriously injured, sources said.

She was rushed to local upazila health complex, where the on duty doctors referred her to the Orthopaedic Hospital in the capital as her left leg was broken and two ligaments were torn.

Hearing the news, the agitated students of the college barricaded the highway for one hour demanding punishment of the criminals.

On primary investigation, police found the incident was intentional, said Subinspector Mohammad Salah Uddin of Shibchar police station.

Locals brought out a procession at Roumari upazila headquarters yesterday afternoon demanding immediately transfer of the upazila nirbahi officer (UNO) for his alleged bribery.

Earlier on Wednesday, lawmaker from Kurigram-4 (Chilmari, Raumari and Rajibpur) constituency Md Zakir Hossen locked offices of seven officers as they were absent in a meeting called by the upazila Bangladesh Rural Development Board (BRDB) officer following the lawmaker's instruction.

The offices of the UNO, woman affairs officer, BRDB officer, upazila engineering officer, upazila forest officer, upazila cooperatives officer and upazila primary education officer were kept under lock and key from 3:00pm to 4:30pm on the day.

Lawmaker Zakir Hossen told this correspondent, "As I received complaints of taking bribe for preparing beneficiaries' list for the 11th batch of 'Job opportunity programme for ultrapeople of the northern region' under the BRDB a few days ago, I requested the

"Nobody had informed me about the meeting on Wednesday when I joined a scheduled meeting as chief guest at the information centre of Datbhanga union under the upazila and earth lifting programme in the union," he said.

"After arriving at my office I saw it locked. I informed the deputy commissioner of the matter and tried to open the office with the help of police. At that time, the MP misbehaved with me. Later the office was opened following the MP's order at 4:30pm," he added.

7 jailed for sand lifting
