## PCJSS-UPDF clashes turn CHT volatile

The recent incidents of killing and abduction, especially in the wake of violent clashes between pro-peace treaty Parbatya Chattagram Jana Sanghati Samity (PCJSS) and anti-peace treaty United People's Democratic Front (UPDF), has made Chittagong Hill Tracts (CHT) region tense

again. "Armed groups of both PCJSS and UPDF have become desperate to control hill areas and collect tolls from commoners. Involved in killing, abduction and extortion, they are trying to overthrow each other," Rangamati Superintendent of Police Masood-ul-Hasan

told this correspondent yesterday.

Six PCJSS men and one from UPDF were killed in a gunfight between the armed members of the two rival organisations at remote Fakirachhara Bastipara in Moidang union under Jurachharai upazila of Rangamati district on Friday.

On the same day, an activist of PCJSS was gunned down allegedly by the armed men of UPDF at Gaborchhara village in Rikhali union under Rajasthali upazila of the

As signatory to CHT peace deal in 1997, PCJSS wants its full implementation. PCJSS leaders are blaming the government for 'dilly-dallying' in implementation of peace accord.

UPDF, on the other hand, termed the peace treaty 'not sufficient for the jummo people'. They are demanding full autonomy in CHT for 'lasting peace' there.

PCJSS leaders at protest rallies on different occasions said armed activists of UPDF are killing PCJSS leaders and activists and extorting common people, particularly indigenous people.

They urged the government to ban UPDF to 'remove the main barrier in the way to implementing the peace deal'.

UPDF also blamed PCJSS for killing and kidnapping their leaders and activists and collecting tolls from common people.

Two more buildings under threat

The Kholpetua River in Shyamnagar upazila of Satkhira district devoured the office building of Satkhira Forest Range and the forest staffs' hostel in the Sundarbans on Friday evening.

At least 18 family members of the forest guards and boatmen have already been shifted to safer places as two residential buildings built for the forest guards and boatmen in the Sundarbans are threatened due to continuous erosion by the river.

ment, the headquarters of 7 Bangladesh Border Guards (BGB) at Nildumur adjacent to the Sundarbans and at least ten villages including Bhamia, Porakatla, Burigoalini and Durgabati in Shyamnagar upazila are under risk.

The forest range office, a hostel and two residential buildings were built for the forest officials, forest guards and boatmen about 1000 yards off of the river Kholpetua in 1975-76 financial year, said forest guard Golam Sarowar and boatman Abdur Razzak.

But due to continuous river erosion over the years, the embankment of the river reached near the office and residential areas and the office, a hostel and two residential buildings in the Sundarbans went into the river under heavy pressure of water at about 7:30pm on Friday.

Lt Col Anisur Rahman, commanding officer of 7 BGB Battalion, who visited the spot, told this correspondent that he has informed the concerned authorities including Water Development Board (WDB) officials of the matter to take measures as soon as possible.

Contacted, Assistant Conservator of Forest Toufiqul Islam of the Sundarbans Forest Range (Western Zone) said they informed the WDB officials of the matter earlier but no steps were taken to save the build-

Local WDB officials did not visit the spot as of writing this report.

Even after repeated attempts, WDB Executive Engineer Mujibur Rahman could not be contacted as this correspondent's cell phone call was received.

The High Court recently delivered a verdict banning physical punishment to children at educational institutions.

### 11-month-old child rescued 18 days into abduction

Mirzapur police yesterday rescued an 11-month-old child after 18 days of his abduction and arrested an abductor couple from Rasulpur in Tangail Sadar upazila and Musinda village in Kalihati upazila.

The rescued child is Nayon, son of Ali Ahmed of Gorai Nazirpara village in Mirzapur upazila and the arrested couple is Abdul Matin, 60, and his wife Moriam Begum, 50, of Char Koptas village in Sirajganj Sadar upazila.

Habibullah Sarkar, officer-in-charge (OC) of Mirzapur Police Station, said Abdul Matin rented the house of Ali Ahmed a few months ago introducing himself as a cloth trader.

Matin abducted the child of his house owner, Noyon on January 4. Later, in a telephone call, he demanded Tk1lakh from Ali

Ahmed as ransom and asked him to keep the ransom money on the railway track at Rasulpur in Tangail Sadar upazila at 9:00pm on Friday.

Meantime, Ali Ahmed informed the matter to police. Police arrested Abdul Matin red-handed while receiving the ransom money yesterday morning.

#### Rare species vulture rescued

A rare species vulture was rescued by locals when it was hit by a full voltage electricity wire near Srimongal upazila town on Thursday. The near extinct vulture is now under treatment at the mini zoo of Sitesh Ranjan Deb at Srimongal town. Every day a large number of people are visiting the zoo to see the vulture. Zoo owner Sitesh Ranjan Deb, also an eminent wild life expert said, the right wing of the 10-kg vulture was seriously injured after being hit by a full voltage electricity wire at Uttarsur village near Srimongal town on Thursday. Instantly the vulture fell down the ground. Local people caught the injured vulture. Later, Sitesh brought it to his zoo. The zoo owner is giving treatment to the near extinct bird which is rarely seen in our country. Sitesh said about 15 to 20 days will be needed for complete cure of the bird. Afterwards, the vulture will be freed, Sitesh said.
