Unlicensed brick kiln in densely populated area

The chairman of Auliapur Union Parishad in Patuakhali Sadar upazila has set up a brick kiln occupying over 0.50 acres of khas land in a densely populated area at East Auliapur village under the upazila without permission from the authorities concerned.

Owner of the illegal brick kiln, Humayun Kabir is also joint general secretary of Patuakhali Sadar upazila unit of ruling Awami League.

The kiln area is located beside Sehakathi canal adjacent to Kabir's village house.

According to Section 4(1) of the Brick Burning (Control) Act, 1989, nobody can office Ashraf Hossain, who Department of Barisal.

set up brickfield or burn also maintains the file at the Environment." bricks without taking office. licence.

The same act prohibits setting up of brickfield in densely populated areas and using wood as fuel for baking bricks.

Ignoring the law, Humayun Kabir set up a brickfield on the khas land.

However, he submitted a prayer seeking licence to the deputy commissioner (DC) in Patuakhali in June last

"Humayun Kabir submitted his prayer for setting up a brickfield in his area without any 'No objection certificate' from the Department of Environment. So the DC office is yet to issue the licence," said Najir of DC

During a visit to the brickfield, this correspondent saw pile of wood that was kept on the premises for use as fuel to bake bricks.

The brickfield started in December last year and at least 80,000 bricks have already been sold from it, said a worker of the field seeking anonymity.

Asked about the matter, Patuakhali Sadar Upazila Nirbahi Officer Md Zakir Hossain said he does not know about it.

When contacted, Patuakhali DC Mohammad Eusuf said, "We consider the prayer for setting up a brick field only after receiving certificate from the

"We have not issued environmental certificate to Humayun Kabir till now. His prayer is pending and we will consider the matter after proper investigation," said Asadul Haque, deputy director of the Department of Environment in Barisal.

"Nobody can start brick production without permission. We will take step with the help of mobile court soon," he added.

When contacted, Humayun Kabir, owner of the brickfield, said, "I submitted necessary papers to the DC office seeking permission. I also submitted papers seeking 'no objection' certificate from the environment department in

Gupta era relic damaged for 'development work'

Bogra Sadar Upazila Parisad recently implemented a rural road project in Sarkarpara area destroying brick built structures of ancient Gupta period.

Implemented under 'Karmo Srijoni programme', the road project started on October 16 and completed on December 18 last year, Project said Implementation Officer (PIO) in Bogra Sadar, Shamsunnahar Sheuly.

The whole process was done without the knowledge of the Department of Archaeology although it is a

protected site under the department.

After being informed, Naheed Sultana, custodian Mahasthan Archaeological Museum, on 19 January lodged a general diary with Bogra Sadar police station enclosing a copy of the Archaeology Act for necessary action. She also sent a letter to Bogra Sadar Upazila Nirbahi Officer (UNO) Sultana Pervin in this regard.

Asked about the matter, the UNO said that local people made a rural road using ancient bricks and soil of the protected archaeological site but it was unknown to the project authority.

Regional Director of the Department of Archaeology Md Badrul Alam told this correspondent that the authority has taken initiative to protect the site according to the Antiquity Act.

Taleb Ali, 85, and a few other local people said that at least 700 metre newlt built road cut through the site.

A few months earlier, Bogra Sadar upazila parishad started a similar project destroying another ancient archaeological site 'Boro Tagra' that also included structures of Gupta period. However, the project was suspended following protests from different quarters.

A poultry development officer and his wife have been arrested on charge of causing serious burn injuries to their 12-year-old domestic help at their Netrakona municipality nouse.

Dr Shishir Chakma of village Udalbagan under Dighinala upazila in Khagrachhari district joined Netrakona District Duck Rearing Unit' at Rajur Bazar in Netrakona municipality three years ago.

In March last year, he took Laxmishita Chakma from Khamarbari, a village adjacent to Udalbagan, to work

as his domestic help. Chakma used to beat Hospital.

On Tuesday midnight, Jesika beat up Laxmishita over the issue of stealing some money. At one stage Jesika struck her with a heated iron bar on different parts of the body, causing serious burn injuries to her, said police and locals.

As the news spread in the area on Wednesday morning, hundreds of local people besieged the duck rearing unit and informed police. Police rushed to the spot and arrested Shishir Chakma and Jesika Chakma

Of the accused, six confessed to their involvement in the mutiny at the battalion in Naogaon town on February 26 in 2009 and begged mercy while the rest claimed innocence.

Model Police Station Aminul Islam filed a mutiny case against 25 BDR jawans of 43 battalion with the Chief Judicial Magistrate's Court on May 17, 2009. The mutineers were later arrested and produced in

complainant alleged that jawans looted firearms from the battalion armoury and fired blank shots. They also revolted against their officers and took control of the battalion headquarters.

On December 21 last year, the court completed recording depositions of 21 prosecution witnesses in the mutiny case. Arguments between the prosecution witnesses and the accused completed on December 22 last year.
