FROM PAGE 1 tolerance and allow opposition lawmakers, who are very small in number this time, to play their due role.

On the other hand, BNPled opposition lawmakers seem to have forgotten their constitutional duties to perform in the parliament as well. Their activities also demonstrate a lack of interest in making the House functional.

They have already boycotted 130 out of total 174 sittings of the ninth parliament, paying no attention to their electoral pledge of ending the culture of boycott. And it is still uncertain whether they will return to the parliament's new-year session which begins today. As if they are afraid that their contribution to making the parliament functional will only brighten the government's image.

The prevailing situation predicts that the current parliament may face the same fate of the previous ones that could not be effective due to successive ruling parties' "winner takes all' attitude, and frequent boycotts by the main oppositions.

Constituted after more than two years of political disorder, the ninth parliament, which steps into the third year today, was expected to be the main force for change in the political culture.

Against the backdrop of misrule of the previous regime and growing political conflict, the ruling AL's electoral pledges styled "A

Charter for Change" gave rise to a widespread expectation of change in the public mind.

The people seemed to have confidence in the pledges, and they gave AL a landslide mandate in the December 29, 2008 parliamentary polls.

The AL-led government itself also termed the new Jatiya Sangsad a "parliament for change" through the president's address to the inaugural session of the ninth parliament, which was approved by the cabi-

The then president Iajuddin Ahmed on January 25, 2009 delivered the address in which he said, "The people of this country have given mandate to the newly elected government to bring a massive change in their political and economic lives."

After almost a year, the AL-led government seemed to have acknowledged that the current parliament could not deliver on the people's expectation for change in its first one year.

The ruling party identified confrontational political culture as the major obstacle to change.

Incumbent President Zillur Rahman on January 4, 2010, in his first address to the parliament, stressed the need for changing the political culture to realise the people's dream.

But what happened in the last one year since then?

The situation did not improve, rather the perennial animosity between

"Tolerance and decency will be developed in the political culture. Efforts will be taken to formulate a code of conduct acceptable to all," the AL electoral manifesto read.

Wealth statement and the cabinet, parliament members, and of their family members would be made public every year, it pledged.

But almost all of the pledges still remain only on paper. No move was taken in last two years in line with the pledges.

Prime Minister also Leader of the Parliament Sheikh Hasina on January 6 in her speech to the nation, marking two years of the ALled grand alliance government, however claimed that her government made the

parliament the centre for practicing democracy.

The current parliament did witness a good beginning. The parliamentary committees were formed in the inaugural session, and opposition lawmakers were given the helms of three parliamentary bodies -- all for the first time in its history.

But soon the culture of parliament boycott returned, and took the shine off those successes. First the opposition said they were staying away from the House proceedings to protest the seating arrangements, and later they raised a number of other issues as well to justify the boycott.

Similar practice in the past had prevented the parliament from functioning effectively. In the fifth, seventh and eighth parliaments, opposition lawmakers boycotted around a half of the total sittings.

President Zillur Rahman in his first address to the parliament last year source of income of the observed that the prevailing prime minister, members of political practice should be changed first, if the "charter for change" is to be realised. There should be an end to the politics of conflict, he said.

Unfortunately, the practice was not changed; rather the situation has deteriorated to quite an extent.

The president is expected to evaluate last year's political situation in his address to the parliament today. The government's stance will be reflected in his address as the cabinet approved his speech.

profits to their reserve instead of distributing those among shareholders.

The central bank issued the directive after a highlevel meeting on Sunday with the finance minister to stabilise the share market.

The directive was issued to 11 banks yesterday, and earlier four other banks were given the order, an official of the central bank said. A central bank high offi-

cial said the directive will make the financial base of the banks stronger, and merchant banks will be allowed to re-invest in the share market remaining within the legal framework. Finance Minister AMA

Muhith also told journalists on Sunday that the institutional investors such as banks, financial institutions and merchant banks could re-invest a part of their profit in the share market.

These were included in the 14-point bailout package for the capital market prepared by the finance ministry yesterday.

"As an institutional investor, we have been providing support to the capital market. It will continue in future," said Mahmud Sattar, president of Association of Bankers Bangladesh and managing director of City Bank.

"The banks cannot invest more than 10 percent of their liabilities in the capital market. We will try to invest our surplus within the legal limitations."

The 30 private banks currently running in Bangladesh made profit of around Tk 13,000 crore in 2010, up 57 percent from the previous year.

According to central bank data, of the amount, around Tk 1,200 crore came from profit made in the share market. Of the total amount, two banks profited Tk 500 crore.

Different quarters have been blaming the involvement of the banks for the recent overpricing of shares in the capital market. They also say that Bangladesh Bank has failed to monitor properly.

However, a BB high official yesterday told The Daily Star that from the beginning of 2009 they have been warning the banks to invest cautiously in the share market. The banks were advised to form merchant banks for operating in stock market.

Participation of banks in the capital market, however, is not that big.

The market capitalisation of the banks is not much yet. On December 31 last year,

the total capital in the share market was Tk 3,50,800 crore of which the exposure of the banks was Tk 12,141 crore.

The BB official said it meant the banks' participation in the share market was 3.58 percent of the total market capital.

The opposition legislators already skipped 48 consecutive sittings since June last year. If they remain absent from 42 more sittings consecutively, they will lose membership as per constitutional provisions.

A number of opposition legislators however had already kept off over 50 consecutive sittings as they were absent when the BNPled opposition parties last joined the House sitting on June 2 last year. The Business Advisory

Committee (BAC) headed by Speaker Abdul Hamid at a meeting yesterday decided that the new-year session with 44 sittings will continue till April 10.

Prime Minister and Leader of the House Sheikh Hasina was present at the

meeting, boycotted by the opposition.

President Zillur Rahman will address the House today amid the opposition lawmakers' continued boycott of its sessions.

Contacted yesterday, BNP legislator MK Anwar said they will decide their next course of action before expiry of the 90-day time limit.

According to the constitution, a member of parliament will lose membership if he remains absent from 90 consecutive sittings without the leave of the House.

Anwar, a national standing committee member of BNP, said they want to join parliament sittings but the atmosphere in the House is not conducive to their return

The opposition lawmak-

ers belonging to BNP, Jamaat-e-Islami and Bangladesh Jatiya Party joined the first sitting of fifth session of the House on June 2 last year. They walked out of it protesting arrest of Mahmudur Rahman, acting editor of the daily Amar Desh. They did not return to the House and boycotted the rest 32 sittings of the fifth session.

They also boycotted the sixth and seventh sessions which had 11 and five sitting respectively. Thus they have remained absent from 48 consecutive sittings.

Briefing journalists after the BAC meeting, Chief Whip of the Treasury Bench Abdus Shahid said a 40-hour discussion will be held on thanks-giving motion on the president's address.
