Three car bombs ripped through crowds near Iraq's shrine city of Karbala yesterday, killing 12 people and wounding dozens in fresh attacks on pilgrims arriving for religious rituals.

"There were three car bomb explosions, two at 8:30 AM (05:30 GMT) and another 30 minutes later," said Nusayef Jassem, the provincial vice chief.

"Twelve people were killed and 150 wounded in the attacks," he said.

Dr Laith Sharifi, an official of the provincial health department, said earlier that 10 people were killed and 50 wounded, with women and children among the victims.

# 'Palestine Papers' stir fury over bowing to Israel

Palestinian offers of major concessions to Israel on Jerusalem and refugees laid out in documents leaked to the press, yesterday provoked an angry and defensive reaction from the Ramallah leadership.

Details of the proposals, laid out during peace talks in 2008, emerged late on Sunday when Al-Jazeera began publishing the first of 1,600 confidential documents known as the "Palestine Papers."

The Arab satellite news channel said the leaks cover more than 10 years of secret talks between Israel and the Palestinians.

The documents, which were shared with British daily the Guardian, stirred surprise and anger among Palestinian officials, with chief negotiator Saeb Erakat dismissing them as "full of distortions.'

"We don't have anything to hide," Erakat told AFP by telephone from Cairo yesterday,

insisting the revelations had been "taken out of context and contain lies."

"Al-Jazeera's information is full of distortions and fraud," he said.

Palestinian president Mahmud Abbas, who is currently in the Egyptian capital for talks with senior officials, insisted that the Palestinian Authority (PA) had shared every development in the peace process with the Arab world's leadership.

"With everything we have done -- in terms of activities with the Israelis or the Americans -- we have given the Arabs details," Abbas said in remarks published by Palestinian news agency Wafa.

"I don't know where Al-Jazeera got these secret things from, and there is nothing hidden from the Arab brothers," he added, adding that Arab nations were kept up to date through the 22-member Arab League based in Cairo.

# Sarkozy lays out G20 agenda

Targets commodities

French President Nicolas Sarkozy said in a speech laying out his G20 agenda yesterday that the world's top economies must agree new measures to curb volatility in commodity markets or risk destabilising food riots.

Speaking to some 300 diplo-

mats and journalists in the Elysee presidential palace, Sarkozy also voiced support for a tax on financial transactions, calling such a move a "moral question" but admitting the idea had many enemies.

"We want regulation of primary commodity financial markets," said Sarkozy, who holds the rotating 2011 presidency of the Group of 20, a grouping of the world's leading rich and developing economies.

"How can you explain that we regulate its presidency.

"If we don't do anything we run the risk of food riots in the poorest countries and a very unfavorable effect on global economic growth," he said. "The day there are food riots, what country at the G20 table will say this does not concern them? I don't see a single one."

Sarkozy has a three-pronged agenda for France's G20 presidency, including tackling volatility in commodity prices, exploring changes to the world monetary system and reforming global economic governance.

He has been meeting with fellow G20 leaders, including US President Barack Obama and China's Hu Jintao, in recent weeks to win support for his plans and assess what France can realistically achieve during

# killing Indian fishermen

Sri Lanka yesterday strongly rejected allegations that its navy had killed an Indian fisherman and warned of "elements" trying to tarnish relations between the neighbouring countries.

Navy spokesman Captain Athula Senarath said its personnel had no involvement in Saturday's reported shooting off the Kodikarai coast in Nagapattinam district, where one fisherman was killed and two were injured.

"Our patrol crafts operating off the northern coast have nothing to do with this reported incident," he said. "There may be some elements involved in trying to tarnish the good relations we have.'

# Lanka denies UN, EU's human rights 'cowardice'

Says HRW annual report

The UN and EU were accused of "cowardice" for claiming to tackle human rights abuses in places like China or Uzbekistan through quiet dialogue and cooperation, Human Rights Watch said in its annual report yesterday.

Highlighting its claim, the HRW report on global human rights violations was issued in Brussels the same day the European Union hosted controversial Uzbek President Islam Karimov amid a flurry of protests from campaigners. The New York-based non-governmental organisation's

executive director Kenneth Roth lambasted "the failure of the expected champions of human rights to respond" to violations in an introduction to the 600-page report covering 100-plus regimes.

In his eyes, the fundamental error made by United Nations Secretary-General Ban Ki-moon and other leading voices is to place the accent on quiet diplomacy, which he says is often a euphemism for "other interests at stake."

Roth cites a "tepid" response from Asian partners to repression in Myanmar, with the report saying the Burmese junta's release of democracy icon Aung San Suu Kyi on November 23 was preceded by no significant steps on 2,100 other political prisoners.

A UK government-commissioned study into food security has called for urgent action to avert global hunger.

The Foresight Report on Food and Farming Futures says the current system is unsustainable and will fail to end hunger unless radically redesigned.

It is the first study across a range of disciplines deemed to have put such fears on a firm analytical footing. The report is the culmination of a

two-year study, involving 400 experts from 35 countries.

The bench came up with the order and rule as the petition sought directives from this court on the government to take appropriate steps to protect public property.

The organisation filed the petition yesterday after The Daily Star ran a series of reports published on January 22-23 on the grabbing of Bhawal estate land.

According to the reports, over 83 percent of the Bhawal estate's 2,516 acres of land has disappeared in the last 60 years from the hands of its custodian, the Court of Wards under the Ministry of Land.

Currently, only 443 acres of the total Bhawal land is registered with the name of its custodian. Surprisingly, 442 civil cases are now pending with the courts of justice regarding the fate of the 443 acres of land, the remnant of the Bhawal estate.

The Court of Wards is also erratically trying to settle an additional 6,977 land settlement petitions to "save" the remaining 443 acres from influential land grabbers.

The third part of the report said "deliberate" neglect by the Ministry of Land during the four-party alliance rule paved the way for a developer to take over 202.76 acres of Bhawal estate land.

The East West Property Development Ltd (EWPD) has developed its housing project near Baridhara on that particular piece of land, according to the report.

During hearing yesterday, Advocate Mahbubul Islam, a counsel for the petitioner, told the court different dishonest land grabbers are occupying hundreds of acres of land of Bhawal estate through illegal means.

The secretary to the land ministry, inspector general of police, deputy commissioner and superintendent of police of Gazipur, custodian of Bhawal estate, and officers-in-charge of Gulshan, Cantonment, Biman Bandar and Khilkhet police stations have been made respondents to the rule.

#### Amnesty slams 'harsh' action for WikiLeaks 'source'

Amnesty International yesterday urged the US authorities to alleviate the "severe" pre-trial detention conditions of Bradley Manning, the US soldier suspected of leaking information to WikiLeaks.

The rights group said the 23-year-old army private has been held in solitary confinement for 23 hours a day in a sparsely furnished cell at the Quantico Marine base in Virginia since July. Amnesty claimed Manning "had been deprived
