Candidates backed by JP appear potential

Five persons are contesting for the mayoral post, 63 candidates for 9 general councillor posts and 21 others for three reserved seats of female councillors in Magura municipality election to be held on Thursday.

The mayor candidates are Altaf Hossain (backed by Awami League), advocate Hasan Seraj Suja (Jatiya Party), Ayub Hossain (BNP), 'rebel' candidate of BNP Farukuzzaman and BM Moon (independent), also a former leader of Jatiyatabadi Chhatra Dal.

The main contest is, however, expected to be limited between Altaf Hossain and Hasan Seraj Suja, said local observers.

"As our party has been dogged by internal feud, two candidates of rival factions Ayub Hossain and union units, party insiders said. Farukuzzaman are fighting for the mayoral posts but none of them are popular in the area. Even they have failed to gain the support of party activists. Grass roots level leaders have already decided to support the Jatiya Party-backed candidate," said a top

leader of municipality unit BNP.

Since July 2009, Magura district unit BNP has been dogged by internal feud over formation of committees at different levels, which has recently spread even to upazila, municipality and

Meanwhile, some AL activists are also supporting Hasan Seraj Suja because they think Altaf Hossain and several other local Awami League leaders have deprived them of all sorts of facilities after the present government assumed power.

The Government of Bangladesh has received a loan from IDA and IFAD for implementing National Agricultural Technology Project-Phase-1. Supply Chain Development Component (SCDC) is one of the components of the project. The implementing agency for this component is Hortex Foundation. Hortex has started the implementation of SCDC and intends to apply a part of this loan for payments under contract for the provision of consultancy services for the project by a consulting firm (International).

The Services include: Request for Expression of Interest (REOI) for short-listing of Consulting Firms for providing various consultants for management support, technical advice and guidance for the implementation of supply chain development activities in commercial farming of high value agricultural commodities with an emphasis on "Strengthening Farmer-Market Linkages in 10 selected Upazilas of Bangladesh."

Short-listed consulting firms will be invited to submit detailed technical and financial proposal to be selected the most competent firm for delivery the services. An international consulting firm will be recruited in accordance with Public Procurement Regulations and World Bank's Guidelines on the use of consultants.

The contract for consulting services will be for 48 person-months of expatriate consultancy services in several disciplines of the SCDC in market led high value agricultural commodities promotion for one year from the date of contract in the current financial year (April, 2011 to November, 2011).

The experience, resources and delivery capacity required:

- Interested consulting firms/organizations should have adequate knowledge on supply chain as well as value chain development management of commercial agricultural farming especially high value agricultural commodities with competent professionals;

Members of Border Guard Bangladesh (BGB) rescued 31 people while they were being trafficked to India through Boroachra border in Benapole yesterday.

Acting on a tip-off, BGB personnel launched a drive in the area and rescued the victims. They were later handed over to Benapole port police.

The victims are Ayesha Begum, 22, Shila Begum, 23, Sathi Begum, 22, Ishanti Mondol, 30, Shapna Begum, 20, Sumi Akhter, 24, Gita Ghose, 22, Hena Begum, 32, Sharmin Akhter, 21, Shimu Begum, 20, Baby Akhther, 5, Akhther Mollah, 25, Enamul Sikdar, 30, Sakhawat Hossain, 40, Nasir Sheikh, 40, Sohag Hossain, 18, Nazmul Hossain, 18, Shanto Mia, 23, Subod Biswas, 43, Alo Ghose, 20, Shahidullah, 21, Mizan, 42, Ujjal Mia, 18, A Alim, 25, Mintu Mia, 30, Ismail Hossain, 24, Ali Akbar, 24, Shariful, 28, Sujan Kumar, 25, Choyon Kumar, 18, and Pronoy Biswas, 24.

BGB Benapole camp incharge Nazrul Islam said a gang of traffickers brought the 31 people from Barisal, Sylhet and Chittagong districts and was sending them to India, promising good jobs.

BGB could not arrest any of the traffickers as they fled the scene, sensing presence of the border guards.

Madrasa student murdered

Police on Sunday recovered a beheaded body of a madrasah student from the bank of the Dharla River at Pachgachhi union under Kurigram Sadar upazila.

Locals found the body of Kafil Uddin, 14, son of Tayab Ali of North Kadomtola village under Sadar upazila. Police and locals said Kafil, a class-six student of Nayarhat Dakhil Madrasah, went to nearby Shulkur Bazar to recharge his cell phone in the evening on January 17. Since then he was missing. On information, police

recovered the body and sent it to Kurigram Sadar Hospital morgue for autopsy.

Contacted, the officer-incharge (OC) of Sadar police station, Md Taharul Islam said they would take action after an investigation.

8 shops gutted

UNB, Sherpur

Eight shops were gutted in a devastating fire at Viadanga bazaar in Sribordi upazila Sunday morning. Fire service sources said, the fire originated from an electric short circuit at a shop at about 8:00am and soon engulfed seven adjacent shops of the market.

On information, fire fighters from Sadar upazila headquarters rushed to the spot and doused the fire with the help of local people.

One killed, 8 hurt as rival groups clash in B' baria

Kishoreganj clash leaves 40 injured

One person was killed and eight others were injured in a clash between two rival groups at Krishnanagar village under Nabinagar upazila of Brahmanbaria district yesterday morning.

The dead was identified as Md Jahangir Alam, 30, son the Md. Nuroo Sarder of the village.

Police and witnesses said the clash was a sequel to a long-standing enmity between Shafial Mia and Kazal Mia of Krishnanagar village. To establish supremacy at the village, supporters of the two equipped with lethal locked in a clash in Kandapara area at around 10:30am, leaving at least nine from both sides injured, according to our correspondent.

Of them, Md Jahangir Alam, 30, succumbed to his injuries on the way to Nabinagar Upazila Heaslth Complex while eight others, including Jahangir's father Md Nuru Sarder, were admitted to the hospital.

The body was sent to Brahmanbaria Sadar Hospital for autopsy. No case was filed with the police station concerned as of attacked them. Alam Bepary of Kamal Pasha 6:00pm yesterday.

that at least 40 were injured in a clash

between two groups over capture of a water body in Austagram upazila on Sunday night.

Police quoted locals as saying that two groups, one led by Kamal Pasha, chairman of Abdullahpur Union in Austagram upazila, and another by Mannar Kha group of Abdullahpur village, clashed over capture of Chhairachandi water body at around 10:00pm.

The feuding groups used firearms, iron rods and other deadly weapons during the clash, leaving at least 50 people from both sides injured. Of them, eight were injured by bullets and sent to Dhaka Medical College and Hospital.

They are Yahiya Khan, 27, Humayun Kha, 26, Rubel Khan, 15, Subar Khan, 20, Sujan Khan, 24, Dulal Mia, 28, Kutub Mia, 40 and Yasmin Akhter, 27. The rest of the injured were admitted

Kishoreganj Adhunik Sadar Hospital, Habiganj Hospital and Austagram Upazila Health Complex.

Mannar Khan group said they went to take control of the water body as per court order, but Kamal Pasha and his men group alleged that they came under attack as Our Kishoreganj correspondent reported they tried to prevent Mannan Khan's men from capturing the water body.
