5 missing as boat collides with trawler in Padma

At least five people went missing as a speedboat collided with a passenger trawler in the Padma River at Louhojang turning point of Mawa on Sunday evening.

Quoting a witness, BIWTC manager Sirajul Haq said the accident occurred at about 5:30pm when a speedboat carrying 13 passengers collided with a trawler with 20 to 25 passengers on board, about two and a halfkilometre away from Mawa ferry terminal.

Soon after the accident, a passenger launch coming from behind rescued the passengers from the river but five people went missing after the incident.

Bailey bridge in Tangail collapses, one dies

Road link with Aricha snapped

One person was killed and 15 others were injured as a bailey bridge near Elasin Bazar in Delduar upazila collapsed on a ditch when a stone-laden truck, four three-wheelers and a motorcycle were crossing it on Sunday afternoon.

Vehicular movement on busy Tangail-Aricha road, especially of heavy vehicles including passenger buses and goods-laden trucks, has remained suspended following the bridge collapse, sources in Roads and station. Highways Department (RHD) said.

However, some light vehicles are trying to cross the area using a LGED

constructed road through an adjacent village.

The bridge collapsed when the stone-laden truck came to its middle point, causing injuries to at least 16 people, police and witnesses said.

Critically injured Afroza Begum, passenger of a three-wheeler, succumbed to her injuries after she was taken to a hospital in Dhaka while the others were admitted to different hospitals including Tangail General Hospital, said Abu Bakar Siddique, officer-in-charge of Delduar police

Being informed, lawmaker of Tangail-6 Khandakar Abdul Baten, Tangail Deputy Commissioner M

Bazlul Karim Chowdhury and Delduar Upazila Nirbahi Officer Shibir Bichitra Barua rushed to the spot, supervised the rescue operations and formed a three-member committee to inquire into the incident.

They also directed the authorities concerned to take immediate steps about five other risky bridges on the road from Tangail to Elasin.

When contacted, Golam Mostofa, executive engineer of RHD in Tangail, could not say how long it will take to resume vehicular movement on the busy road as the matter of repairing or reconstructing the bridge will be decided after higher authorities of RHD inspect the spot.

Over 400 sued for N'ganj clash

Over 400 people were sued in two separate cases filed in connection with Sunday's clash between workers of ACI Pharmaceuticals and police at Siddhirganj in Narayanganj.

A worker of the medicine factory was killed and more than 100 were injured, 15 by bullets, in the clash occurred on the factory premises at Godnail over pay-hike and regularisation of temporary workers.

Sub-inspector Zakir Hossain of Siddirganj Police Station filed the cases with the police station at around 10:00pm on Sunday.

Of the cases, one was filed for obstructing law enforcers in discharging their official duties, attacking police and ransacking vehicles and the other for death of Enamul Haque, a worker of ACI pharmaceuticals.

Meanwhile, Ain O Salish Kendra (ASK) yesterday expressed deep concern over death of the medicine factory worker in clash between workers and police on Sunday.

In a statement, ASK Executive Director Sultana Kamal urged law enforcers as well as company owners to show tolerance to the workers and defuse their

Mayor-elect stabbed in Matiranga

Police and family sources said a group of about 6 to 10 BCL activists led by BCL Matiranga upazila unit vicepresident Md Palas stabbed Aladdin, leaving him critically injured.

Locals rushed him to Matiranga Upazila Health Complex. Later, doctors referred him to Chittagong Medical College and Hospital.

Demanding immediate arrest of attackers, Khagrachhari JCD district unit secretary Md Ibrahim Khalil blamed the BCL men for the attack.

Contacted, Matiranga upazila BCL vice-president Md Palas blamed the internal feud of JCD for the attack.

No case was filed with Matiranga Police Station as of 5:00pm yesterday.

'Forced' pvt coaching, fee hike spark protest at Pabna polytech

Four students expelled for rampage on campus

The authorities of Pabna Polytechnic Institute yesterday temporarily expelled four students of the institute in connection with rampage on Sunday when the agitated students ransacked three rooms of the institution and assaulted a teacher protesting 'exorbitant rise' in private tuition fees.

Later police rushed to the spot and brought the situation under control.

"On Sunday, some unruly students assaulted Md Moniruzzaman, a teacher of the institution, and ransacked the doors, windows and furniture of three rooms of the institution without any reason. We have identified four of them and decided to expel them from the institution till completion of the investigation about the incident," Md Shahjahan Ali, principal of Pabna Polytechnic Institute, told this correspondent yesterday.

Protesting the assault on a colleague, teachers of the institution boycotted their classes yesterday. The college authority also submitted a complaint against them with Pabna police station yesterday.

The temporarily expelled students are Md Sajal of electrical department, Md Hafiz of power department, Md Russel of construction department and Md Mejbah of civil engineering department.

Talking to this correspondent, several students claimed that a few teachers of the institution forced the students to get private coaching from them.

The fees for private tuition was Tk teaching practice." 400 to 500 last year but recently it has been raised to Tk 800 to one thousand, much to the grievance of the students, said a student of power department.

departments submitted an application to the principal about this matter but no step was taken. Later when the students went to talk to the teachers about the issue they misbehaved with the students, sparking the demonstration on Sunday," he said.

The agitating students also denied the allegation of assaulting the teacher.

Shahjahan Ali said, "Following the demand of students we held a meeting with the heads of all departments of the institution last week. In the meeting I instructed the departmental heads to ensure holding regular classes by teachers instead of engaging in private
