## The last and only wish of FF Nosimuddin

At 84, the Liberation War hero still wants to die after state recognition

At the age of 84, freedom fighter Nosimuddin wishes to die after getting recognition from the government.


The Liberation War veteran is now passing his days in a sorrowful condition with his wife Rabeya Begum and their physically challenged son at Karnopur Majhatari village under Lalmonirhat Sadar upazila.

"Nosimuddin used to collect information about movements of Pakistani soldiers and their camps, drew maps on them and submitted to the freedom fighters' commander," recalled his co-fighter Amal Chandra of Moghulhat village.

"The maps drawn by him helped freedom fighters to conduct operations against the occupation forces. Thus he worked as a guide during the Liberation War," he added.

"I fought against Pakistani forces in Sector 6 under the command of the then Wing Commander AKM Bashar," Nosimuddin said wistfully.

"Other freedom fighters



tell their stories to the new generation on various occasions, especially on Independence Day and Victory Day. They join different programmes but I have to remain silent with my glorious stories kept in my heart. All of my co-fighters have been getting benefit from the government. But my name is not even in the list of freedom fighters. People do not even Rosna Begum. knowme," he added.

"After submitting applications four times since 2004, I wrote another one on October 1, 2010 to the Ministry of Liberation War Affairs with the recommendation of our local commander. But I am yet to get

His wife Rabeya Begum said, "We have been living in a hut. I work as day labourer earning Tk 30 to 50 a day that is barely enough."

Freedom fighter Osman Ali said, "Nosimuddin was our co-fighter. I wonder why his name was not put in the list of freedom fighters. Our other co-fighters including Gofur Miah, Amal Chandra, Joynal Haque, Bacchu Miah, Nur Jamal, Shamsul Haque of the village got recognition from the government and people pay respect to them."

"Families of other freedom fighters are well respected in the society. But we are isolated as my father's name was not included in the list," said Nosimuddin's daughter

The commander of Lalmonirhat district freedom fighters' unit Yasuf Ali said his office has already sent letter to the ministry concerned for including Nosimuddin in the freedom fighters' list but they are yet to get any response.

### Baby burnt alive

An infant was burnt alive at village Uttar Mojlishpur in Nolerchar under Chanandi union in Hatiya upazila early Thursday. Victim Anika, daughter of Milad Hossain, was only 51 days old. Sub inspector of Nolerchar PS Fazlul Kabir quoting locals said that a group of criminals set the house of Milad Hossain on fire at around 2.30am. Hearing hue and cry, locals rushed to the spot and brought the blaze under control in 30 minutes. But they failed to save the baby. A case was filed in this connection.

### Body exhumed after 3 years

Body of an elderly man was exhumed yesterday at the directive of a court. Police said Ekramul Haque, 60, died allegedly by hanging himself at Patuabari village of Palashbari union under Sadar upazila in 2007. He was buried near his former house at Uttar Pare village of Kachukata union in the same upazila. A UD case was filed at that time and the case was also dismissed as police reported it as a case of suicide. But the daughter of the deceased Maya Begum, 35, filed a murder case recently accusing 13 people of killing her father. The court accepted the case and ordered to exhume the body.

### Temple ornaments stolen

Source said, on Wednesday night, criminals entered the temple by breaking open the back door of the temple and took away the ornaments from the bodies of goddess and the cash from a box.

## Safe drinking water plant in Kushtia

## Former UP chairman murder sparks protest

Half-day hartal, rally in Saidpur

Former chairman of Khata Modhupur Union Parishad under Saidpur upazila was murdered in Kamar-Pukur Kala Bagan area near Saidpur-Dhaka highway early yesterday.

Family and police sources said the victim, Mokhlesur Rahman Sarker, also a freedom fighter, was returning home at Khata Modhupur village from Saidpur town riding a motorbike.

When he reached Kamar-Pukur Kala Bagan point of the highway at around 12:30am, a gang of criminals intercepted

Mokhlesur, dragged him to a nearby cropland and slit the throat.

rushed to the spot in the morning, recovered the motorbike. body and sent it to Nilphamari Hospital for autopsy.

A half-day hartal, called by Bangladesh Muktijoddha Sangsad Saidpur upazila unit, was observed in Saidpur town yesterday protesting the killing.

Addressing a rally, the freedom fighters demanded immediate arrest and exemplary punishment of the

Officer-in-charge of Party (Ershad).

Saidpur Police Station Ismail Hossain said it was a preplanned murder, as the Being informed, police killers did not take away his money, mobile phone and

Police Superintendent Alamgir Rahman and other high officials visited the spot. No one was arrested in connection with the murder as of filing of this report at 3:30pm.

Mokhlesur Rahman contested the parliamentary election on Awami League ticket from Nilphamari- 4 constituency (Saidpur-Kishoreganj) in 1991. He quit AL in 1996 and joined Jatiya
