Khaleda Zia laid the foundation stone of the project to set up the university on 50 acres of land at Defulia on the outskirts of the city near the borders of Barisal, Jhalakathi and Pirojpur districts after the parliament approved that the university would be named after Ziaur Rahman.

Later the caretaker government changed the site for the university at Goriar Par, about eight kilometres from the city centre near BKSP on November 10, 2008 and the University Grants Commission advertised for appointment of a vice chancellor for Shaheed Ziaur Rahman University on November 25, 2008.

A fund of Tk 95 crore was approved in the meeting of ECNEC on November 29, 2008, and the authority also decided to start classes of five departments of the university by renting 16 rooms on Barisal Zila School campus in 2009-10 academic session.

However, that project was abandoned after the Awami League (AL)-led grand alliance came to power.

Later on March 9 in 2010, the government piloted a bill in parliament titled Shaheed Ziaur Rahman University, Barisal (Amendment) Bill 2010 seeking renaming of the proposed university as Barisal University, which was duly approved.

Khan, director of Barisal University Implementation Project, said due to stay order of the court, even after placing a fund of Tk 7.44 crore for acquisition of land, the project authority is yet to receive its possession.

## Obscene dance, illegal acts under the guise of fair

Obscene dance, gambling and deceitful lottery are going on under the guise of 'adivasi mela' (fair of indigenous people) at Balabhir village in Boda upazila of Panchagarh district.

A couple of days after the fair started on January 7, the organisers arranged round the clock gambling at the site where ganja, phensidyl and other harmful items are sold, villagers said. Many innocent people are becoming

losers while the activities, run throughout the night, cause disturbance of students ahead of the SSC examinations. Civil and police administrations are yet to

take any action although there is no legal permission to run gambling, raffle draw and

Although the organisers claimed it to be a fair meant for indigenous people, no cultural activities of indigenous people were seen when this correspondent visited the fair on Friday. In the name of jatra (open air drama),

several groups are performing obscene dances in presence of policemen.

A public representative of Boda upazila, also a local leader of ruling Awami League, along with a few political colleagues are conducting the activities, locals said.

Admitting organisation of jatra, lottery and gambling at the 'adivasi mela' without legal approval of the administration, acting in charge of Boda police station Sub Inspector Harun-or-Rashid said, "As local ruling party men arranged it for indigenous people's welfare, we overlooked the matter. But all these activities will be stopped from tonight [Sunday]."

When contacted, leader of Panchagarh Indigenous People's Welfare Association Rajoni Kanti Mardi said, "Although it has been arranged in the name of indigenous people's welfare we are yet to get benefit from it."

When contacted, Vice-Chairman of Boda upazila parishad Mofizar Rahman said, "No nude dance is being performed here. I have ordered the organisers not to hold any gambling at the jatra compound. We have taken verbal permission from the authority."

He, however, declined to say who the authority is.

District Superintendent of Police Shahriar Rahman said the jatra has been permitted but obscene dance and gambling are not allowed there.

Upazila Nirbahi Officer Sarwar Alam could not be contacted for his comment as he did not receive his cell phone despite repeated calls from this correspondent.

An absconding college teacher, who allegedly took video footage of his illicit act with a student here in Shibganj, was sent to jail on his surrender before a court onWednesday. Accused Abdul Latif,

assistant professor of chemistry department of Binodpur Degree College remained absconding for over three months.

He appeared before the Court of District and Sessions Judge, Chapainawabganj and prayed for bail. Judge Anwar Hossain rejected his bail prayer and sent him to jail. Police said, Latif took

video footage of his illicit act with a student of the college in his mobile phone in 2007. Later, the girl was married

to a schoolteacher of the same upazila and they had a child. Meanwhile, Latif's

mobile phone went out of order last September and he took it to a service centre at Binodpur Bazar. Technicians at the centre copied the obscene video and sent those to a number of mobile phone holders.

Angry over seeing the footage, the girl's husband sent her to her parent's house on October 1 last year.

As the news spread, the next day hundreds of students of Binodpur Degree Fifty-nine Indian nationals including three women, convicted for various crimes during College, their guardians and people of Binodpur the last one decade, are languishing in Satkhira jail even after end of their prison term as village demonstrated and confined college principal Ruhul Amin to his office for at least two hours demanding punishment of Abdul Latif.

Same night, the girl filed a rape case with Shibganj police station and Abdul Latifwent into hiding.

in the mutiny case against 61 jawans of BGB Sylhet sector headquarters today.

The court headed by Col SM Farhad, fixed the date on completion of arguments between the prosecution witnesses and the accused on December 29 last year.

During the argument, prosecutor Major AKM Aurangajeb stated that 61 jawans took control of the sector headquarters in the city's Akhalia area on Sylhet-Sunamganj Highway on February 26, 2009.

They looted arms and ammunition from armoury, set fire to some vehicles and put up barricades on the highway, he added.

Of the accused, 28 confessed to their involvement in the mutiny while the rest

claimed innocence. The then officer-in-charge of Sylhet Kotwali Police Station Syeduzzaman filed three separate cases with the Chief Judicial Magistrate's Court on May 18 in 2009 against the mutineers of Sylhet sector and two separate battalions under the sector.

They were immediately arrested and produced in the Chief Judicial Magistrate's Court that sent them to jail hajat.

It will be the fourth judgement in the cases for mutiny in greater Sylhet region. The special court-3 sentenced 14 jawans of 8 Rifles Battalion, Sunamganj, to different terms of rigorous imprisonment on August 2 last year.

The second judgement was delivered on December 29, awarding jail terms to 39 personnel of 21 rifles Battalion. In the third case, 59 jawans of 38 Rifles Battalion were jailed on December 30.

Deputy Attorney general Farhad Ahmed will represent the attorney general while special public prosecutors Gazi Zillur Rahman and Md Habibur Rahman Sheikh has remained in a dilapidated condition for long. will remain present.
