## 20KM GAZIPUR-AIRPORT ROUTE

# Work for rapid bus service starts in 2012

Implementation of rapid bus service project in the Gazipur to airport route begins early next year and to be completed by the end of 2013, said officials concerned at a workshop at a city hotel yesterday.

Roads and Highways Department (RHD) and Asian Development Bank (ADB) jointly organised the workshop on presentation of the draft of final feasibility report on Greater Dhaka Sustainable Urban Transport Corridor Project.

Md Aminur Rahman Lasker, project director, said the 20-kilometre double-lane rapid bus service (Bus Rapid Transit, BRT) route from Gazipur to Hazrat Shahjalal International Airport will have a seven-metre wide dedicated lane at the centre of the road.

"We will widen the existing 15-metre road with the land available at RHD's ownership and also through acquisition of land where necessary for the other commuters," he said.

Every day one-lakh commuters can use BRT, once built. It will also bring down the uses of private cars.

The project cost has been estimated at US\$190 million, of which ADB has proposed 125 million with 28 million co-financing from the bilateral development partners and the rest from government of Bangladesh.

The ADB is funding the feasibility study of the project as a model pilot, while the final report is expected by April, said Lasker.

AKM Mozammel Haque, a lawmaker from Gazipur, said the Dhaka-Gazipur highway is so clogged with

traffic load of 29 different routes that it takes three hours to get to the centre of the capital from Gazipur.

The project is an extension of the Airport-Sadarghat BRT route no-3 recommended in the Strategic Transport Plan.

The government, as under constant pressure, will now prioritise to develop rapid mass transportation systems (Mass Rapid Transit, MRT), said Communications Minister Syed Abul Hossain who was present at the workshop as chief guest.

Mozammel Haque Khan, secretary to Roads and Railways Division; and Stefan Ekelund, head of Portfolio Management Unit of ADB; among others spoke at the workshop chaired by Shahabuddin, chief engineer of RHD.

## 10 structures on Kalyanpur canal knocked down

Dhaka Water Supply and Sewerage Authority (Wasa) with the help of district administration removed around ten semi-concrete structures yesterday as part of an ongoing eviction drive to free a stretch of city's Kalyanpur main canal.

They however spared three mosques, portions of which were built on the canal.

Ruhul Amin, executive engineer of Wasa, said they decided to spare those considering religious sentiment.

Alid Mainul Amin, executive magistrate of Dhaka district administration, said he asked the management committees to remove the illegal portions.

Manual demolition began from the canal near Kalyanpur Bridge behind Acme Laboratories with Mirpur Police Station and members of riot police maintaining law and order.

The team carried a similar drive at the same stretch of the canal last Monday and pulled down more than a dozen of such illegal structures.

Illegal structures occupied half a kilometre of the three kilometre long canal, said Ruhul.

## HC forms body to save Mahasthangarh

The High Court yesterday formed a 10-member committee to recommend ways to protect the historical archaeological site of Mahasthangarh in Bogra and its adjacent shrine and mosque.

An HC bench of Justice AHM Shamsuddin Chowdhury Manik and Justice Sheikh Md Zakir Hossain asked the committee to submit a report before the court within two months.

During hearing a writ petition, the court directed the authorities to stop construction of structures near the archaeological site for the next two months.

It also ordered the deputy commissioner and superintendent of police of Bogra to submit a report within 15 days on steps taken against the persons responsible for damaging the historical site, shrine, and mosque.

Director general of the department of archeology will head the committee formed by the HC.

Other members of the committee are: DC and SP of Bogra, thana nirbahi officer of Shibganj of the district, historian Prof Muntasir Mamun, journalist Shahriar Kabir, two representatives from Dhaka University and Jahangirnagar University, one representative from the National Museum in Dhaka and the curator of Mahasthangarh shrine.

The court issued the order during hearing a writ petition filed by Human Rights and Peace for Bangladesh seeking direction on the government to protect and preserve the site.

During hearing yesterday, the court said it will not allow anybody, even if he or she is very powerful, to damage the historical sites of the country.

The bench said this while Nasima, the curator of Mahasthangarh shrine, yesterday told the court that she is not getting support from the administration to properly protect and maintain the shrine.

Earlier on January 23, the bench summoned five persons including Nasima and an Awami League leader on charges of constructing a road near Mahasthangarh archaeological site in Bogra ignoring an HC order.

## Stop new commercial works in Dhanmondi

### HC directs govt

High Court (HC) yesterday directed the government not to allow any further commercial operation and institution within the city's Dhanmondi residential area for the next six months.

In response to a writ petition, the court also directed the government to submit a report within four weeks on what steps they took to remove illegal commercial institutions from the area since 1999.

The HC bench of Justice Mohammad Momtazuddin Ahmed and Justice Gobinda Chandra Tagore also issued a rule upon the government to explain within four weeks why it should not be directed to evict the institutions.

Dhanmondi Residential Welfare Association President MA Masud and General Secretary MA Matin Chowdhury jointly filed the writ petition on Tuesday as public interest litigation.

Petitioner's counsel Advocate Manzill Murshid told the court that hundreds of illegal commercial institutions are operational there, damaging residential character and environment.

He said no step has yet been taken to remove those and authorities concerned failed in their duty to protect the residential area.

## CHARGES AGAINST TARIQUE

# Decision on cognisance Feb 10

A Dhaka court yesterday fixed February 10 to decide whether money-laundering charges against BNP Senior Vice-Chairman Tarique Rahman and his business partner Giasuddin Al Mamun would be taken into cognisance.

Judge Mohammad Zahurul Haque of the Senior Special Judge's Court passed the order after the defendants submitted a petition seeking adjournment of the hearing.

On September 29 last year, the High Court (HC) rejected a writ petition filed by Tarique, challenging the case proceedings.

He filed a leave-to-appeal petition with the Supreme Court, which now awaits hearing on February 6.

Mamun was produced before the court, while Tarique had gone abroad for treatment.

Earlier, on July 6 last year, the ACC pressed charges against the duo for laundering Tk 20.41 crore in between 2003 and 2007.

The charge sheet says, Tarique had realised the money in foreign currencies from different companies and organisations. In exchange for the sums, he had promised to win them contracts using his power as son of the then prime minister Khaleda Zia.
