

44 mutineers jailed in Rajshahi

A special court of Bangladesh Border Guard (BGB) here yesterday sentenced 44 jawans of 37 Rifle Battalion of BGB to different jail terms ranging from four months to seven years for their involvement in a mutiny in 2009.

The Special Court-17, headed by BGB Kushtia Sector Commander Col Nazrul Islam Sarker, also fined each of the soldiers Tk100.

Of the convicts, five were jailed for highest seven years each, two for six years, four for five years, two for four years, four for three years, seven for two years, one for one month and 19 for four months each, said Prosecutor Lt Col Zahid Hassan.

Nayeb Subedar Nazrul Islam filed a case in this regard on November 11 last year.

The case statement noted the accused revolted and looted firearms and ammunition from the battalion armoury. They also fired blank shots and desecrated a portrait of Maj Gen Shakil Ahmed, the then director general of BDR, mentioned Col Nazrul Islam.

Charges were framed against the accused on January 2 for their participation in the mutiny at the battalion on February 26, 2009 that killed 74 people, including 57 army officials in Dhaka.

Eleven prosecution witnesses gave depositions against the accused.

The court handed down the punishment after analysing video footages and other official records which proved the accused guilty.

BCL beats up another with iron rods at RU

Activists of Bangladesh Chhatra League (BCL) Rajshahi University (RU) unit yesterday beat up a student of the university on the campus, branding him as an activist of Islami Chhatra Shibir (ICS).

The victim, Mizanur Rahman, is a fourth year student of law and justice department. He received injuries to his hands and legs and is now undergoing treatment at Rajshahi Medical Collage and Hospital (RMCH).

At around 12:30pm, a group of BCL men led by Nayan, Kabir, Shimul and Tuhinul locked the gates of Rabindra Arts Building where

Mizan was appearing in fourth year final examination.

The BCL activists entered the building at around 1:30pm and dragged Mizan out of the examination hall. They beat him up with iron rods and sticks and left the scene.

Teachers and employees of law and justice department rescued Mizan and took him to RMCH.

Injured Mizan said he is not involved in Shibir politics. But BCL activists alleged Miza is a Shibir activist and also took part in February 9 violence on the campus.

Contacted, RU Proctor Prof Chowdhury Zakaria said they will take actions against the persons involved after investigation into the incident.

Outlaw held in Goalanda

Police in a drive arrested an activist of an outlawed party from Goalanda upazila bus stand area Tuesday night.

Arrestee Jinnat Sheikh, 30, is a member of outlawed Sarbahara Party, and son of Habib Sheikh of Bahir Bethuri village of the upazila.

Police said Kadam Ali, former leader of the outfit, was killed by his rivals following an internal dispute at Bethuri trawler ghat Saturday night.

Later, police recovered a pair of sandal of Jinnat from the spot. Victim's brother filed a murder case accusing Jinnat and unknown 10/12 other people in this connection.

30 injured as BCL, JCD clash in Sirajganj

Clash between activists of Bangladesh Chhatra League (BCL) and Jatiyatabadi Chhatra Dal (JCD) at Sirajganj Government College left at least 30 people injured yesterday morning.

In Kurigram, a JCD leader was hospitalised following head injuries caused by BCL activists on Wednesday afternoon.

Fifteen of the 30 people, injured during yesterday's clash between activists of BCL and JCD on Sirajganj Government College campus, were admitted to Sirajganj General Hospital, reports our Sirajganj Correspondent.

Following an altercation centring the syllabus of National University in 2009-10 session at the college campus, the two groups engaged in a clash, police and witnesses said.

During the two-hour-long clash, two groups hurled brick chips on each other, causing injuries to 30 people including Babu, Ashik, Monowar, Jewel, Salman, Musa, Malek, Raju, Dipu, Jakir and Mamun.

Seven houses and eight shops adjacent to the college campus were also vandalised during the incident.

Our Kurigram correspondent adds: BCL activists injured joint secretary of the district unit of JCD Hosnain Ahmed Hijaal in College More area of Kurigram town on Wednesday.

As a sequel to assaulting of a few activists of JCD and BCL by the two rival student organisations during the last few days in the town, some BCL activists beat Hosnain Ahmed Hijaal with sticks in College More area when he came out from Kurigram town hall after completing examination of National Service Programme at about 2:00pm.

With head injuries, he was admitted to Kurigram Sadar Hospital.

Nine JCD activists held in Kushtia

Leaflets with derogatory remarks against FM seized

Police arrested eight Jatiyatabadi Chhatra Dal (JCD) activists as they besieged Kushtia Sadar police station Tuesday night to protest arrest of a fellow activist.

Police said they raided the district party office of BNP on Nawbab Seraj-Ud-Daula Road in the town at about 7:30pm and arrested one Mahfuz with leaflets having derogatory remarks against foreign minister Dipu Moni.

The posters accused the FM of her inaction following the recent brutal killing of Bangladeshi girl Felani by Indian Border Security Force (BSF).

After the arrest, hundreds of activists of JCD district unit brought out a procession and besieged Kushtia Sadar police station at about 8:30pm.

Police chased the party activists and arrested eight of them from in front of the police station.

They are Sadekul Islam, Year Ali, Sujon, Jahangir Alam, Sharier Faisal, Robiul Islam, Liakat Ali and Mehedi Hasan Mithu.

Officer-in-charge (OC) of Kushtia Sadar police station Asaduzzaman said police arrested the JCD men for distributing the leaflets and disrupting the activities of the police station.

A case was filed against the JCD activists in this connection.
