Pakistan cabinet resigns as part of revamp plan

AFP, Islamabad

Pakistan's ministers yesterday submitted their resignations to the prime minister, who intends to appoint a smaller cabinet in order to reduce government spending at a time of economic crisis.

"Today's meeting is going to be the last meeting of the present cabinet," Prime Minister Yousuf Raza Gilani told more than 50 ministers, praising their record on the economy, constitutional reform and response to major floods.

A senior government official told AFP that the ministers had tendered their resignations to Gilani during the meeting.

"Now the prime minister will forward these resignations to the president for acceptance," the official told AFP, on condition of anonymity.

"The cabinet usually stands dissolved after the president accepts the resignations forwarded to

him by the prime minister," he added. The main ruling Pakistan People's Party (PPP) last week authorised Gilani to dissolve the cabinet after powerful opposition parties demanded a smaller line-up as part of retrenchment efforts to tackle Pakistan's economic woes.

A reduction in the size of the cabinet is a legal requirement of the 18th amendment to the constitution, which stipulates it should be no larger than 11 percent of parliament.

Shariatpur. It also does not give a clear idea about the entire incident that involves the allegation of rape,

physical torture and finally, the lashing, she added.

Rehan Husain, however, said the accused might get the benefit of doubt if the case is recorded again. "Instead, the investigation

officer can record statement of three to five witnesses to get the actual incident and record them in Uddin, sub-inspector of Noria the current case," he suggested. Following Hena's death on

January 31, her father Darbesh Kha went to Noria Police Station of the district to file the case where police asked him to describe the incident.

The police recorded his statement as first information report Criminal Procedure Code, 1898. (FIR).

"I am illiterate. I have never been to a police station in my life. The police officer asked me to sign a paper. As I cannot sign, they took impression of my left thumb on a typed case statement," said Darbesh.

"I later realised that the police took advantage of my illiteracy."

According to the FIR, police said Bangladesh Human Rights read out the statements to Darbesh before taking his thumb impression.

Chunnu Mia, a relative of the victim, who accompanied Darbesh at the police station,

denied the police claim. The police inquest prepared 16 Criminal law expert barrister hours after Hena's death failed to trace any injury marks on her body but found her having an affair with

Mahbub. The Daily Star has obtained a copy of the inquest report prepared on February 1 by Aslam

Police Station.

"An inquest report is drawing up a report of the apparent cause of death, describing such wounds, fractures, bruises and other marks of injury as may be found on the body," reads section 174 of the

Sara Hossain, a legal expert, said an inquest report has nothing to do with the emotional attachment, if any, of the victim.

"It was designed to malign the victim socially," she said.

Sara, also a human rights activist, said police are trying to blame the victim to conceal their failure to protect the girl.

Iraq car blast kills eight

Three near-simultaneous car bombs killed at least eight people in the ethnicallydivided northern city of Kirkuk yesterday, a medical official and a police officer said.

Dozens more people were wounded in the triple attack at around 10:25am local time in the west of the oil-rich city, said Sadiq Omar Rasul, head of Kirkuk province's health department.

"We have received eight dead bodies and 68 people have been wounded, they are being treated at Kirkuk General Hospital and Azadi hospital," he told AFP.

Police Major Salam Zangana put the toll at eight killed and 83 wounded. According to him, among the dead were a woman, a child and two policemen, while the wounded included security officers, women and children.

said Abu Taher, owner of Mukta Enterprise at New Market of the capital. Some refiners admitted

that they reduced supply claiming the present prices, fixed by the government in December last year, are now less than their cost, which has been rising due to soaring prices of cooking oil on the international market amid concerns of crop losses due to unfavourable weather in oil seed growing areas.

Refiners said the government promised them of revising the prices every 15 days in light of the trend on the world market, as Bangladesh meets nearly 80 percent of its annual demand for cooking oil through imports.

But it has yet to reset new prices, although a month and a half has passed, since the last time it fixed the prices.

Meanwhile, refiners informed the government that their current cost is Tk 113 for each litre of soybean oil, and sought re-fixing of the maximum selling price, according to MA Rouf Chowhdury, president of Refiners & Vanaspati Manufacturers Association.

The delay in re-fixing the price has caused the refiners to cut down supply to the market, creating scope for middlemen in the supply chain to charge prices at their whims.

"We were selling at losses.

For nearly a week, we had to slow down supply of bottled oil to minimise the loss," said Mostafa Kamal, chairman of Meghna Group of Industries, one of the biggest importers of cooking oil Meghna markets under the brand name of Fresh.

On Tuesday, Mohammad Sharif, a salesman at Rifat General Store in Wari, asked for Tk 570 for a 5-litre bottle of soybean oil. Yesterday, retail sellers at

Karwan Bazar claimed that representatives of refiners informed them of an increase in the prices of packed soybean oil. "Till this morning, com-

panies sold a five-litre pack to us for five hundred taka. At noon, we came to know that the price went up by twelve taka per litre," said Nur Nabi a retailer at Karwan Bazar yesterday. Officials of cooking oil

refining companies admitted that they are planning to increase the prices by Tk 10 to Tk 12 for each litre of packed soybean oil. It means that the prices of

5-litre packs will stand at Tk 560 to Tk 570 after the spike. Bangladesh Vegetable Oil They however added that the supply side will normalise after the price hike.

Mostafa Kamal of Meghna Group said high prices of vegetable oil on the world market, and devaluation of taka against dollar are causing them to pay more for imports.
