#### Senior US official arrives in Dhaka

Principal Deputy Assistant Secretary of State in the Bureau of South and Central Asian Affairs, Geoffrey R Pyatt, arrived here yesterday on a three-day visit to Bangladesh.

#### War crimes trial necessary for justice: Morten

Morten Bergsmo, co-ordinator of the International Criminal Court (ICC) Legal Tools Project and director of Case Matrix Network (CMN), yesterday said it is necessary to hold trials of war crimes taken place in the country 40 years back for ensuring justice in the society.

"It is not only possible but also necessary to hold trials," he said.

Law Minister Shafique Ahmed said Morten Bergsmo is here to increase the knowledge of the prosecutors with their system.

Ilia Utmelidze, deputy director of CMN and legal adviser to Norwegian Centre for Human Rights, was also present in the meeting.

The other accused are Sanvir's bodyguards Khairul Hassan Uzzal and Shamsuddin Ahmed, two guards Nure Alam and Humayun Kabir.

## Owner blamed for undermining JS body authority

Tofail Ahmed, chief of the parliamentary standing committee on industries ministry, yesterday accused owner of Deshbandhu Sugar Mill of undermining the committee's authority to investigate the company's corruption in exporting sugar.

Taking floor on a point of order in the House, the ruling Awami League lawmaker also sought permission to submit a notice seeking remedy for the violation of the committee's privileges.

Deputy Speaker Col (retd) Shawkat Ali, who was presiding over the sitting, advised him to submit the notice.

Referring to an advertisement published in a national Bangla daily yesterday, Tofail said the owner distorted facts in the advertisement and accused the parliamentary body of holding discussion on a sub judice matter.

He said the company bought 6,000 tonnes of sugar from the state-run Bangladesh Sugar Corporation, during the last

caretaker government's rule, to export to Europe. Instead of exporting, the company sold the sugar in the domestic market at twice the price. The company bought sugar at Tk 33 per kg.

#### JSD slams AL for disunity
