## Muhith slates Kamal's remark on stock index

Finance Minister AMA Muhith yesterday criticised the chairman of the parliamentary standing committee on the finance ministry for his remarks on the stockmarket index.

"I have not given any figure on what should be the index. The only thing I've said the market is overvalued and it will correct itself," Muhith told journalists after a meeting on the offloading of state-owned companies' shares at the finance ministry.

AHM Mustafa Kamal, chairman of the standing committee, said on Tuesday the index at Dhaka Stock Exchange should come down to 3,000-3,500 for stability.

The index now hovers around 6,500 from nearly 9,000 in early December.

"I've no right to say what the index should be," Muhith said on Kamal's remarks.

He also said the House body chairman can only recommend but can't give any decision.

Mustafa Kamal owns CMC Kamal Textile Mills, a company listed on the stockmarket. The price of a share of CMC Kamal rose to nearly Tk 1,600 in November from Tk 144.75 in March last year.

The price increase rate was over 1,000 percent during this period.

According to data available at the Dhaka Stock Exchange,

CMC Kamal that was listed in 1997 gave dividend (10 percent bonus) in 2009. "He (Kamal) has a conflict of interests in the stockmarket

as two of his companies are listed on the market. Simultaneously, he is a lawmaker and chairman of a watchdog committee," said a former chairman of the Securities and Exchange Commission.

The finance minister yesterday came down heavily on the investors for demonstrating on the streets. "What rubbish they are doing. It is pre-planned," he said.

Reading from the report of the second autopsy, conducted at Dhaka Medical College Hospital, Civil Surgeon Golam Sarwar said, "One bruise on left lower chest is two and a half inches long and two inches

The latest autopsy has found eight external and seven internal wounds.

"In our opinion, the death was due to haemorrhage followed by Septicaemic shock resulting from the wounds inflicted by blunt weapon. Those were ante-mortem and homicidal in nature," Sarwar told a two-member bench of the HC.

A murmur of voices rose in the courtroom as the civil surgeon concluded. Someone shouted out, "You scoundrel. How much money did you take?"

The DMCH autopsy found four bruises on the chest, three on the back of abdomen and one in left

The external bruises were on average four inches long and two inches wide.

The internal ones were mostly four and a half inches long and three inches wide. The wounds include three in the chest, three on the back of abdomen and one in left thigh.

Asked which one of the two reports is true, Sarwar avoided a directly a reply. "This is about the experience of doctors. The DMCH doctors are more experienced than those from Shariatpur," he said.

Instantly, the court wondered about the fate of hundreds of post-mortems done in the district in past. "According to your state-

ment, all the post-mortems done in the past in the district were wrong," one judge told Sarwar.

In reply to another question on how Hena died within 34 hours of her discharge from the hospital, Sarwar claimed Hena was "completely healthy" at the time of her release.

"Then it must be a genie who has killed the girl," the judge quipped.

At one stage of the hearing, Additional Attorney General MK Rahman brought to the court's attention different news reports containing the civil surgeon's statement that journalists were lying about Hena's death.

"What you have said is completely false, and what the journalists said are completely true," another judge observed.

Nirmal Chandra Das, the medical officer who headed Shariatpur autopsy team, tried to raise the issue of lack of instruments for a proper autopsy. But he could not name any such tool when the court asked

Eyewitness said when the opposition lawmakers gathered at the place around 3:00pm, Sergeant-at-Arms Capt AKM Faruque Hassan invited them to have tea and snacks at the Speaker's office. The lawmakers refused the invitation and some of them even hurled abuse at Faruque.

During the sit-in, the opposition MPs demanded action against those who "tortured" BNP leaders and activists across the country in Monday's hartal. ment for a sustainable eco nomic growth and poverty reduction, said US Ambassador to Bangladesh James F Moriarty.

"Bangladesh has made substantial progress in developing institutions and undertaking reforms to reduce corruption," he said at the inaugural session of the 20th Annual US Trade Show 2011.

"However, sustaining these efforts will be a challenge," he added.

Moriarty said Bangladesh has not been very successful in attracting investment because investors look for a stable and predictable environment where rules are consistent and risks are minimum.

"Each country's reputation is becoming very critical and Bangladesh has shown steady progress in the last two decades," he said.

Bangladesh has enormous potential for strengthening economic relationship with the US, especially if it succeeds in attracting more investment, Moriarty noted.

Monir noted. Experts say consumption of tannery waste through fish and poultry can cause liver and kidney diseases,

even cancer. In July last year, The Daily Star found in and around Hazaribagh some 100 small traders using tannery waste as ingredients for poultry and fish feeds and supplying those to some 20 factories

across the country.

Shahidul Islam, chief scientific officer of Bangladesh Council for Scientific and Industrial Research (BCSIR), said in the country around 176 tonnes of solid waste is produced a day at 270 tanneries, 90 percent of which are located in Hazaribagh.

Monir Chowdhury said they will take measures to compel the tannery owners not to sale their waste to feed traders.

The practice of using tannery waste for fish and poultry feed started around 10 years ago, as the prices of imported protein for feed had gone up over the years.

Hena's family. The bench also ordered them to simultaneously proceed with the murder case filed by Hena's father Darbesh Kha with Naria police on January 31.

It directed the inspector general of police (IGP) to take legal and departmental actions against subinspectors of Naria police --Mirza AK Azad and Aslam Uddin -- for manipulating the first information report and the inquest report regarding Hena's unnatural death.

The IGP was ordered to replace existing investigation officer Aslam Uddin with another police officer having the rank of at least an assistant superintendent of police.

The police chief was directed to submit a compliance report to the court within 15 days as well. The court directed the

health secretary, and the director general (DG) of the Directorate of Health to constitute a high-powered committee comprising DG Health, principal of Dhaka Medical College Hospital (DMCH), director of the hospital, heads of the forensic departments of Bangabandhu Sheikh Mujib Medial University and Shuhrawardi Hospital, and joint secretaries of the law and home ministries to examine why the post-mortem reports prepared by Shariatpur Sadar Hospital and DMCH are diametrically different.

The committee will also examine whether the civil surgeon of Shariatpur, and the doctors of the hospital there, who prepared the first postmortem report, committed any offence or were negligent in their duties.

The DG Health will have to submit a report to the HC within 30 days of receiving the order.

The court ordered the secretaries to the ministries of religious affairs and information to run a campaign at all mosques, madrasas, and union parishads across the country identifying fatwa as a criminal offence.

Hena, 15, was mercilessly whipped at a village arbitration following a fatwa on January 24 for allegedly having an illicit affair with her married cousin Mahbub, while her family kept insisting that she had actually been raped by the man. She died on January 31.

According to the second post-mortem done by DMCH, she died of extensive

external and internal injuries. The inquest report by Naria police and the first postmortem by Shariatpur Sadar Hospital however had not found any mark of injury on Hena's body right after her death. The Daily Star in a news

report on Feb 7 raised doubt about the reports from Shariatpur and Naria, which prompted the HC to issue a suo moto order the same day for exhumation of Hena's body and a fresh postmortem. The body was exhumed

that night and sent to DMCH. The next day a new postmortem was done by DMCH which found extensive wounds on Hena's body, and determined those were the cause of her death. Yesterday's HC ruling

came after the new postmortem report had been submitted to the court the day before. A huge crowd of local and

international journalists, human rights activists, and lawyers thronged the court yesterday to know about the newpost-mortem. Meanwhile, a Shariatpur

court yesterday placed Mahbub Khan, the alleged rapist and the main accused in the existing case, on a fiveday remand. He was arrested by Shariatpur police from Savar on Wednesday.

During yesterday's hearing at the HC, Civil Surgeon of Shariatpur Golam Sarwar; doctors Nirmal Chandra Das, Rajesh Majumder, and Hosne Ara Begum of Shariatpur Sadar Hospital, who prepared the first post-mortem report; Sultan Ahmed, who attended Hena at that hospital; arbitrator Idris Ali Sheikh, who is also a member of the local union parishad; OC of Naria Police Station Abul Khair Fakir; Subinspector Aslam Uddin, who prepared the inquest report; Hena's father Darbesh Kha; and her cousin Minu Begum appeared before the court responding to its summons.

Attorney General Mahbubey Alam, Additional Attorneys General MK Rahman and Murad Reza Deputy Attorney General ABM Altaf Hossain, Assistan Attorney Genera Fazilatunnesa Bappy, and Advocate Seema Zahur assisted the court.

But he said he would ignore "diktats from abroad".

Egypt's military had earlier said it was standing ready to "protect the nation".

"I express a commitment to carry on and protect the constitution and the people and transfer power to whomever is elected next September in free and transparent elections," Mr Mubarak said.

Ahead of Mr Mubarak's announcement, thousands of Egyptians had again gathered in central Cairo to call for him to step down.

Doctors, bus drivers, lawyers and textile workers were on strike in the capital yesterday, with trade unions reporting walk-outs and protests across the

country. Mr Mubarak, 82, had previously said he would leave office only after presidential elections due to be held in September.

Negotiations between the government and opposition groups have made little progress, with protesters disillusioned at plans for reform put forward by Mr Mubarak's government.

In recent days, the US government had stepped up its call for the protesters' concerns to be addressed.

Mubarak announced that he had put into place a framework that would lead to the amendment of six constitutional articles in the address late on last night, reports Aljazeera. "I can not and will not

accept to be dictater orders from outside, no matter what the source is," Mubarak said. He said he was addressing

his people with a "speech from the heart" Earlier, the Supreme Council of Egyptian Armed

Forces had met to discuss the

ongoing protests against

Mubarak's government.

In a statement entitled Communique Number One televised on state television, the army said it had convened the meeting response to the current political turmoil, and that it would continue to convene such meet-

Tens of thousands poured into Tahrir Square after the army statement was televised. Thousands also gathered in Alexandria, Egypt's second city, our correspondent said.

Earlier, Hassan al-Roweni an Egyptian army commander, told protesters in the square that "everything you

want will be realised". Hassam Badrawi, the secretary general of the ruling National Democratic Party (NDP), told the BBC and Channel 4 News earlier on that he expected Mubarak to hand over his powers to Omar Suleiman, the vice-

president. "I think the right thing to do now is to take the action that would satisfy ... protesters," Badrawi told BBC television in a live interview.
