
Burdened by bumper potato

Growers in 8 northern districts to count loss for poor storage facilities

Bumper potato yield in eight northern districts this season hardly makes the farmers happy as 57 cold storages in the country's largest potato producing region can accommodate only 13.5 per cent of the total production.

Average yield of harvested potato in a hectare this year is 19.5 tonnes and accordingly total production in the region is expected to be about 37 lakh tonne, said officials of the regional office of the Department of Agriculture Extension (DAE) in Rangpur.

Seventy percent of the winter vegetable in the region has already been harvested.

"We are expecting bumper production as the weather is favourable, fertiliser and pesticide supply is stable and farmers are getting them at fair price," said Mamunur Rashid, acting deputy director of DAE in Nilphamari.

Farmers cultivated potato on 1.87 lakh hectares of land in Rangpur, Dinajpur, Gaibandha, Kurigram, Lalmonirhat, Thakurgaon, Panchagarh and Nilphamari districts, which is 12.6 thousand hectares higher than the target set by DAE this year, said DAE sources.

"We are expecting bumper production as the weather is favourable, fertiliser and pesticide supply is stable and farmers are getting them at fair price," said Mamunur Rashid, acting deputy director of DAE in Nilphamari. "Farmers are opting for high yielding

potato varieties and adopting scientific methods of cultivation, resulting in bumper yield. Farmers cultivated high yielding varieties like

Granula, Patronize, Diamond, Hira, Dhira and others in vast tracts of land in this region," Mesbahul Islam, horticulture specialist of regional DAE office in Rangpur, said.

There are 28 cold storages in Rangpur, seven each in Dinajpur, Thakurgaon and Nilphamari, four in Lalmonirhat, and two each in Gaibandha Kurigram districts, said sources of Cold Storage Association and regional DAE office. There is no cold storage in Panchagarh district.

The total storing capacity of the 57 cold storages is 4.7 lakh tonnes or 13.5% of total production, they said.

About 25.72 lakh tonnes of potato will remain outside the cold storages and a large amount of it will remain vulnerable to damage.

Sayed Ali, owner of a big cold storage in Jaldhaka, said farmers have already booked all the available room in advance for storing potatoes.

"Considering the interest of potato farmers in this monga-prone region, commercial banks should relax their rules and conditions for giving loans on easy terms so that interested entrepreneurs may come forward to set up new cold storages," Md Selim, an American expatriate, also owner of newly set up cold storage 'Ankur Himagar Ltd' in Nilphamari.

"Potato farmers are facing storage problem as there are not inadequate cold storages. We are suggesting farmers to follow traditional ways to store potatoes in well-ventilated place, using bamboo floors enclosed with bamboo fences," Md Mohsin Ali, additional director of DAE in Rangpur region, said.

Criminals loot cattle laden truck

A gang of armed criminals took away a cattle laden truck in Jangal area of Bandar upazila on Dhaka-Chittagong highway early Friday. Police said, the gang numbering 4/5 halted the Dhaka-bound Indian cattle laden truck from Noakhali in the area at about 4:00am. Taking the driver, helper and two cowboys hostage at gunpoint, the gang took control over the steering and at one stage dropped the hostages on the road. Later, the gang left the place along with the truck. Cattle trader Ohidur Rahman estimated the value of the looted 18 cows at Tk 6.75 lakh. Police recovered the truck in an abandoned condition from in front of Modhumoti filling station in Sonargaon upazila in the early morning.

Brickfield fined in Satkhira

A mobile court here fined a brickfield Tk 30,000 on charge of polluting environment by using firewood at Bardal in Assassuni upazila yesterday. A court here on Wednesday convicted a district Mohila Awami League (AL) leader and sentenced her to six months imprisonment in a contempt of court case filed by a college teacher last year. Convict Rifat Amin went into hiding from

Assistant Judge's Court soon after Judge Mohammad Zahidul Islam pronounced the verdict in the morning.

According to prosecution, Rifat owns a house at Mujitpur in the district town which she leased to Anisur Rahman, a resident of Sultanpur area and lecturer of a private college, for 12 years on 31 December, 2000.

Following the contract Anisur took posses-

Nine years later Rifat tried in vain to evice Anisur from the house breaching conditions of the lease.

On 17 Dec, 2009, she hired a few goons and vandalised Anisur's school, causing huge economic loss to the tenant.

The victim lodged a civil suit with the court against Rifat on January 6 last year.

Angered at filing of the suit, Rifat rallied her goons and launched fresh attack on the school on the night of 7 Jan, 2010, damaging documents and properties of the institution. It prompted the tenant to file a contempt

Drug peddlers, addicts jailed

Mobile courts in Dinajpur and Natore on Friday jailed eight drug peddlers and five addicts.

A mobile court in Dinajpur on Friday convicted six people and sentenced them to two years rigorous imprisonment each for possessing drug, reports UNB.

The convicts were identified as Ali, 45, son of late Sheikh Romar, his wife Parul, 38, Milon, 24, son of Nur Islam, Nur Mohammad, 48, son of Shamsul Haque, Nur Islam, 70, son of Hafiz Uddin and his wife Haowa Begum, 35, of Sipahipara area of the district town.

Officer-in-charge of Kotowali PS upazila. Hasan Iqbal said on a tip-off, a team of police raided the houses of Mohammad Ali and Haowa Begum late at night and arrested them along with 3kgs of hemp. Later, on the basis of their confession, police arrested the four other drug peddlers the same night.

Later, the mobile court led by executive magistrate Sumi Akter instantly handed down the verdict.

In Natore, a mobile court on Friday evening convicted two drug peddlers and awarded them one month imprisonment each for selling hemp at Lokmanpur village in Bagatipara menteach.

The convicts were identified as Delwar Hossain and Ayez Ali of the village.

On secret information, police conducted a drive in the area and arrested the duo while selling hemp.

Later, the mobile court led by upazila nirbahi officer (UNO) Yeamin Khan handed down the verdict.

The same court conducted a drive in Bansbaria area of the upazila on the day and arrested five addicts -- Pintu, Anowar, Babul, Kismot and Koli Begum -- while taking hemp and awarded them seven days' imprison-
