

Dyke burst adds to their miseries

9 Aila-hit villages flooded in Khulna

Five hours into the completion, Patakali embankment in Koira upazila of Khulna district collapsed under the pressure of strong current of Shishu River on Sunday afternoon.

Over 20,000 people of nine Aila-hit villages in South Bedkashi union under Koira upazila have remained marooned as saline water flooded the area.

One person was seriously injured as solid chunks of earth hit him during the collapse.

Messers Mizan Enterprise, owned by Monirul Huq, son of former local lawmaker Awami League leader Nurul Huq, constructed the embankment at a cost of Tk 2 crore 6 lakh 25 thousand.

"The embankment collapsed shortly after its construction as it was done by an inexperienced contractor," said Koira upazila Chairman GM

Mohsin Reza.

Md Aliuzzaman, Water Development Board (WDB) section officer in charge of Koira upazila, said the contractor did not use proper materials for embankment construction.

"Of course, army men supervised construction work of this embankment," he added.

Chairman of affected South Bedkashi union Shamsur Rahman said fraudulence of the contractor and negligence in monitoring by WDB men are responsible for the collapse.

Contractor Monirul Huq could not be contacted for his opinion about the embankment collapse as his cell phone was found off despite several attempts since Sunday.

Meanwhile, a spokesman of the army claimed that all the embankments damaged by cyclone Aila in Kamarkhola and Sutarkhali unions

under Dakope upazila in Khulna district have been constructed properly and it will enable over a lakh people to go back to their homes from makeshift camps.

The WDB invited tenders for construction of seven damaged embankments in worst-hit Kamarkhola and Sutarkhali unions at a cost of Tk 50 crore 69 lakh.

The work began under supervision of the army on November 7 last year and it was fully completed on Sunday, sources said.

"Strict supervision by the army and monitoring of construction works by Food Minister Dr Abdur Razzaq, Water Resources Minister Ramesh Chandra Sen and several government high-ups during their recent visits largely contributed to completion of sustainable embankments in Dakope upazila," said lawmaker Nani Gopal Mandol.

Five pirates jailed in Bagerhat

A court here yesterday convicted five pirates and awarded them 17 years' imprisonment each. The convicts are Ishaq Uddin, 50, Monir Hossain Sarder, 30, Akram Gazi, Monir Hawlader, 22, of Bagerhat district and Shaheed Khandaker, 35, of Barguna district. According to prosecution, forest guards arrested the five pirates from a trawler in Chandashar area in Sharankhola upazila on August 22, 2007 when they were taking preparation for committing piracy. They also recovered two firearms, nine rounds of bullet and arms making materials from the trawler.

Night guard beaten to death

UNB, Bogra

A night guard was beaten to death by unidentified criminals in Barpur area in the district town early Sunday. The deceased was identified as Shahadat Ali, 65, son of Mozibor Rahman in the area. Police said Ali resisted the criminals as they tried to take away goods from a welding workshop. At one stage, they picked up altercation with the guard and beat him mercilessly, leaving him critically injured. Locals rescued him and took him to Bogra Shaheed Ziaur Rahman Medical College Hospital where the doctors declared him dead.

Three held with arms

UNB, Gazipur

Three alleged muggers were arrested along with arms and bullets at South Chalna village in Sadar upazila Sunday evening. The arrestees were identified as Harun-ur-Rashid alias Thandu, 35, of Bhaowal Mirzapur village, Abul Hossain, 27, and Badol, 27 of Kathora village in Sadar upazila. Acting on a tip-off, police conducted a drive in the area and arrested the three when they were taking preparation for mugging in the evening. Later, a foreign made pistol and four bullets were recovered from their procession.

UP chairman arrested

Police arrested Paharpur Union Parishad chairman at Aowlia Bazar in Bijoynagar upazila on Sunday night. The arrestee was identified as Mahbubur Rahman alias Mia Bali. Police said they arrested Mahbubur as a warrant of arrest was issued against him in the morning following a case filed by Anti Corruption Commission for misappropriation of rice of Vulnerable Group Feeding (VGF) and Vulnerable Group Development (VGD).

BGB returns body of BSF man

Border Guard Bangladesh (BGB) handed over the body of a member of Indian Border Security Force (BSF) to the BSF authority through a flag meeting on Baghbhander border in Bhurungumari upazila of Kurigram district yesterday noon.

Chotu Singh, 26, of Lotaphela BSF camp of India, was on patrol duty Saturday night but he did not come back to his camp on Sunday morning, sources said.

"Body of the BSF man was found in a fishing net in Dudhukumar River at bordering Shaljhor village of North Dhaldanga union

under Bhurungumari upazila at about 12:30pm on Sunday when some fishermen were catching fish there near border pillar No 988," police said.

Informed by the fishermen, men from Uttar Dhaldanga BGB camp and police recovered the body at about 5:00pm on Sunday. Police sent the body to a hospital at Kurigram.

"After post mortem in Kurigram, BGB handed over the body to BSF authority through a flag meeting in Baghbhander border area at about 3:00pm on Monday," said Officer-in-charge (OC) of Bhurungumari police station Md Kafil Uddin.

4 JMB men get life in Chandpur

Four militants of banned Islamist outfit Jama'atul Mujahideen Bangladesh (JMB) were sentenced to life term rigorous imprisonment in separate cases in the district yesterday.

The court also acquitted eight members of the same organisation as the charges against them were not proved.

Judge Mohammad Motahar Ali of Additional District and Sessions Judge's Court in Chandpur passed the verdict in the afternoon.

Those sentenced to jail in three separate cases are Abul Kalam Azad alias Rashed, Shamim Hossain Galib, Sohrab Hossain Billal and Rahmat Ullah.

The court also fined Rashed and Galib Tk 30,000 each, in default, they are to suffer another year in jail.

70 fall sick due to food poisoning in Dinajpur

At least 70 people fell sick after having meal at a marriage ceremony at Husnapara village in Dinajpur Sadar upazila on Sunday night.

Of them, 37 were admitted to Dinajpur Sadar Hospital while the rest given first aid, hospital sources said.

Mother, 2 daughters murdered in Mymensingh

Unknown assailants killed a woman and her two daughters at Bhatta village in Phulpur upazila of Mymensingh yesterday, police said.

The dead are Khodeza Begum, 44, and her two daughters Zohora Khatun, 22, and Murshida, 10.

Police recovered the bodies of Khodeza and Murshida, a class III student, from a nearby pond around 6:00am.

Physically challenged Zohora's body was found in a room of their house.

S Alam, officer-in-charge of Phulpur Police Station, suspected that the murder was premeditated and the victims were strangled to death.

Locals said Khodeza's husband Ali Hossain had a brawl with his neighbour Sufia Begum over a family matter on Friday.

Ali beat up another neighbour Emdad

Hossain on Saturday following a quarrel with him over the same issue, they added.

Police said Emdad was admitted to Phulpur Upazila Health Complex and was transferred to Mymensingh Medical College Hospital last night.

Ali Hossain went into hiding after Emdad filed a case against him on Sunday.

However, Ali's brother Mujibur Rahman said Sufia had a quarrel with her (Sufia's) in-laws over the rent of a shallow machine.

An arbitration was held to resolve the issue when Emdad created obstruction resulting in a brawl with Ali and his three brothers, who supported the arbitration.

At one stage, Emdad and his in-laws beat up Sayeda, Mujibur's sister-in-law, and threatened with dire consequences.

Mujibur said Emdad and his accomplices may be behind the killings.

Dazzling days of Language Movement in Nilphamari

The then East Pakistan sub divisional town Nilphamari joined the Language Movement of 1952 on 4 February.

On that day, Muslim Chhatra League had centrally called a strike in all educational institutions of the eastern province demanding Bangla as a state language of Pakistan.

During the strike, Urdu speaking sub divisional officer (SDO) Monwar Hossain misbehaved with Model High School headmaster Asiruddin Ahmed and Girls' High School headmaster Abu Nazem Mohammad Ali as they 'failed' to keep the students away from participating in the agitation.

In protest against the verbal abuse by the SDO, students and teachers of all educational institutions in the town called a fresh strike for next three consecutive days on 8, 9 and 10 February. The protesters demanded Bangla as state language and removal of the SDO for his misbehaviour.


On 21 February, in line with the central programme, all-out strike was observed in all the educational institutions of the town. A big rally was held on the premises of Muslim Hostel of Nilphamari High School.

The entire scenario changed after the news of killing Rafiq, Salam, Barkat, Jabbar, Shafiq and others on 21 February in police firing in Dhaka reached Nilphamari at night.

Thousands of people burst into protest on 22 February. Defying warning by the SDO, the town was abuzz with processions and

meetings.

The agitation flared further when the then government arrested Khairat Hossain, the Nilphamari opposition member of East Pakistan provincial assembly, in Dhaka, on 22 February.

The Pakistani government was angered by Khairat Hossain, as he along with renowned political personality Moulana Abdur Rashid Tarkabagish, had walked out of the provincial assembly protesting the killing of 21 February.

Khairat Hossain used to give directions to the local Language Movement leaders in Nilphamari from Dhaka.

To suppress the uprising, police arrested convenor of local unit Awami Muslim League Advocate Dabiruddin Ahmed and teacher Abu Nazem Mohammad Ali on 26 February.

Agitated people besieged the local police station. As the situation deteriorated, the police authorities appealed to the two arrestees to calm down the protesters.

Later at a joint meeting of Awami Muslim League and Muslim Chhatra League, a decision was taken to observe strike in the town on 28 February.

Police, in an anti-agitation move, arrested local Muslim Chhatra League general secretary Shafiqur Rahman and Jubo League convenor Shamsul Haque on 27 February. This triggered further protests. Khairat Hossain was released from Dhaka Central Jail after being imprisoned for about two years. Dabiruddin Ahmed and Abu Nazem Mohammad Ali were released after six months from Rangpur jail.

Muslim Chhatra League leader Shafiqur Rahman and Jubo League leader Shamsul Haque were released from Dhaka Central Jail after about one month. All the five leading Language Movement veterans of Nilphamari suffered immense mental torture in jail. However Bangla was finally declared as a state language.

Four of the five leading language movement veterans in Nilphamari have passed away.

Contacted, lone surviving veteran Shafiqur Rahman, the youngest of them said, "Four of us have left but Allah has kept me alive to narrate the role of the district in the Language Movement to the new generation."

Prime accused in Sylhet hotelier killing case held

The prime accused in the case for killing Atique Rahman Atique, managing director of Hotel Anurag of Sylhet city, was arrested in the capital yesterday.

Rab members arrested the accused, Shafiqur Rahman Shafiq at a house at Banani in the morning and later handed him over to Sylhet Kotwali police.
