The buying pressure was so intensive that there were no sellers for some 80 securities on the trading board.

Advancers outnumbered losers 220 to 37, with one issue remaining unchanged on the premier bourse that traded more than 6.11 crore shares and mutual fund units on a value of Tk 689 crore.

Welcoming the initiatives, market intermediaries said this time the market may turn around, as the latest moves are more effective than the previous ones. "The initiatives are good

and the impact is seen in today's [yesterday's] trading. The market would make a comeback in the near future, unless anything unexpected grips it," said Sheikh Mortuza Ahmed, president of Bangladesh Merchant Banker's Association.

DSE President Shakil Rizvi said the government move is evidence of fund supply in the market facing liquidity crunch. He also said, "The current

price earnings ratio of the market showed that it is a very good time to go for investment."

If people invest in fundamental securities for a longterm basis, they must get benefits after a certain period, he added.
