That Shakib has been criticised for doing the opposite in the World Cup opener paints a fickle picture of detractors. If the dew is such a big factor, as it was made out to be on the days following the Idea Cup loss, then Shakib must have been correct in deciding to field on Saturday. Then again, as is being advocated now, if the dew is not much of a factor then criticism heaped on Shakib a year ago must be seen as baseless. The truth, as is often the case, lies between the two extremes.

The dew cannot be a central aspect of team strategy, simply because a team cannot expect to win the toss every time. It should ideally be seen as a hindrance that has to be accommodated for. It is an ever-present component of day-night games in the subcontinent, and so should be taken out To focus solely on that and of the equation, and spinners should think of bowling with a wet ball as part of their skill base.

As for the toss, the answer to whether it would have been better to bat or field first is one based on conjecture. It can be argued, however, that the odds of successfully defending a total of 296 is higher than successfully chasing 370. A lot may be up for debate, but the fact that Bangladesh bowled poorly and Virender Sehwag and Virat Kohli batted brilliantly is not.

Pintu cleared of attempted murder charge

A Dhaka court yesterday acquitted detained former BNP lawmaker Nasiruddin Ahmed Pintu of an attempt to murder case.

Metropolitan Magistrate Farhana Ferdous passed the order after complainant Kabir Hossain of the case submitted a petition seeking an order from it that he would not run the case against Pintu.

Pintu was sent to jail on February 15, 2007 after he turned himself in to a Dhaka court to seek bail in the case.

Kabir Hossain, also a BNP activist of Baragram in Kamrangirchar area, filed the attempt to murder case against Pintu with the Chief Metropolitan Magistrate's (CMM) Court on January 25, 2007 after local police of Hazaribagh Police Station refused to record his complaint.

On June 26, 2006, Pintu called Kabir out of his house and beat up mercilessly with hockey stick and dumped him with fractured hands and injuries to the head in a nearby dustbin for "tarnishing" his [Pintu] image.

Sub-Inspector Tajul Islam, also the investigation officer of the case, submitted the charge sheet to the CMM Court of Dhaka, showing 13 people as prosecution witnesses.

Pintu was also shown arrested in different cases including graft and mobile snatching cases.

Though released on bail, Pintu was again arrested in June 2009 for his alleged involvement with helping Border Guard Bangladesh members to flee during mutiny at the Pilkhana.

He said the ship-breaking workers must be provided with relevant training and helmets, gloves and other necessary safety gears.

Modern technology must be used during breaking ships, the judge said, adding that oil tankers and nuclear and passenger ships, which contain toxic and hazardous materials, cannot be imported until they are cleaned.

Waste of the ships has to be dumped in a specific place so that environment and water are not polluted, the court observed.

Referring to a reported statement of Prime Minister Sheikh Hasina, who has recently said the shipbreaking sector is identified as a separate industry considering its huge potentials and economic benefit, the bench said the industry must follow the relevant




