

# Rapist gets life in Madaripur

## Victim rescued, one held in Joypurhat

One person was jailed for life for rape and kidnap in Madaripur while a rape victim was rescued and the alleged rapist was arrested in Joypurhat on Wednesday.

A court in Madaripur on Wednesday convicted a man and sentenced him to life term imprisonment in a rape case and 14 years jail in another case of kidnapping.

The court also fined him Tk 5,000 in the two cases, reports UNB.

The convict was identified as Samsher Hossain, 40, son of Yusuf Ahmed Mia of Lalbagh in Dhaka.

According to the prosecution, Dipa Akhter, daughter of Jahangir Matubbar of Chargabindapur village of Khoajpur union in Sadar upazila, was kidnapped and raped by Samsher on June 5, 2008. Police rescued Dipa from Lalbagh area on July 21, 2008.

Dipa's father filed two cases with District and Sessions Judge Court of Madaripur for rape and abduction.

District and Sessions Judge Court judge Ataur Rahman, handed down the

verdict.

According to our RU Correspondent, Rapid Action Battalion (Rab-5) on Wednesday night rescued a rape victim and arrested a man in this connection at Biswashpara village in Joypurhat.

Arrestee Ratan, 28, is son of Abdur Razzak of Biswashpara village in Joypurhat.

Rab-5 officials of Rajshahi Zone said, at around 8:00pm Ratan and his three accomplices allegedly raped the girl at a rented house of Kamal Hossain in Biswashpara village.

On information, a Rab team rushed to the house and rescued the victim.

Sensing the presence of Rab personnel, the rapists fled the house. However, acting a trip off, the Rab men later arrested Ratan from a house in the same village at around 9.00pm.

Following the incident, the victim filed a case with Joypurhat police station accusing Ratan, Bakul Hossain, 23, Md Suman, 24, of Biswashpara village and Md Bappy, 24, of Arambag village.

## Students protest hike in rent of pvt dormitories

Several hundred students, who stay at private-run dormitories for their study at different educational institutions in Dinajpur town, held a rally and formed a human chain yesterday protesting sudden hike in rent.

Protesting about 20 to 30 per cent rent hike by a 'syndicate' of house own-

ers of private dormitories in the district, the students also brought out a protest procession after their gathering on the premises of Dinajpur Government College.

After parading different streets in the town, the students joined an hour-long human chain in front of Dinajpur Press Club at noon.

About 15,000 students of different educational institutions of the district reside at private dormitories situated near the institutions, students said at their programme.

The institutions include Dinajpur Government College, Dinajpur Government Women's College, Dinajpur Polytechnic Institute, Dinajpur Vocational Institute and Hajee Danesh Science and Technology University.

Several hundred government and non-government officers and employees also stay at private dormitories, said the students.

The students alleged that owners of around 300 private dormitories in Dinajpur town recently formed a syndicate to raise the rent without consulting with the residents.

## BSF tortures Bangladeshi

A Bangladeshi cattle trader was tortured by Indian Border Security Force (BSF) at Tentulbaria border point on Friday night.

Victim Mizanur Rahman, 35, is son of Shukur Ali of village Agrabhul in Sharsha upazila under Jessore district.

Quoting locals Border Guard Bangladesh (BGB) sources said a group of cattle traders while returning home from India on February 24 were chased by BSF men at Tentulbaria camp opposite to Rudrapur border in Sharsha upazila. They caught Mizanur, took him to the camp and tortured him mercilessly.

Later they left the victim on the shoal of the bordering river Ichhamati inside the Bangladesh territory at about 3:30 am yesterday.

## HUMAN CHAIN, RALLY IN NILPHAMARI

# Potato growers demand more storage facilities

A human chain was formed in Nilphamari town yesterday demanding government's steps to provide potato storage facilities for the growers of the northern region so that they could save their produce from getting damaged.

Organised by Communist Party of Bangladesh (CPB), the participants also protested

hike in power tariff and demanded uninterrupted power supply in the region for boro farming.

Later, they held a rally at 'Chowraongi' intersection with Sreedam Das, president of CPB district unit in the chair. CPB leaders Atiar Rahman, Abdur Rahim, Solaiman Ali and Nazrul Islam addressed the rally.

The speakers demanded that the government set up more cold storage in the

region and ensure smooth power supply for boro cultivation.

Though the region saw a high potato yield, it could not make the growers happy due to abnormal fall in market price of the vegetable, the speakers said.

They protested hike in power tariff in the peak boro season and demanded uninterrupted power supply for irrigation of their land.

# 46 houses, 42 shops gutted

At least 46 houses and 42 shops were gutted in separate incidents of fire yesterday, the day before and on Thursday.

At least 13 shops and 3 jute godowns were gutted in a devastating fire early yesterday at Pukuria Bazar of Bhanga upazila in Faridpur.

Fire service men and locals said the fire originated from a kitchen of Mojib Chowkier adjacent to Pukuria Bazar at about 12.05am and soon engulfed the adjacent shops and jute godowns, reports our correspondent.

The fire damaged properties 400-450 maunds of jute, groceries and valuables worth about Tk 20 lakh, claimed the owners while the fire service men estimated the loss at Tk 10 lakh.

In Savar, a garments storeroom and 10 houses were gutted in separate fire incidents at Dhaka Export Processing Zone (DEPZ) and Norshingapur areas yesterday morning.

DEPZ fire service sources said the fire originated from an electric short circuit at the storeroom of SBC garments factory at BEPZA building at about 9.15am.

In another incident, 10 houses of the 'Sramik Polli' at Norshingapur under Ashulia PS were gutted by fire yesterday morning.

The extent of loss from the fire could go up to Tk 10 lakh, fire service men said.

In Patuakhali, at least 26 shops were gutted in a fierce fire which broke out near Nolkhola bus stand in Dasmina upazila early Friday.

Locals said the fire originated from an electric short circuit at a tea stall at about 3am and soon engulfed the adjoining shops.

At least 10 people sustained burn injuries while trying to put out the fire.

The affected shops owners claimed that cash and valuables worth over Tk 90 lakh were gutted in the blaze.

In Narayanganj, at least five people were injured in a fire at Masdair area on Thursday. The fire gutted 36 houses, three shops and three godowns.

The fire that originated from a jute godown of one Mamun and burnt dwelling houses, shops and jute warehouses, reports our correspondent.

The affected people claimed that they lost property worth Tk 50 lakh.
