#### men held for launched beating cop

Police arrested two Bangladesh Chhatra League (BCL) activists on charge of beating two traffic constables in the city's Lama Bazar area yesterday.

Two arrestees, Pinku Das, 18, and Ripon Das, 26, were immediately rushed to the Sylhet MAG Osmani Medical College Hospital as locals beat them up.

Police and witnesses said the incident occurred at the city's Lama Bazar point where a traffic constable stopped a rickshawpuller, as he ignored traffic signal.

Police said the two BCL men, who were travelling on the rickshaw, swooped on the constable Faruque Hossain all on a sudden.

#### officers being discriminated

Say gender experts

Female civil service officials have been facing different forms of discrimination during their posting, promotion, and transfer nowadays, according to gender experts.

Apart from disparities, they are also facing problems due to lack of childcare facilities and womenfriendly lavatories in their offices, said Prof Nazmunnessa Mahtab of women and gender studies department, Dhaka University.

Prof Mahtab was presenting the keynote paper at a consultation workshop at Cirdap auditorium in the city yesterday.

She also said, "I have found some women Bangladesh Civil Service (BCS) officers telling that they fall victim to teasing by their male colleagues."

The male officers are often found to have told the females "you will get promotion and better posting as you are a woman," said Prof Mahtab.

According to the gender expert, remarks of this type are gender insensitive that directly neglect qualification of a woman.

The workshop "Promoting gender equality and preventing violence against women at workplace" was jointly organised Labour and Employment Ministry and International Labour Organisation (ILO).

ILO's national programme officer Selina Ahmed moderated the workshop addressed by Labour Secretary Nurul Haque, Joint Secretary Abdur Razzaq, ILO Bangladesh deputy director, and Ranjan Karmokar of Steps Towards.

### Concern over removal of Prof Yunus

Different socio-political organisations have expressed concern over the government's decision to remove Nobel laureate Prof Muhammad Yunus from the office of the managing director of Grameen Bank.

They said the disrespectful attitude towards Prof Yunus would tarnish the country's image in the international community and requested the government to review the decision with utmost importance and tolerance.

In a written statement, Jatiya Party Chairman Hussain Muhammad Ershad said the decision is incorrect.

"Apart from playing an important role in reducing poverty with the help of Grameen Bank, he also earned Nobel Prize for his activities with the bank and make the country and the nation feel honoured the country and the nation," read the statement signed by Ershad. "If a personality like him faces disrespect

in his country like this, it would not be considered honourable for Bangladesh in the international community," it added.

Ershad believes the government is not

involved in the matter, and the debate can be ended if Bangladesh Bank withdraws its notice for the removal. The JP chairman also hoped for government intervention in the matter.

Jatiya Samajtantrik Dal (JSD), in a press release, said the government's attitude towards the Nobel laureate is wrathful, and it may cause millions of microcredit takers lose their faith in Grameen Bank.

Saying that the move may spoil Bangladesh's image in the international community, JSD leaders called on the government to consider the situation in a friendly and patient manner.

In another written statement, Mahbubuddin Chowdhury, secretary general of National Association of Unesco Clubs in Bangladesh, expressed dissatisfaction at the decision.

Stating that Prof Yunus has managed to put Bangladesh in the world map for a second time since Bangabandhu Sheikh Mujibur Rahman, Chowdhury requested the government not to create any debates regarding the Nobel winner and spoil the goodwill of Bangladesh.

#### Dowry puts her life at stake

A teenage girl who was beaten up seriously by her husband for dowry Wednesday is now struggling for life at Chittagong Medical College Hospital (CMCH).

CMCH sources stated critical the condition of Fatema Akhter Yasmin, 19, now under treatment at One Stop Crisis Centre (OCC) of the hospital.

The victim's mother Rabeya Begum told The Daily Star that Yasmin was married to Sohel Mian, 25, of the city's Madarbari area about a year ago.

During the wedding ceremony Sohel was given Tk 40 thousand and 1.5 tolas of gold-ornament, but he used to torture Yasmin from the very beginning for further dowry, said Rabeya. "Sohel demanded Tk 2

lakh from us and tortured my daughter seriously several times to put pressure on us to pay the said amount as dowry." The poor mother said they gave him Tk 60 thousand in phases only to see their daughter happy. Still the torture was continuing and Yasmin fled her in-law's house to her parent's house in Kazir Dewry area few days before, said Rabeya. According to sources,


Sohel along with some of his companions kidnapped Yasmin from in front of her parents' house around 3:30pmWednesday.

The miscreants fastened Yasmin's face with a towel, took her on a CNG-run autorickshaw, and beat her unconscious en route.

Passers-by rescued Yasmin while Sohel and his accomplices fled. They took her to CMCH where she remained unconscious till filing of the report around 7:00pm yesterday.
