Other West Pakistani politicians made it clear that they were not in agreement with Zulfikar Ali Bhutto, who they said had no right to speak for the whole of the west wing since the Pakistan People's Party had not won a majority in Baluchistan and the North West Frontier Province. The consensus among large numbers of West Pakistani politicians was that the only Suhrawardy Udyan) on over power at the centre to Sheikh Mujibur Rahman.

In Dhaka, a buoyant Bangabandhu congratulated the people of Bangladesh for observing the hartal called by him in a disciplined manner. statement of the complainant ASM Asif for over an hour and let the defence lawyer cross-examine the complainant.

After cross-examination for over an hour, the judge fixed March 9 for the next hearing.

Humayun Kabir Sabbir, a director of Bashundhara Telecommunications Network Ltd, was brutally killed on July 5, 2006.

Sanvir and two guards of Bashundhara Group Nure Alam and Humayun Kabir have been absconding since the case was filed.

In his deposition, Asif mentioned at about 11:30pm on July 4 of 2006, his brother-in-law Sabbir was talking to Sanvir over the cell phone where he said that he could not go out of residence so late at night. But Sanvir was pressing Sabbir repeatedly to go out.

The following day, a message came to his wife that an accident. His wife called Sabbir over his cell phone, but a policeman of Gulshan police received the call and said Sabbir had met an accident. Later, his wife came to know from the gatekeeper that Sabbir left the residence at 12:15am.

Asif tried to contact with Sanvir and his father Shah Alam. But he [Asif] was informed that they were busy with meeting. After a while, Abu Sufian, one of the directors of Bashundhara Group, told him that Sanvir and Shah Alam were abroad.

Asif went to the place of occurrence where Sabbin was found dead and went to a flat from where Sabbir had fallen. He found several portraits of Bashundhara Group family members. He also found there Shamsuddin Ahmed, an accused in the case.

Then he went to Dhaka Medical College and Hospital where Sabbir's body was taken for postmortem examination.

Meantime, Shah Alam made a phone call to him and said he wanted to meet Sabbir had fallen victim to and talk to him but Asif refused the proposal, the complainant added.

Probe delay irks court

On February 3, the court ordered further investigation into the case following a petition in which the prosecution brought allegations against some new BGB jawans in connection with the February 25-26 carnage in 2009 that left 74 people including 57 army officers killed.

Soon after the judge started the court proceedings yesterday, the prosecutor informed him that 25 BGB jawans have already been arrested.

He then pleaded for more time saying it is required to interrogate the arrestees, record their statements and find if more people were involved.

In response, the court said the state has to take huge burden and incur loss for such failure. "I came here keeping proceedings of another case suspended," the judge said.

"I hope you [prosecutor] will not fail to carry out your responsibility in future."

Prosecutor Mosharraf Hossain Kajol then tried to defend the prosecution saying there are some new developments.

During the proceedings, the court also heard several bail petitions filed by a number of defence lawyers. It rejected 521 bail petitions filed yesterday and on February 3.

But it observed that the accused have long been in the custody and they have the right to obtain bail.

Earlier on the day, 801 out of 824 accused of the carnage case were hauled before the make-shift court on the playground of Dhaka Alia Madrasa as 21 are absconding, one is dead and another accused is sick.

Meanwhile, out of the 25 BGB jawans arrested by the Criminal Investigation Department recently, the Chief Metropolitan Magistrate's Court, Dhaka, sent 22 to jail yesterday on completion of their two-day remand. Three were further remanded for three days.

FROM PAGE 20 considering relevant materials including the pending criminal case against Thomas in connection with palmolein import when he was a senior official in the Kerala state government, and the recommendations of the Department of Personnel and Training between 2000 and 2004 for initiating disciplinary pro-

ceedings against him. Centre for Public Interest Litigation, a non-governmental organisation, as well as retired bureaucrats and police officers challenged Thomas' appointment as the CVC.

The SC verdict against the appointment is a big embarrassment to the government that had defended his selection for the post.

It came at a time when the Congress-led government's image has taken a beating by a series of major scams including the one relating to sale of 2G telecom spectrum licence for mobile phones.

Opposition BJP and Left parties said their stance against Thomas' appointment as the CVC had been vindicated by the SC judgement.

"It is the biggest blow to the Congress-led UPA government, to the prime minister and Sonia Gandhi", said BJP spokesman Rajiv Pratap Rudy. The high-powered com-

mittee that had appointed Thomas as the CVC had included in it the prime minister, Home Minister P Chidambaram and the Leader of the Opposition Sushma Swaraj, had opposed the government decision and given a dissenting note.
