

(Milu) five years ago at a dinner party. Today I wish I had met him sooner, for Milu was a figure larger than life, and time spent with him was always memorable.

two weekend trips inside Bangladesh, a few walks along Baridhara Lake, and several social get-togethers. But his passion for life, his intellectual curiosity, and his love of adventure was so infectious that being around him for even a short time could affect one's view of life.

Milu loved Bangladesh, in particular, its people, places and history. He enjoyed driving his jeep to remote regions of the country. In 2009, I joined him and other friends on a trip to Birisiri, Netrakona. It was there that I first ries. noticed Milu's unconventional style. For example, he had an uncanny ability to establish quick rapport with local people. When we reached the Shomeshwari river, instead of exploring the new place, Milu became engrossed in a conversation with a senior boatman. Next day, this man provided us a boat for plying up and down the picturesque river. At one point, we left the boat and trekked to the emerald lakes set among some small hills. When we reached the hills, Milu charged to the top ahead of everyone else.

This was unnerving, because we all knew Milu was a heart patient. But this slowed him down not one bit.

Milu's knowledge of Bangladeshi Not that I spent much time with him: history was encyclopaedic. Touring a new place with him was like walking with a history book.

> At Birisiri, Milu waxed eloquent about the great leader Moni Singh (who hailed from that region) and his role leading the Hajong people of that area. While we were exploring Mahasthangarh in Bogra, he discussed the ancient civilization around Pundrabardhan. His words reflected a deep love and respect for the hardworking people of Bengal over centu-

Milu's actions also reflected this love. He established an urban health NGO through which he and other doctors dispensed free medical services. He also educated several students from his home Hatia on scholarship.

Once I bemoaned the failure of Bangladesh to attract foreign tourists. Milu's unexpected reply: "Why bother? See how beautiful it is? Influx of tourists will mess it up. Let Bangladeshis enjoy Bangladesh."

My last conversation with Milu was three weeks ago. Naturally, we planned another outing in his favourite country.

But that trip will never happen, for Milu passed away on February 20, 2011, In November 2009, we set out for ending a short but richly lived life. May

Govt blamed Grameen Bank Former staff for removal of Dr Yunus

Several NGO executives in a joint statement yesterday expressed deep concern over the termination of Nobel Laureate Dr Muhammad Yunus from the post of Grameen Bank managing director in a "disgraceful and abnormal" manner by the government.

They also criticised the government for not giving Dr Yunus the opportunity of self-defence.

Moreover a section of people are spreading propaganda against Dr Yunus following a Norwegian television documentary, though it was resolved by the Norwegian government many years ago, said the statement.

Government decision coupled with such propaganda will tarnish image of the country in international arena. The faith of 83 lakh Grameen Bank members and three crore microcredit borrowers in Bangladesh as well as several crores across the globe will be lost, they said.

Bangladesh Environment Lawyers' Association Executive Chief Syeda Rizwana Hassan, Credit Development Forum Executive Director Abdul Awal, NGO Federation Director M Tajul Islam, International Network of Alternative Financial Institutions Executive Director Atikunnabi and Bangladesh Shishu Odhikar Forum Executive Director Kafiluddin Ahmed signed the statement

If the reshuffle in the bank management was done in a positive way, it would help maintain the bank's stability and uphold the country's image.

They also urged the committee, formed to scrutinise the bank's activities, to take necessary steps to end misunderstandings, if any, between the govt and the bank management.

Meanwhile, two organisations yesterday condemned the removal of Dr Yunus from Grameen Bank and demanded review of the decision.

"The decision of removing Dr Muhammad Yunus from Grameen Bank is not only illegal but a testimony to colonial mindset," said Mukto Rajnaitik Andolon.

"The decision is an attempt to destroy the revolutionary steps of micro-credit, changing the lives of eight million destitute women, with the touch of a pen," it said, urging all to resist the government decision.

Another organisation, We Love Dr Yunus, in a statement, demanded review of the decision considering its probable disastrous effects on Grameen Bank.

"Grameen Bank and Dr Yunus are our pride and he should be treated in such a manner," it said.

SYLHET DOUBLE MURDER

Suspect confesses crime

Police yesterday arrested a suspect, who confessed in police custody of murdering a woman and her housemaid in the city last week, and sent him to jail.

Police found the partially burnt and decomposing bodies of Shaheda Akhtar Mili, vice-president of Jalalabad Rotaraci Club and activist of Sujon, and her housemaid Momota after breaking into their residence on February 28.

The arrestee Abdul Maleque, 30, a vegetable vendor of the area, gave his confessional statement at Chief Judicial Magistrate Court.

Maleque took a Tk 30,000 loan from Milli around two and a half months ago on condition of giving her a share of the profit, said OC Khondaker Naoroj Ahmed of Kotwali Police Station, quoting the statement.

When Maleque could not pay back and Milli threatened to file a case, Maleque strangled them and tried to burn the bodies to remove evidence, the OC added.

demand probe into

'irregularities'

A group of former employees of Grameen Bank, who claimed to have either been terminated or forced into retirement, yesterday demanded reinstatement of their jobs and probe into Nobel laureate Prof Muhammad Yunus'"irregularities".

They made the call at a press conference at Dhaka Reporters Unity in city yesterday, just two days after Prof Yunus was removed from Grameen Bank. Under the banner of

Grameen Bank Nirjatito Karmi Parishad (forum of repressed employees), they also demanded that all the activities of the bank be made public. Confused and failed to

answer properly some questions by the journalists, the bank's former employees said no one was behind them or persuaded them to hold the press conference.

Masum Sarkar, convener of the parishad, claimed that Prof Yunus misusing his power as the managing director terminated or gave temporary and force retirement to hundreds of employees of the bank.

Masum, also the former assistant general manager of the bank, however, said, "Prof Yunus did not embezzle money, but spent huge money wantonly."

The parishad leaders claimed that some 8,000 employees had faced termination or retirement, of whom some were fired several years ago and some recently.

Asked about the formation of their organisation, Masum said they formed it a month back but not all the 8,000 employees are the members of the organisation.

When asked if he sought help from labour court or conventional court, he did not reply properly. But the parishad leaders claimed some of the members, present at the programme, sought court's help.

Asked why they were holding the conference now, the convener could not specify and rather said they took some time to mobilise the 'illfated' employees. "Besides, the terminated employees are also persuading us to do something," said Masum.

Encroachers gobble up Atir Khal

An NGO team in a visit yesterday found grabbers have been filling the whole Atir Khal (canal) and its adjoining vast wetlands in Basila of the city.

The team of Bangladesh Poribesh Andolon (Bapa) also found Dumini canal in Khilkhet is being filled and narrowed at many points for different housing projects.

Bapa general secretary Abdul Matin led the team during its visit

inspect the water bodies' present condition. The team discovered Atir Khal is

almost dead due to unabated earth filling that has been going on in violation of wetland and open space protection act 2000.

Bapa team later inspected the Turag river from Amin Bazar to Tongi Bridge and found a vast portions of the river in Amin Bazar have been encroached by sand traders.

The bridges from Amin Bazar to to the two canals and the river Tongi except Amin Bazar Bridge

were also found too low, which will hinder movement of water transports in the circular waterway.

The encroachment as well as dumping industrial waste was going on at different points of the Turag narrowing the river and polluted it severely, according to Bapa.

Bapa team's visit to Dumini canal disclosed that the canal has been as narrow as a drain at different points, as it was filled with earth for different housing projects unceasingly.

Upon the visits, Bapa yesterday held a news conference at Civil

Engineering Building in the city to demand protecting of the three water bodies against land grab-

The environment organisation also demanded that the height of the bridges from Amin Bazar to Tongi on the Turag River be raised for smooth movement of water transports.
