Reopen the lone Rakhine language school in Kuakata

Community people urge government

People of Rakhine community in Kuakata have urged the government to take early steps for reopening their community school to facilitate mother language learning of their children.

Earlier Rakhine language was taught at a community school run by Rakhine people at the local Bouddha Bihar (pagoda).

But the century-old school that taught children for two hours from 7:00am to 9:00am daily was closed in 1998 due to lack offund. Later in January 2006, Rakhine youth

school on the ground floor of his residence at Karanipara in Kuakata to teach mother language to the community children.

Chin Than Monjur set up a community

from a pagoda in Chittagong. It started with around 20/25 community children and later the number of students

rose to 58. Imtiaz Tushar, a local youth also director

of Kuakata Development Society, took over the charge of the school after six months. He personally managed salary of the only teacher Monjur and other maintenance cost. He also collected some Rakhine language books from Myanmar and distributed it among students for free.

Following response from local people, Tushar also set up three more community schools in Mothaupara, Naiuripara and Nayapara in Kuakata area. Over 200 Rakhine children studied in these community schools. But after two years all these schools closed due to lack of fund.

"Our children cannot learn their mother language as there is no school here. Our new generation is about to forget their mother tongue. Many of them can speak their mother tongue as they learn it by hearing He also collected some old Rakhine books from their parents but they cannot write it, said Chin Than Monjur.

CEC due in Khulna today

Man killed by 'wife and son'

A man was killed allegedly by his wife and son following a family feud at Jaypur village in Nababganj upazila Saturday night. The deceased was identified as M Mizanur Rahman. Police said Mizan's son Rantu Miah and first wife Bulbuli used to quarrel with him for returning home often in drunken state. On Saturday night when he returned home in drunken state the mother and the son locked in an altercation with him. At one stage, they stabbed him indiscriminately, leaving him dead on the spot.

Woman, boy commit 'suicide'

A woman and a teenage boy allegedly committed suicide in the district yesterday and on Saturday night. The victims were identified as Muslima Begum, 45, wife of Mobarak Sana of village Sarulia in Tala upazila and Habibur Rahman, 15, son of Abul Khair of village Tulshidanga in Kalaroa upazila, also a student of class nine at Kalaroa Alia Madrasha. Quoting locals police said, Muslima took poison following a quarrel with her husband and died at home at about 10:30 pm on Saturday. In the other incident, Habibur committed suicide by hanging himself from the ceiling of his house at village Tulshidanga yesterday morning.

Poultry culled in Patuakhali

About 4,000 poultry birds of a farm killed in Patuakhali town were culled at about 8:00 pm on Saturday following detection of bird flue. Patuakhali Sadar upazila administration, livestock officials and policemen jointly killed the affected hens at 'Patuakhali Poultry Farm' at Bahalgachia in the town. Md Esha Mahmud, owner of the farm said he informed livestock officials following death of several hens at the farm. "They killed 3,700 pieces of hens of my farm and dumped them under the soil," he said.

Girl rescued from brothel

Police and DB personnel in a joint drive rescued a girl, aged 14, from a brothel at Daulatdia Monday night. The girl was identified as Happy, daughter of Kuddus Bepari in Sadapur Mohabbatpur village of Nababganj upazila of Dhaka district. She was working in a garment factory in Mirpur. Goalonda police station SI Ilias Munshi said Raju, a young boy allured Happy to marry her in Faridpur on November 30 last year. But, he sold out Happy to the brothel. Later, Happy's family came to know about it and took legal assistance from Ain Sahayata Kendra (ASAK).

Frauds decamp with depositors' money

Hundreds pauperised in Gaibandha

Aggrieved depositors laid a siege to the house of Unipay2u agent in Sundarganj upazila under Gaibandha district on Saturday afternoon demanding immediate return of their deposit.

Ismail Hossain Shaon opened Swarna Enterprise at Sundarganj upazila town as an agent of Unipay2u and started collecting money from depositors by offering very attractive benefit packages, locals

Giving assurance that the depositors will get double their money by ten months, Ismail was able to collect crores of taka from about two thousand depositors, they alleged.

With the hope of getting huge profit, people collected money from various sources including sale of landed property to 'invest' in the NGO project.

They became worried when the government imposed restrictions on the activities of Unipay2u following its dubious activities. Depositors strongly

demanded return of their money from the agent but in vain. Around two months ago, agent Ismail Hossain and

other employees of Unipay2u upazila office Swarna Enterprise fled away after locking the office fearing wrath of depositors.

Sex workers in Mymensingh brothel are crying for a shelter home to save their innocent kids from the 'dark world'.

Twenty-five of the 70 children in the brothel are school going. "For long we have

demanded a shelter home where our kids will enjoy a better environment to receive education to change their generations to come. There are shelter homes in Dhaka, Jamalpur, Tangail and Daulatdia but our demand for the same is yet to be met," said Hasna Hena, secretary of Shuktara, an organisation of sex workers at the brothel.

"Many children of a brothel at Sonagachhi in Kolkata of West Bengal got established there through receiving higher education as the authority arranged adequate shelter home facility," she said. "World Vision HIV/AIDS

a pre-primary school where our children can take their primary learning. We raised our demand in different forums on several occasions and urged the local administration for a shelter home but to no effect," she said.

"When the children need care in their reading table in the evening, we have to remain busy to entertain the clients to earn bread," said Monwara, a sex worker.

"We have to admit our children to different schools concealing the real address to save the kids from embarrassment. Some sex workers rent houses in the town for their children's education but it is not possible for all, said Baby Akhtar, assistant secretary of Shuktara.

School going Shimul, Kalu, Rony, Emon, Sagar, Ibrahim, Asha and Dulali -all staying with their mothers at the brothel, said they do not like the chaotic atmosphere and huge shouting of the drunken people.

'We want to receive education to live well like other children but who will come forward to help us?" said Shimul, a class two student.

"People neglect us and our mothers are helpless,' said Emon.

"We have no scope to come out from this hellish life. But we want our children to lead a decent life by receiving proper education," said Antora, a young sex worker and mother of a

ten-month old girl. "When the election comes, candidates give assurance to meet our demands to draw our votes. But after the election, they forget everything and keep themselves away as representatives of the civilised society," said Ayesha Begum, an elderly sex worker.

Restore time-scale, nationalise job

Agitating non-govt college teachers demand

Non-government college teachers yesterday staged demonstrations in several districts across the country demanding restoration of time-scale and nationalisation of their job.

In Barisal, non-government college teachers formed a human chain in front of Ashwani kumar Hall in the city and then held a rally at the venue, reports our correspondent.

Addressing the rally, the speakers threatened to launch a road blockade, programme and refrain themselves from the upcoming Union Parishad (UP) election and public examination duties if

their demands are not met by March 8.
