# GSMA calls for lower spectrum costs

GSM Association (GSMA) Director (spectrum) Kristin Due Hauge has suggested the government carefully consider the spectrum policies in the licence renewal guidelines for telecom operators.

Hauge said the authorities should not charge exorbitant fees for spectrum; otherwise the telecom operators may have to pull out of the market due to high costs.

Radio spectrum is the part of the electromagnetic waves corresponding to radio frequencies lower than 300 GHz (Gigahertz) used by the cellular telephone operators or broadcast television stations.

Exorbitantly high costs may restrict technological expansion in the country, which in turn may hinder in achieving the government's ambitious goal of a 'Digital Bangladesh', Hauge said. "It is about the government earning

more short-term revenues opposed to long-term growth and economic development of the country," she added.

Hauge suggested the telecom authority should review the tariff models in neigh-

The high frequency charges in the licence renewal process have become a large issue for the four telecom operators who have to renew their secondgeneration (2G) licences this year.

The four operators -- Grameenphone, Banglalink, Robi and Citycell -- will have to pay a combined Tk 28,000 crore in frequency charges during licence renewal.

The three GSM (global system of mobile communication) operators Grameenphone, Banglalink and Robi are operating at the frequency of 1,800 MHz (megahertz), while the CDMA (code division multiple access) technology-based Citycell operates at 900 MHz.

The telecom regulator had earlier sold each MHz of spectrum to the operators at Tk 80 crore in 2008.

## ICCB points to rising payment defaults in world trade

"The advent and continuing challenges of the financial crisis has seen a surge in defaulting which lead to rows between partners in international trade," said Mahbubur Rahman, president of International Chamber of Commerce Bangladesh (ICCB).

Rahman yesterday spoke at the daylong workshop on international trade finance: cases-analysis and solutions, organised by ICCB.

He said the increase in risk has seen a surge in use of the traditional trade finance instruments such as commercial letters of credit (LC) and standby letters of credit by the parties.

According to the recently published global survey: Rethinking Trade Finance 2010 by the World Trade Organisation, 34 percent of respondents had seen an increase in refusals, 44 percent had seen an increase in claims under standby LC's, 23 percent (up from 12 percent in 2009) had experienced an increase in the num-

> The ICCB president said international trade injects global competitiveness, so the domestic business units tend to become efficient being exposed to international competition.

The use of latest innovations in science and technology is essential to advance the agriculture sector and attain selfsufficiency in food by 2013, Agriculture Minister Matia Chowdhury said.

"The government will continue its initiatives to achieve self-sufficiency in food and ICT can play a key role in reaching the goal," the minister said at the launch of the BCS Digital Expo 2011 yesterday.

Bangladesh Computer Samity (BCS) in cooperation with the Ministry of Science and ICT, and the ICT Business Promotion Council organised the fair at Bangabandhu International Conference Centre in Dhaka. Matia said the government is commit-

ted to building a 'Digital Bangladesh' by 2021 by using modern science and technology and it has been working hard to accomplish the goal.

She said a remarkable development took place in agriculture through providing huge facilities to farmers over the last couple of years.

But she expressed concern that the population is increasing fast and cultivable lands are shrinking gradually.

"Though unplanned use of cultivable land is putting pressure on agriculture, we have to grow our food grains to ensure food security," she said.


Blaming the developed countries, Matia said: "They (developed countries) produce biofuels from food grains. They do not give us food. So, we have to grow our own food grains."

ICT can bring a revolutionary change to the agriculture sector, she said. "Our scientists have already discovered the genetic code of jute."

#### FBCCI urges govt to keep taxable ceilings unchanged

The apex trade body of the country yesterday urged the government to increase income tax and expand the VAT (value added tax) network without bringing in change to the taxable ceilings.

"Still many people remain out of the tax network. That's why, we have proposed an increase in tax and an expansion in the VAT network instead of raising the existing ceilings," said AK Azad, president of the Federation of Chambers of Commerce and Industry (FBCCI), at its office.

The FBCCI president made the comments at a meeting with a three-member World Bank delegation.

Ernesto May, director, poverty reduction, economic management, finance and private sector development of World Bank, South Asia, led the delegation accompanied by Sanjay Kathuria, lead country economist of World Bank in Bangladesh.

The trade lobby group's plea came as the National Board of Revenue (NBR) opened discussion with stakeholders and trade associations in the run-up to framing the proposed budget for fiscal 2011-12.

The FBCCI also expressed concern over shortage of funds in the banking system, resulting from banks financing to power sector projects, import-based commodities and cotton, prices of which have gone up on the world market.

Presently, the lowest ceiling for individual income tax is Tk 165,000, while a 15 percent uniform VAT (value added tax) is applicable for both goods and services. Ernesto May said increasing the domestic resources

in the form of revenue collection is important. In Bangladesh, domestic resource is 11 percent of

its GDP (gross domestic product). He said the World Bank is engaged with the government and trying to bring in international expe-

riences in VAT. The FBCCI chief also called upon the World Bank to invest under public private partnership (PPP) ventures to reduce power crisis and improve railway and river
