19,000 to fly in within week

Biman starts operating flights March 13

Repatriation of the remaining 19,000 Bangladeshis who fled trouble-torn Libya and are now stranded in Egyptian and Tunisian borders, is expected to be completed within a week through joint operations by IOM chartered flights and Biman Bangladesh Airlines.

In a bid to speed up the repatriation, five flights of Biman will be put into operation from March 13 to bring back the Bangladeshis from Egyptian border.

Addressing a press briefing, Foreign Secretary Mijarul Quayes said that 1,928 Bangladeshis were repatriated from Egypt, Tunisia and Greece yesterday.

With this, about 11,226 Bangladeshis were repatriated from Egypt, Tunisia and Greece till date, he said.

Meanwhile, the apex trade body FBCCI yesterday declared that it would create a fund for the rehabilitation of the returnees.

"We will create a fund with contributions from different trade bodies and the government for rehabilitation of our brothers," said AK Azad, president of the Federation of Bangladesh Chambers of Commerce and Industry (FBCCI) at a discussion in the capital yesterday.

Mother sues 9 'rapists'

Nine alleged rapists of Serafina Mardi, an ethnic minority girl who committed suicide failing to stand humiliation, were sued yesterday with the first court of Women and Children Repression Prevention Tribunal here.

Tribunal Judge Afzal Hossain took cognisance of the case filed by the victim's mother Sushana Soren.

The accused -- Nirmol Soren, Porimal Soren, Rajon, Jewel, Elias, Shimon Hembrom, Simon, Julian, and Karlus Mardi -- are still free. The tribunal asked Godagari police to probe the alle-

gation in line with another case filed by police for provoking the girl to take her own life.

Serafina of Amtulipara in Godagari upazila committed suicide by setting herself on fire on February 20 to protest an out-of-court settlement of her rape.

A catholic priest and 12 other community leaders allegedly forced the victim and her family members to follow the agreement in order to protect their religion in the village.

After settling the gang rape incident, the rapists and community leaders forced Serafina to marry Nirmol under false pretences only to escape rape charges, alleged Sushana.



TORTURE IN CUSTODY

JS body okays bill with harsh punishment

A parliamentary body has recommended enactment of a bill with provisions of harsh punishment for torture and inhuman or degrading treatment by law enforcers or government officials.

The Parliamentary Standing Committee on Private Members' Bills and Resolutions in a report in parliament yesterday made the recommendation for passage of the Torture and Custodial Death (Prevention) Bill with some modifications.

Abdul Matin Khasru, chief of the parliamentary body, submitted the report after scrutinising the bill placed by Awami League lawmaker Saber Hossain Chowdhury in the House in 2009. The bill proposes stringent punishment of life impris-

onment at maximum and also fine for committing the offences. Officials charged with the offences will not be able to justify their acts citing exceptional circumstances includ-

ing a state of war or emergency, political instability or order

of a superior or a public authority, according to it. The bill was drafted in conformity with the UN convention against torture, and cruel, inhuman or degrading treatment or punishment.

Bangladesh on October 5, 1998 signed the convention adopted on December 10, 1984 with a promise to create an effective legislature and take administrative, judicial SEE PAGE 6 COL 3
