In Patuakhali district, 391 filed nomination papers for 61 chairman posts, 2,470 for 549 ward councillor posts, and 739 for 183 female reserved seats in 61 union parishads under seven upazilas of the district.

In five upazilas of Barguna district, a total of 2,025 candidates are contesting for chairman and councillor and reserved women councillor posts in 35 union parishads. Of

In Jhalakathi district, 181 candidates are in the election race for 32 chairman posts, 1,160 for 288 councillor posts, and 366 for 96 female reserved seats in 32 union parishads under four upazilas.

A total of 3,193 candidates are in the election race in 52 union parishads under seven upazilas of Bhola district. Of the candidates, 310 are vying for 52 chairman posts, 2,234 for 468 ward councillor posts, and 649 for 156 female reserved seats.

In Pirojpur district, 309 candidates filed nominations for 49 chairman posts, 1,970 for 441 ward councillor posts, and 582 for 147 female reserved seats.

Manirul Islam, acting deputy election commissioner in charge of Barisal division, said voting will take place on March 29, 31 and April 3. Number of voters in 307 union parishads under six districts of the division is 44, 05,529, he added.

#### Betel leaves on 7 more bighas 'torched'

Betel leaves on seven more bighas of land in Kaliganj upazila of Jhenidah district were 'torched' yesterday.

The incident took place at Balarampur village at around 3:30pm. Villagers brought the blaze under control after two hours of frantic efforts.

The affected farmers are Tapan Kumar Das, Chandi Kumar Das, Bishnu Kumar Das, Ganesh Chandra Das, Shasti Chandra Das, Laxmi Chandra Das, Bikash Kumar Das, Ashok Kumar Das, and Rabindra Nath Bishnu.

"I saw smoke in a betel leaf garden of Ganesh Chandra Das at around 3:30pm. The fire spread very fast to the adjacent gardens and gutted betel worth about Tk 30 lakh," said Akbar Ali, an elderly resident of Balarampur village.

This was the fifth arson attack on betel leaf gardens in the upazila since February this year. The latest attack was made on March 9 on around 500 bighas of land in four villages of the upazila, destroying betel leaves worth about Tk 20 crore.

Betel leaves on 60 bighas of land were torched on February 9, on 20 bighas of land on February, 20, on 50 bighas of land on February 22, and on 500 bighas of land on March 9 at Raigram and Dulalmundia village in Kaliganj upazila of the district.

The mystery behind the fire incident that caused indescribable loss to the farmers is yet to be unearthed.

#### AL lawmaker's house looted in Barisal


House of a ruling Awami League lawmaker, also district AL office secretary was looted in broad day light in the city yesterday.

Advocate Talukdar Md. Yunus, the AL MP, said unknown criminals broke open of the door of his rented house on the second floor of Afsana Cottage at Anami Lane and looted goods worth Tk 3 lakh and Tk 1.75 lakh between 11:00am and 12:30pm.

The lawmaker was attending a programme at his constituency Gournadi and his family members were residing in Dhaka at the time of the incident.

H M Manik Hossain, a headmaster of Dhandoba School in Gournadi, came to visit him at 2:30pm. Getting no response after repeated calls he found the door open and house ransacked.

The AL lawmaker was informed immediately and high officials of police and other law enforcing agencies rushed to the spot. A case was lodged in this connection with Barisal Kotwali police station.

#### Boy drowns at Madhabkunda waterfall

A nine-year-old boy fell in a well of Madhabkunda waterfall and drowned on Saturday.

Body of school student Pevez Ahmed Bappi was recovered by the fire brigade divers from the well yesterday morning.

According to the fire fighters and Baralekha police, Bappi and his brother-in-law Firoz Miah met the tragic accident at the tourist spot while they were riding a hill adjacent to the well. Suddenly they slipped and fell into the well. Firoz was rescued at once but Pevez went missing. Both were members of a 60-member tourist team from Gazipur.

Local people tried to rescue Bappi but failed. Later a team of fire brigade divers came from Dhaka yesterday morning and recovered Bappi's body from the well.

Relatives of Bappi yesterday returned to Gazipur with the body. His brother-in-law Firoz Miah was admitted to Baralekha upazilahealth.complex.

Bappi was a student of class IV at Dhumbarishala Government Primary School under Sreepur upazila of Gazipur district.

#### BNP activists attack police

Two policemen were injured as BNP activists threw brickbats on them from a procession in Jhikorgachha upazila bazaar bus stand area Saturday evening. Police said local BNP organised a protest meeting demanding withdrawal of a defamation case filed against BNP leader and publisher of a local daily former minister Toriqul Islam in bazaar area Saturday afternoon. After the meeting, when the processionists were passing by the bus stand, some activists threw brickbats targeting police, leaving the two police officers injured, said OC Abdur Razzak of Jhikorgachha PS. The injured were admitted to the upazila health complex. A GD was filed.

#### Jute seeds seized, one held

Detective branch of police here seized 423 packets of low quality Indian jute seeds and arrested one Belal Hossain from Chawk Rampur area in the town on Saturday. Arrestee Belal Hossain is son of Abdus Salam of Jongli Bograpara village under Natore Sadar upazila. He was allegedly involved in repacking the date-expired low-grade seeds. Local people and sources said, Abdus Rahim, 45, his younger brother Abdus Sattar, 40, and Rahim's brother-in-law Abdul Quddus used to make and sell fake jute seeds in the name of an Indian company. Nasirul Islam, acting superintendent of police in Natore, said, on secret information, DB police seized about 300 sacks of fake 'Bharot Nursery' seeds from Chawk Rampur area and arrested van driver Belal. Later, the team raided Rahim's house and seized more than 120 bags of seeds and tools for making fake seeds.

## Jamaat sues 1,000 AL men in Nilphamari

Jamaat-e-Islami Bangladesh has sued 1,000 local leaders and activists of Awami League and its front organisations on charge of damaging, ransacking and torching its district party office. Though the incident took place more than a year ago on 13 February, 2010, Jamaat

Nayeb-e-Amir (vice president) of the local unit of Jamaat Azizul Islam filed the case with the court of Monjur-e-Alam, chief judicial magistrate of Nilphamari.

The court accepted the case and directed the judicial magistrate Ramesh Chandra Daga to start investigation and file a report within 5 May.

After filing the case, Jamaat men tried to conceal the matter, but somehow it came to light on Friday. This has created tension among
