The High Court yesterday directed the authorities concerned to demarcate areas of all the parks and playgrounds in the capital and demolish the structures except those that were built for the purpose of sports and religion.

Delivering a judgement on two separate writ petitions, the court said no structure could be built inside the boundaries of the parks and playgrounds of the capital from now on.

According to the statements of the writ petitions, there are 68 parks and 10 playgrounds in Dhaka city and different types of structures including residence

Still occupied flouting High Court order of 2004

A limited company named after prime minister's slain brother Sheikh Jamal continues occupying Dhanmondi road-8 playground, as Dhaka City Corporation has ignored the High Court (HC) directions in this regard for seven years.

Dhanmondi Club, which has been occupying the playfield for four decades with unauthorised structures and without permission, was turned into a limited company named after Lieutenant : Sheikh Jamal in August 2009.

DCC, official custodian of the playground, has ever been permissive of its unauthorised occu-: pancy and commercial uses in clear disregard to : HC directions.

Following a writ petition, a HC bench in April and Bangladesh Poribesh : 2004 directed the DCC mayor to report to the court : within 20 days as to what actions it had taken to Bela filed the petition in : preserve the playground and remove the : unauthorised semi-concrete structures there.

DCC Mayor Sadeque Hossain Khoka evaded an answer to why they did not free the playground of : unauthorised occupancy despite HC directions. : He just said the law section would take care of legal

Prof Muzaffer Ahmad, a resident of Dhanmondi and noted environmental activist, said the playground would embrace the same fate as Abahani field has, denying the residents a free open space.

Manzur Kader, president of the club, told The Daily Star at the time of renaming the club that they would build a mini stadium on the playground including a six-storey club building, cricket pitch, football and hockey ground, and swimming pool with gymnastic facilities.

He also said the club would be formed in the pattern of elitist Dhaka Club, Gulshan Club, and Uttara Club.

The HC, however, restrained anybody from altering the character of the playground.

The club recently persuaded DCC to replace the existing boundary wall of the playground with an expensive one at a cost of more than half a crore

A recently-excluded member of the club's 11member executive committee said the club takes huge financial contribution from various highprofile businesspersons in the name of sports.

Asked how the club has been running its activi-

ties in the playground without permission with unauthorised structures, Manzur Kader said, "You better talk to the prime minister and do whatever you wish."

Md Mashiar Rahman, chief estate officer of DCC, said, "We have not authorised anybody to take possession or care of the playground. Those who are there are occupying the playground ille-

Public Works Department (PWD), owner of the 13.5-bigha Dhanmondi playground, handed it over to DCC in January 1984 for maintenance and conservation.

The DCC did not live up to its duty as a custodian to prevent the illegal occupancy, said Abdul Kader Chowdhury, executive engineer of PWD.

The public works ministry in July 2008 decided to free the playground of any illegal occupancy and maintain it as a public open space. Nothing has happened yet to carry out the decision.

A HC bench in May 2003, following a writ petition filed by Bangladesh Environmental Lawyers Association (Bela), issued a rule upon the government to ensure proper maintenance and protection of the playgrounds and open spaces.

Dhaka requests Tunis to help fly 7,701 nationals 2,931 return home today

The government has sought landing permission of Biman aircrafts in Tunisia to expedite the repatriation of 7,701 nationals now stranded in the Tunisian border, Ras Jdir.

Two aircrafts of Biman Bangladesh Airlines have

already carried 600 Bangladeshis, and remaining 845 passengers will be repatriated in next couple of days. Besides, Biman will operate two additional aircrafts

tomorrow (March 17) to complete repatriation from Egypt. Foreign Minister Dipu Moni at a press briefing yester-

day said a total of 20,994 Bangladesh nationals have already repatriated to Bangladesh, and another 2,931 people are due to return today. She said that currently, there are about 25,000

Bangladeshi citizens inside Libya, and they have been evacuating to safer areas. So far 33,735 Bangladeshis have left Libya fearing

deadly clashes.

"We are now awaiting Tunisian government's permission to operate Biman flights. The foreign secretary is now in Tunisia and holding meetings with government officials regarding Biman's landing permission and assurance to continue allowing Bangladeshis in its border till completion of repatriation," Dipu Moni said.

She said the influx of Bangladeshis at the border point of Al Salloum in Egypt has decreased remarkably.

According to Dipu Moni, the foreign ministry was informed that there are 189 Bangladeshi nationals staying in Ain-Amenas, a southern city of Algeria that is close to Libyan border.

The IOM has taken necessary preparations to repatriate the 189 Bangladeshi citizens, she added The foreign minister further informed that the Greece

government has recovered more bodies in Crete Island, but all of them are yet to be identified. "We are suspecting that the bodies may be of the 11

Bangladeshis who jumped from ship and went missing during evacuation at Hania Port in Crete Island," she added. She said three bodies have earlier arrived in Dhaka

and Greek police on Monday received another body, which the Bangladesh embassy in Athens has identified as Ruhul Amen, son of Majir Uddin of Hasan Lata in Dange Bazar, Polan, Narsingdhi. Meanwhile, Dipu Moni said that while returning

from Egypt, she held a meeting in Dubai with the Bangladesh ambassadors from Saudi Arabia, Kuwait, United Arab Emirates, Iran, Jordan, Oman, and Qatar and discussed the situation, in which Bangladeshis are residing in these countries.

Produce Jamaat top leaders before int'l crimes tribunal

Jail authorities asked

The International Crimes Tribunal yesterday asked the jail authorities to produce five detained Jamaat-e-Islami leaders including its Ameer Motiur Rahman Nizami before it on April 20 in connection with war crime charges.

The four other Jamaat leaders are Secretary

General Ali Ahsan Muhammad Mojahid, senior assistant secretaries general Muhammad Kamaruzzaman and Abdul Quader Molla and Nayeb-e-Ameer Delwar Hossain Sayedee.

The three-member tribunal headed by Justice Nizamul Huq directed the prosecution to submit the progress reports on the investigation into the war crimes allegations against the five leaders by April 20.

The tribunal also directed the jail authorities to provide necessary treatment to Sayedee Bangabandhu Sheikh Mujib Medical University (BSMMU), if necessary.

The tribunal passed the order in respect of Nizami, Mojahid, Kamaruzzaman and Quader Molla in a suo moto move, while passed the order in respect of Sayedee after hearing a petition filed by the prosecution seeking time for completing investigation against him.

The tribunal, however, rejected a petition filed by Sayedee seeking bail in connection with the war crime charges.

Sayedee was produced before the tribunal after it began proceedings at about 10:30am.

Earlier in the morning, the prosecution placed six "case diaries" (regular progress) of

gations brought against him. Sayedee is a very influential political person and may hamper the investigation and threaten the witnesses if he is free, Haider Ali argued.

Sayedee's counsel Tajul Islam told the court the prosecution could not show any progress in the investigation against his client, who should not be detained on "false" charges.

He prayed for his client's bail saying there is no evidence of the allegations against him.

Tajul also prayed to the court to ask the jail authorities to take necessary steps for proper treatment of his client.
