Plunderers now protectors

The number of cases filed for stealing resources in Madhupur forest sees a significant fall during the last several months as once forest resource plunderers are now serving as community forest workers, helping protection and development of the traditional sal forest.

The dramatic change appeared as forest department in June-July last year provided 400 people two months' training under a project styled 'Revegetation of Madhupur Forest through Rehabilitation of Local and Ethnic Communities'.

As many as 368 and 354 cases were filed in 2008 and 2009 for stealing resources in Modhupur forests, said sources of forest department in Tangail.

But only 20 such cases were filed last year while the number of cases filed in first two and a half months this year is three, they said.

Since the independence, around 18000 cases have been filed for stealing of Madhupur forest resources and around 3000 of them are under trial at present.

Once spread over 45,000 acres of land, Madhupur forest has now shrunk to only 8,000 acres, forest department sources said.

To save the traditional forest from gradual extinction, forest department last year made a list of 500 tree plunderers and provided

The participants received trainings on apiculture, mushroom cultivation, nursery, afforestation, fire fighting, poultry, cow fattening, fish farming, vegetable gardening, grass growing, compost fertiliser production, cultivation of medicinal plants, production of jam and jelly etc.

Preparations are on to provide similar trainings to some 150 more people, said a forest official.

"I was accused in over 100 forest cases as I had been stealing trees from Madhupur forest since my boyhood. But now I am serving as a community forest worker to protect the

forest," said a middle-aged

man of Gachhabari village in

Madhupur upazila. The government has also arranged grants and aids for rehabilitation of 5500 families living inside Madhupur forest. As per plan to make the dwelling houses envi-

ronment friendly farmhouses, each family has got 100 saplings of firewood trees, 50 saplings of fruit trees and 50 saplings of forest trees.

They have also got grant for cattle raising and cultivation of vegetables and medicinal plants.

Each of the families was also given a modern furnace so that they do not have to use wood as fire.

"Following failure to save the forest and its resources by filing cases for years, we are implementing the project to preserve forests by rehabilitating the forest dependent people and including them in the process to protect forest resources. The government has provided Tk 15 crore from its Climate Trust Fund for the purpose," said Asit Ranjan Paul, divisional forest officer in Tangail.

Influential forest plunderers, both locals and out siders, have also grabbed vast areas of forestlands and raised orchards including pineapple and banana plantations and set up makeshift structures there, forest department sources said.

Over 40,000 people living in 57 villages, set up in Madhupur forest areas after 1950, are dependent on the forest resources for livelihood

Besides, over 100 brickfields made around Madhupur forest in seven upazilas of Tangail and Mymensingh districts are dependent on the firewood from the forest to burn bricks.

Verdict in case against 52 mutineers today

Charges against 71 others framed

The special court-17, set up at Six Battalion headquarters in Jamalpur under BGB Mymensingh sector, will deliver judgement in the mutiny case against 52 jawans of the battalion today.

The court, headed by Kushtia Sector Commander Col Md Nazrul Islam Sarker, framed charges against the accused on completion of arguments between the prosecution witnesses and the accused on February 9, according to a correspondent.

Two other members of the court are Lt Col Gazi Md Salahuddin and Major Md Ashfaque Hossain. As many as of 11 witnesses gave their statements before the court. The accused claimed innocence and begged for mercy.

Meanwhile, Mutiny charges against 71 jawans of 30 Battalion under Khagrachhari sector were framed yesterday.

Trial of the mutiny case against 52 jawans of Jamalpur battalion began at the special court--17 on November 24 last year. At the beginning, Deputy Assistant Director (DAD) Md Azizul Islam of the battalion brought allegations against 52 jawans.

The DAD told the court that the jawans

revolted against their officers on February 26 in 2009, took control of the battalion headquarters and looted firearms and ammunitions from armoury, court sources said.

In Khagrachhari, the special court-15, headed by Lt Col Abu Wahab Mohammad Hafizul Haque, yesterday framed charge against 71 mutineers of 30 Battalion, reports a correspondent

Prosecutor Lt Col Md Zakir Hossain read out the charges in presence of the accused at the court.

According to the charges, the jawans

revolted against their officers at the battalion headquarters in Panchhari on February 26, 2009 and looted arms and ammunition from armoury. One of the accused named Md Faruk Mia

confessed to his involvement in the mutiny while the rest 70 claimed innocence. The special court will start recording

depositions of the prosecution witnesses today and asked the authorities concerned to produce all the 71 accused in the court at 9:00am today.

Two others member of the court are Lt Col Sayadis Sakline and Major AZ M Golam Mostafa AL Mamun.

15 houses, 12 shops gutted

At least 15 houses and 12 shops were gutted in two districts yesterday and the day before.

In Kishoreganj, 15 houses were gutted in a fire at Kalatoli in Karimganj upazila early yesterday, reports our correspondent. Sources said the fire origi-

nated from the cowshed of one Siraj Miah and soon engulfed the adjoining 14 houses. On information, fire fighters from the district

town rushed to the spot and doused the blaze in one and half hours of hectic efforts. One Sirajul Islam was

injured by fire and admitted to Karimganj health complex.

Fire service sources said the loss was primarily estimated at Tk 30 lakh.

In Patuakhali, at least 18 shops were gutted at Gopalia bazaar under Baufal upazila on Monday midnight damaging goods worth over Tk 20 lakh, reports our correspondent.

Locals said, at about 1.30 am, a fire originated from a pharmacy owned by Delwar Hossain and spread to other shops. On information fire service men from Baufal upazila headquarters rushed to the spot and brought the fire under control.

Girl rescued from brothel

A man was arrested along with fake currency notes from a shop at Darbasta bazaar in Jointapur upazila


on Saturday night. The arrestee was identified as Zohir Uddin, son of Mahmud Hossain of Kurikhola village in Goainghat upazila of the district.
