Nation observes Bangabandhu's birthday today

The government and various socio-cultural and political organisations have chalked out elaborate programmes to mark the 91st birth anniversary of Father of the Nation Bangabandhu Sheikh Mujibur Rahman and the National Children's Day.

BSS adds: The nation will observe the 91st birth anniversary of Bangabandhu and the National Children's Day today with due respect and festivity.

The day is a public holiday. Bangladesh Betar, Bangladesh Television and private TV and radio stations will air special programmes, while national dailies will publish special supplements highlighting the significance of the day.

Paying rich tributes to Bangabandhu, President Zillur Rahman and Prime Minister Sheikh Hasina gave separate messages on the occasion.

President Zillur Rahman and Prime Minister Sheikh Hasina will visit Tungipara, the birthplace of Bangabandhu, this morning and place wreaths and offer munajat at his mazar there. The prime minister will

address a children's rally on the mazar premises, open a library and distribute sewing machines among the distressed people.

After returning from Tungipara, the president will inaugurate the National Children's Day programme to be arranged by Bangabandhu Shishu Kishore Mela a Bangabhaban at 12 noon.

Bangladesh Awami League has drawn up countrywide elaborate programmes to observe the day in a befitting manner.

The programmes include hoisting of the national and party flags at Bangabandhu Bhaban in the city and Awami League offices across the country at 6:30 am, placing of wreaths at the portrait of the Father of the Nation in front of Bangabandhu Bhaban at Dhanmondi at 7:00am.

A central delegation of the party led by its President and Prime Minister Sheikh Hasina will place wreaths at Bangabandhu's mazar at Tungipara.

Sheikh Hasina will address as the chief guest a discussion to be organised by Awami League at the Bangabandhu International Conference Centre in the city at 4:00pm on Friday.

Court summons 'bribe taker' SI April 13

A Dhaka court yesterday summoned a sub-inspector of Mirpur Police Station to appear before it on April 13 in connection with a case filed against him for his involvement in taking Tk 5,000 as bribe from the complainant of a case.

Judge Mohammad Zohurul Haque of Senior Special Judge's court passed the order after taking the charge against SI Rakibul Hassan into cognisance.

On March 3, Jahangir Alam, assistant director of Anti-Corruption Commission (ACC), submitted to the court the probe report against the SI.

Jahangir in his report said he investigated the incident that SI Rakibul took Tk 5,000 in bribe from Ferdous Ara, complainant of another case.

During the investigation, Jahangir recorded statements of Ferdous Ara and 14 others and found Rakibul involved.

ACC Assistant Director Anwarul Haq filed the case against Rakibul on December 19, 2010 with the Senior Special Judge's Court of Dhaka for committing such offence.

Around 10:00am on Thursday, young boy Morshed Hossain with a plaster cast on his broken leg at Pallabi 111/2 bus stop in the city was struggling to hire a CNG-run threewheeler. But the drivers present there did not want

to go to his destination, Bangabandhu Sheikh Mujib Medical College Hospital in Shahbagh. After futile effort for over an hour,

Morshed hired a rickshaw and went to Purabi bus stop, adjacent to Pallabi, in quest of one but faced the same situation. Though a driver showed his interest to go,

he demanded Tk 200 as fare, a distance that costs Tk 100 to 150 by metre. On the other hand, even if Morshed goes by metre, he has to pay Tk 20 more on

what the metre read reaching his destination, in compliance with the driver's demand. I was talking to

Morshed while he was bargaining with the driver, Ruhul Amin. As soon as Ruhul realised that a journalist is present, he immediately expressed his willingness to go by metre, without additional charges.

"I failed to reach the doctor by 11:00am as the drivers are unwilling to go there," said Morshed.

Similarly, Afroza Begum, a resident of Forashganj in Old Dhaka, was in urgent need to reach Shikdar Medical College Hospital as her relative died in the morning. She too failed to hire any auto-rickshaw after trying for about an hour.

When one did agree, he said he could go only up to Dhanmondi 15 instead of the full distance to Shikdar, putting the blame on an empty gas tank.

Like Morshed and Afroza, many city dwellers are suffering this phenomenon: the CNG-driven 3-wheeler drivers are not obeying the government decision to go by metre. According to the government decision, every CNG-run three-wheeler is also bound to go as per passenger requirement.

Violation of these rules is frequently occurring, as drives by both Dhaka Metropolitan Police (DMP) Traffic and Bangladesh Road Transport Authority (BRTA) are now infrequent.

Tapan Kumar Sarkar, director enforcement of BRTA, said its special drives are now paused and will resume soon.

During the drive, beginning January 16 and ending February 8, BRTA filed 1,062 cases against defaulting drivers and fined them around Tk 4.91 lakh, said Tapan.

For similar reasons, the team also seized 40 CNG-run three-wheelers and scrapped

them on dumping grounds, he said.

whether seals of the designated company and BRTA are on the metre after calibration and whether any privately owned three wheeler is plying

commercially," said Tapan. Additional Commissioner Mili Biswas of DMP Traffic said they are continuing drive

against the violators. The government took the decision on January 16, setting a charge of Tk 25 (previously Tk 14) for the first two kilometres and Tk 7 (previously Tk 6) for each subsequent kilometre.

Responding to the owners' demand, the government also increased the daily rent an auto-rickshaw driver has to pay to the owner to Tk 600 from Tk 450. The government fixed the minimum fare at Tk 25, from a previous

Proposal on 832 flats for low-income group okayed

The government will provide 1,230 square feet flats to low and medium income people at Mirpur in the city within a price range of Tk 45 to 50 lakh on hire purchase basis.

Cabinet committee on purchase yesterday approved a proposal to construct 832 such flats under Anandanagar Residential Flat Construction project at Mirpurwith an estimated cost of Tk 248 crore.

Each 14-storied building will have 52 flats. Each contractor -- Civil Engineers Ltd, Biswas Trading and Construction, Ena Properties Ltd, and KSBL-JVCEL-H&S JV will construct four buildings.

Housing and public works ministry's proposal said if solar panel is installed and rain water harvesting is added with the

buildings, each flat will cost Tk 48.89 lakh. Without them, each flat will be priced at Tk 45.89 lakh.

The government planned construction of 33 buildings under the project on 7.50 acre land at city's Mirpur.

The committee also awarded China Communication Construction Col Ltd, a consultant firm, the contract to conduct feasibility study for construction of a tunnel under Karnaphuli River in Chittagong at a cost of Tk 12.43 crore.

Proposal to purchase 41,486 electric poles for greater Mymensingh and Sylhet regions was also okayed. Charka SPC Poles Ltd JV got the Tk 79.24 crore work order.

Besides, the committee approved a proposal to import 25,000 metric tonnes of urea fertiliser from Qatar at a cost of Tk 70 crore.

'Block financial sources of militants'

Speakers at a rally yesterday demanded the government to expedite trial of people who committed war crimes and crimes against humanity and block financial sources of militants.

An immediate trial is a prerequisite to ensure democracy and progress of society, they said, demanding the ban on communal politics and trial of all grenade attacks including the one on 21 August.

Shamprodayikata-Jangibad Birodhi Mancha (a platform against communalism and militancy) organised the rally at Central Shaheed Minar in the city where its Joint Convenor Ziauddin Tarik Ali read out a declaration of the platform.

"Why should we demand the trial? Those who committed crimes against humanity have to be tried. A quick trial would rid the nation of the stigma," said Deputy Speaker of the Parliament Col (retd) Shawkat Ali.

Industries Minister Dilip Barua said the trial of war criminals will be held and verdict of the trial will be made effective in this land.

Jatiya Samajtantrik Dal President Hasanul Haque Inu said the politicians would have to ensure trial of those arrested.

Ajoy Roy, convenor of the mancha, presided over the rally while Dr Nur Mohammad Talukder, member secretary of the organisation, moderated.
