# French rally for Prof Yunus

FROM PAGE 20 conviction, a giant in the fight against extreme poverty," reads an op-ed titled "We must save Grameen Bank and microcredit in Bangladesh" on March 16 in the French newspaper Le Monde by former prime minister Rocard, former International Monetary Fund (IMF) managing director Michel Camdessus, Member of Parliament Jérôme Chartier, Friends of

Hirsch. "We do not accept that Grameen Bank will become a state-owned tool or, even worse, a tool of propaganda," the article reads, according to a statement of Friends of Grameen.

The opinions came as supporters of the Nobel laureate are increasingly voicing concern that the government, which owns less than 5 percent of Grameen Bank, is plotting to take full control of the bank -- a charge the authorities deny.

The Supreme Court on Tuesday postponed for two weeks a hearing on the petition of Prof Yunus, who faces removal from Grameen Bank after the central bank relieved him of the post of managing director for holding the position without approval. "It appears the delay is

primarily due to increasing divisions within the Government of Bangladesh regarding Muhammad Yunus and independence of Grameen Bank," says Friends

of Grameen.

Famous Brazilian author Paulo Coelho also expressed his support for Dr Yunus. In an article styled "Ignorance and Greed" on his blog (paulocoelhoblog.com), he said, "The only weapon that we currently have and that the government doesn't, is international awareness and presence in media and people's heads."

Similarly, 26 members of the US Congress last week appealed to the Bangladesh government to ensure independence of Grameen Bank.

In a letter to Prime Minister Sheikh Hasina, the Congressional Bangladesh Caucus said Washington and Dhaka have championed solid ties in areas ranging from economic cooperation to defence.

"Unfortunately the situation with Dr Yunus is beginning to overshadow these concrete gains and introduce uncertainty regarding one of Bangladesh's most visible and beloved institutions," it said, urging the government to resolve the matter through a mutually satisfactory com-

promise. In a gesture of support, Secretary of State Hillary Clinton also telephoned Prof Yunus.

"Friends of Grameen", headed by Mary Robinson, former president of Ireland and former United Nations high commissioner for human rights, is an international platform set up to promote microcredit and social business, in particular, the microcredit activities of Grameen Bank.

# Robert Blake due Saturday

on March 19 on a five-day visit to hold talks with government leaders, opposition politicians and civil society members.

Blake arrives in Dhaka on the second leg of his threenation tour of China, Bangladesh and Kazakhstan, US diplomatic sources in Dhaka told The Daily Star. In Bangladesh, Blake will

hold bilateral meetings with the government and meet civil society leaders and the opposition, according to US Department of State. He will also attend the Regional Security Initiative (RSI) Conference in Dhaka.

Sources said Robert Blake's visit to Bangladesh is crucial in the context of removal of Prof Muhammad Yunus from the post of managing director of Grameen Bank and the US concernabout it.

The United States said it was "troubled" by Yunus' removal and called on the Bangladesh government and Grameen Bank to reach an honourable compromise on this issue.

Diplomatic sources said that the State Department official is expected to meet Prime Minister Sheikh Hasina, Leader of the Opposition Khaleda Zia, Foreign Minister Dipu Moni and other senior government and opposition leaders.

The sources said Prof Yunus's removal will dominate his talks with the political and civil society leaders. He is also likely to meet ProfYunus.

He will reach Beijing on a 2day visit on March 17-18. There he will lead a US government delegation to the US-China Sub-Dialogue on Central Asia. Assistant Secretary Blake will also discuss regional issues with government officials, and will meet with scholars and students.

Blake will be in Kazakhstan on March 24-25, when he will lead the US delegation at the second Annual Bilateral Consultations. Topics will include Afghanistan cooperation, civil society, human rights, and military cooperation. He will meet with students at Nazarbayev University and members of civil society.

The Bureau of South and Central Asian Affairs deals with US foreign policy and US relations with the countries of Afghanistan, Bangladesh, Bhutan, India, Kazakhstan, Kyrgyzstan, Maldives, Nepal, Pakistan, Sri Lanka, Tajikistan, Turkmenistan and Uzbekistan.

minister, cabinet members, parliament members and their families will be made public every year.

But in the first two years of its tenure, the AL government did not implement

this electoral pledge. Rather, the prime minister and a number of ministers on different occasions spoke against submission of wealth statements, saying they had already submitted those to the Election Commission before the last

parliamentary elections. Muhith however has made his wealth statement public, and people appreciated it. But his family members' wealth statements are

yet to be published. The finance minister said on February 14 last year wealth statements of ministers, lawmakers and their relatives would be made public by June 2010.

Following the cabinet committee's decision yesterday, Muhith said all members of the council of ministers, advisers, MPs and mayors will have to mention in their wealth statements about their relatives if they are engaged in any contractual business with the government.

They will prepare their wealth statements on the basis of the statements they had submitted to the EC before the parliamentary elections.

The finance minister said he will also send a letter to the chief justice informing him of the government decision on wealth statements.

His ministry will request the chief justice to take measures for submission of the Supreme Court judges' wealth statements to the Cabinet Division, if they

decide to disclose those. Meanwhile, legal and financial experts said submission of wealth statements will greatly help create transparency in the government's functioning, and people will be able to know how much wealth a

selling rice for Tk 24 a kg under the Open Market Sale (OMS) and other programmes to bear a subsidy of Tk 18 on every kg of rice. Earlier, the purchase

committee had approved procurement of 3.50 lakh tonnes of rice from Vietnam in two phases. Most of the rice has already reached Bangladesh. The food ministry told

the cabinet committee on economic affairs that it wanted to import 2 lakh tonnes of rice in the next two months. The committee gave a waiver of the conditions of public procurement act to import the rice quickly.

The proposal was immediately approved in another meeting of the cabinet committee on rice through OMS and fair

try told the committee that the target of collecting boro rice from the domestic market could not be achieved in the last fiscal year. The government

decided not to procure rice in the aman season due to instability in the domestic market and a rise in rice and wheat prices on the international market. The food stock eventually dwin-

In the current fiscal year, international tenders were floated for purchasing 7.10 lakh tonnes of rice through 21 private importers. But the importers have supplied only 1.33 lakh tonnes of rice till date.


