STALKING

Two youths jailed, another fined

Three youths have been punished for sexually harassing three girls in Jessore and Pabna.

A mobile court on Monday jailed two college students in Jessore for stalking a girl student of Abdur Razzak Municipal College in Sadar upazila, reports our Benapole correspondent.

Of the convicts, Rakibul Islam is son of Mozahar Ali and an HSC student of Jessore Cantonment Public College while Biplob Hossain is son of Jahanagir Hossain and a student of Barobazar College in Jhenidah.

Officer-in-charge Sheikh Emdad Ali of Sadar police station said the two youths came to the Abdur Razzak College premises and sexually harassed a student of the college. Hearing the news, viceprincipal of the college Sultan Ahmed informed a mobile court led by Executive Magistrate Shailendra Nath which rushed to the spot and sentenced Rakibul to four months and Biplob to two months imprisonment.

In Pabna, another mobile court on Tuesday fined a young man Tk 8,000 for sexually harassing a female SSC examinee.

The stalker was identified as Ratan Hossain, 25, son of Zakir Hossain at Kushiara

Candidates urge EC to ensure fair UP election

Candidates at a view exchange meeting in Barisal city on Tuesday expressed doubt about fairness and transparency of the upcoming union parishad election as, what they said, the recently held municipality polls turned political.

Organised by the district unit of Sushasaner Jonno Nagorik (Sujan), 18 UP chairman aspirants, representatives from different socio-cultural and professional bodies, human rights and election monitoring organisations attended the meeting at the auditorium of Barisal NGO Development Network in the afternoon.

Sujan, Rabeya Khatun, Mohiuddin Manik, Nazrul Islam Chunnu, Ranjit Dutta, Abul Kalam and Nurjahan Begum exchanged views with the UP election candidates at the meeting with Sujan Barisal city unit Vice-President Akkas Hossain in the chair.

Mosharraf Hossain Sharif, a chairman candidate, said, "The Election Commission and the authorities concerned failed not only to stop use of black money and muscle power in the election, but also to make the local government non-political."

Seven other candidates--Hafizuddin Khan, Faruk Hossain, Jewel Talukdar, Nazrul Islam, Ali Shikdar, Abdullah Al Mamun and Ferdous-ur-Rahman-- also made the same allegation.

They urged the Election

Badiul Alam Majumdar, Commission to create an central general secretary of atmosphere conducive to free, fair and transparent UF election.

> Other participants demanded more autonomy for union parishads to strengthen and develop democratic national government system.

> They urged the voters to elect honest and competent candidates for socioeconomic development at grassroots level

The first phase of the UP elections will be held between March 29 and April 3 at 596 UPs in 12 districts of the coastal belt. Time for withdrawing nominations is between March 13 and March 18.

Elections to other union parishads will be held from the third week of May to June. Polls in 205 out of total 4,505 unions across the country will not be held due to disputes over their boundaries.

3 JMB men jailed for Narail serial blast

Three militants belonging to Islamist outfit Jamaat-e-Mujahideen Bangladesh (JMB) were sentenced to jail yesterday in the case for serial bomb blast on August 17 in 2005 at four spots of Narail town. Md. Sikandar Ali, Judge of

the Speedy Trial Tribunal, Khulna delivered the judgment in the afternoon.

According to court sources, JMB militant Saifuzzaman Probal was sentenced to life imprisonment and fined Tk 20,000, in

default, to suffer three more years in jail.

The court also convicted JMB militants Ruhul Quddus and Hafez Mahmud alias Rakib Hasan and sentenced each of them to 14 years RI each and fined Tk 10,000 each, in default, to suffer more two years in jail.

Four other accused acquitted of charges are Ziaur Rahman, Abdul Aziz Shikder, Syed Arafat and Mamun Gazi.

SI Jahangir Alam of Narail Sadar police station filed the case as complainant on August 18 in 2005 naming seven people as accused of exploding bombs one after another on the previous day at four different spots of the

OC Md Ishaque Dukhu Mia of Narail Sadar police station investigated the case and submitted the charge sheet to court on November 9 in 2006.

The case was, however, transferred to Khulna Speedy Trial Tribunal on September 26 last year.

Criminals shot dead a businessman at Damodar village in Fultola upazila Tuesday

The deceased was identi-

fied as Zinnah Bhuiyan, 52, owner of a cosmetics shop and son of Jafar Bhuiyan of the village. Police said Zinnah and

his son were returning home from the shop at the upazila headquarters by an autorickshaw at about 10:00pm.

When they reached near their house, a gang of criminals intercepted their autorickshaw and shot him, leaving him critically injured.

The criminals, however, left the scene by the autorickshaw.

Zinnah was rushed to the upazila health complex first and later shifted to Khulna Medical Collage and Hospital where he died after an hour.

Four BCL, 3 Shibir

Motihar police on Tuesday night arrested four Chhatra League (BCL) and three Shibir activists from Rajshahi University (RU) areas on separate charges.

The arrested BCL activists include Manzurul Alam, a third year student, Sahabuddin Al Faruq and Muhammad Hanif, both fourth year students of Political Science department and Monzurul Kawsar, a first year student of Social Work department of Rajshahi College.

They were arrested from Kazla area near the university at around 9:30pm upon a complaint by Mehedi Hasan, a first year student of Language department, of and Tk 1,000 from him, police said.

Meanwhile, police arrested the three Shibir activists -- Rezaul Karim Raju, a fourth year student of Arabic department and a resident of a Shibir controlled dormitory, Anamul Haque and Shafikul Islam -in connection with February 9, 2010 violence that left BCL worker Fareque Hossain killed and at least 100 BCL activists injured.

Kishoreganj and killed man in Noakhali on Monday and the day before while villagers caught four of a gang in Pabna on Tuesday.

Robbers looted cash, gold ornaments and other valuables from a house at Khilpara village in Sadar upazila of Kishoreganj on Monday, reports our correspondent.

Neighbours said a gang of robbers numbering 10-12 swooped on the house of Nurul Huda of the village at around 3:00 am breaking open the window grills.

They looted cash Tk 5 lakh, 10 tolas of gold ornaments, mobile phone sets and other valuables keeping the house members hostage at gunpoint.

Nurul Huda's younger brother's wife Sabita Akhter,30, was injured by robbers as she tried to raise a hue and cry.

In Noakhali, an alleged robber killed one person at village Uttar Ramnarayanpur of Mohammadpur union under Chatkhil upazila on Sunday night, reports our correspondent.

The victim was identified as Mohammad Hasan,28, son of late Salamat Ullah of village Sreerampur of Khilpara union of the same upazila.

Nazmul Haque, officer-incharge of Chatkhil police station quoting eye witnesses said Hasan was taking tea at a tea stall at Uttar Ramnarayanpur village around 11:00pm. All of a sudden, a gang of 4 wearing mask came there by two motorbikes and opened fire on Hasan, killinghim on the spot.

According to police, killer Hasan is a robber and accused in at least 10 cases

of robbery and murder.

Away in Pabna, four rob-Robbers looted a house in bers were caught while fleeing after committing a robbery in Boya area of Santhia upazila early Tuesday, reports our correspondent.

> The arrestees were identified as Hosen Ali, 19, son of Shahadat Molla, Jomin alias Jamil, 28, son of Baten of Shalika village, Bikash Goswami, 20, son of Gurupad Goswami of Bongram village in Bera upazila and Abdus Salam, 35, son of Osman Sikder of Tolot village in Santhia upazila.

> They were trying to decamp after looting cash money and a mobile phone set from fish trader Abdus Salam of nearby Boya Khorbagan area in the upazila.

> Hearing Salam's cry for help, locals chased the gang and caught four of them redhanded while others managed to flee.

> Angry villagers after a mass beating handed them over to police. Police said the arrestees were wanted in several cases of robbery in Bera and Santhia areas.
