## Tougher criteria set in students' visa for UK

The United Kingdom (UK) announced an overhaul in students' visa system, with tougher entry criteria and limited work entitlements, making it difficult for average grade Bangladeshi students to study and work there.

Changes will protect the interests of meritorious

Bangladeshi students wishing to study in Britain, but are bad news for those who tried to abuse the student visa route, said the UK Border Agency Regional Director Chris Dix. At the UK parliament on Tuesday, British Home Secretary

Theresa May announced results of a consultation beginning last December on student immigration system reform, says a press statement of British High Commission in Dhaka. "This overhaul will ultimately reduce the number of

Bangladeshi students in the UK," said an official of the high commission. Last year, around 9,000 Bangladeshi students entered Britain, where around five lakh Bangladeshis are settled, the

official added. Those wishing to study at degree level in the UK will have to speak English at an "upper intermediate level" as per requirement of Common European Framework of Reference. This is an increase from the current level of requirement, the statement said.

### NGOs to obtain climate | Charges cash after final review

All the 53 non-government organisations that were entitled "in principle" to receive cash from the government's Climate Change Trust Fund will be reviewed before the final allocation, as allegations have surfaced about their ability to implement climate projects.

"We are going to review their proposals and also their capability of implementing the projects before disbursement of the fund," said State Minister for Environment and Forests Dr Hasan Mahmud after a meeting of Climate Change Trustee Board yesterday.

His remarks followed a report published in a Bangla daily about selection of incapable and inexperienced NGOs to accomplish the small projects in different climate-hit areas to reduce the adverse impacts.

The minister, however, tried to defend the work of officials concerned, saying, "the technical committee just selected those organisations in principle." They were still conducting their review about the project and the organisations, he added.

"It was not the final selection. They would not get any

# SC adjourns govt's review petition hearing till Mar 28

The Supreme Court yesterday adjourned till March 28 the hearing on the government's petition to review its judgment on the fifth amendment to the constitution.

The government on March 14 filed the review petition with the SC against some of its observations regarding transitional and temporary provisions in the judgment. Five-member bench of the Appellate Division headed by Justice Md Muzammel Hossain yesterday passed the

adjournment order after hearing a short submission from Attorney General Mahbubey Alam. The attorney general told the apex court that this court should expunge its observations in its verdict, which con-

done provisions regarding transitional and temporary provi-

sions in Article 150 of the constitution. He also prayed to the Appellate Division for upholding its HC Division observations, which did not condone those

#### 150 more law enforcers fall sick

A mobile court also awarded imprisonment for different tenures to a son of the hotel owner and the cook of the hotel for unhygienic environment.

Most of the sick personnel were admitted to Rajarbagh Police Lines Hospital while the rest at Dhaka Medical College Hospital, Combined Military Hospital and Galaxy Hospital as they were vomiting and suffering from dehydration.

# Add provision to constitution for strong local govt

Says Prof Muzaffer

Noted academician Prof Muzaffer Ahmad yesterday urged the government to include necessary provision in the constitution for strengthening the local government.

Power concentration will hinder the progress of democracy, so it should be decentralised through strengthening the local government institutions for good governance, he

He was presiding over a roundtable on local government organised by Bangladesh Upazila Vice-chairman Samannoy Parishad at Dhaka Reporters' Unity (DRU) yesterday.

Muzaffer, also president of Sushashoner Jannoy Nagorik (Shujan), stressed the need for specific explanation on budgetary allocation for the development of local government.

He said it is easier to solve most of the civic problems that turn difficult for the central government, as the local government representatives stay close to mass people.

Shujan secretary Badiul Alam Majumder said the government has curbed power of local government representatives by making the lawmakers adviser to the upazila parishad.

He also emphasised the need for launching movement at grassroots level to press the demands for strengthening the local government.

Jatiya Samajtantrik Dal (JSD-Rob) president ASM Abdur Rob strongly criticised the government. "They are establishing partisan ruling system, rather than democracy."

He also talked on Nobel laureate Dr Muhammad Yunus. "The government has belittled the country by besmirching DrYunus's image because he is the model the nation."

At the function, some upazila vice chairmen demanded repealing of the rules that have narrowed the jurisdictions of

local government and made the institutions inactive. Local government expert Dr Tofail Ahmed and represen-

## Grameen Bank official mysteriously burnt to death

An official of Grameen Bank mysteriously burned to death at Sonakura C&B Bazar area under Shibpur upazila of Narsingdi on Tuesday night.

The deceased Nazmul Mia, 35, son of Ramjan Ali, hailing from Madhabdi village under the upazila, was the senior manager of Grameen Bank Noadia branch under Monohordi upazila.

Nazmul's wife said they went to sleep around 11:30pm and she woke up hearing cries of locals around midnight. She followed the cries to an abandoned place 100 metres from the house and found the burnt body.

On information, police rushed to the spot and sent the body to hospital morgue for autopsy.

Officer-in-Charge Mojibur Rahman of Shibpur Model Police station said they recovered a mobile set, a match and a fuel can from the spot. They would be certain of the cause behind the death after autopsy, he added.
