It has announced that fresh water rather than seawater will now be used to cool the damaged reactors, in the hope that this will be more effective.

Prime Minister Naoto Kan said the situation was "very unpredictable".

The official death toll from the 11 March earthquake and tsunami has passed 10,000, and more than 17,440 people are missing.

Hundreds of thousands of people have been made homeless; an estimated 250,000 people are living in emergency shelters. Food, water and fuel are in short supply.

The Japanese government has put the rebuilding cost at \$309bn.

SAFETY MEASURES

The levels of radiation found in the sea near the plant were more than eight times higher than those found in the same area last week, the Japanese officials said.

A spokesman for Japan's Nuclear Safety Agency said the radioactivity level in the sea off the nuclear plant was

"relatively high" but the impact on marine life would be minor.

"Generally speaking," spokesman Hidehiko Nishiyama told a news conference, "radioactive material released into the sea will spread due to tides, so you need much more for seaweed and sea life to absorb it."

He continued: "And, since [the iodine] has a halflife of eight days, by the time people eat the sea products its amount is likely to have diminished significantly."

The contamination probably came from both airborne radiation released from the reactors or tainted water that spilled into the sea, Mr Nishiyama said.

In a televised address on Friday, Prime Minister Kan said: "The current situation is still very unpredictable. We're working to stop the situation from worsening. We need to continue to be extremely vigilant."

He also thanked the workers, firefighters and Self-

Daiichi plant.

Japan's chief cabinet secretary Yukio Edano has said a rigorous inquiry is under way to establish the cause of a leak at the plant, after tests showed water in the turbine halls of reactors 1 and 3 had radiation levels 10,000 times higher than normal.

Japan's Nuclear Safety Agency has reiterated its position that it believes the reactor may have been damaged but it is going no further than that, says the BBC's Mark Worthington in Tokyo.

The agency has denied any suggestion that the reactor core may have cracked, Kyodo news agency reports.

The two affected workers, who remain in hospital, had reportedly not been wearing the correct protective boots and had ignored a radiation alarm at the plant.

A revision of safety measures has been ordered.

The government has asked people still living reactors at the Fukushima voluntarily. Until now, resi-

dents in the zone had been advised to stay indoors. **FOOD FEARS**

Japan has banned shipments of foodstuffs grown in several prefectures around

the damaged nuclear plant. People in Fukushima prefecture have been told not to eat 11 types of green leafy vegetables because of contamination worries.

Importers of Japanese products are finding low levels of radiation in some food stuffs, however the amounts found do not pose a health hazard. China, Singapore, Hong

Kong, and other Asian importers have already placed bans on some imports of vegetables, seafood and milk products.

Australia, the European Union, the United States and Russia have followed suit. The Fukushima plant is

"The civil surgeon's negligence in preparing the autopsy report has been proved which is against medical ethics," the report

"The civil surgeon in a most unlikely move formed a committee for the autopsy at his own initiative realising the importance of the matter. Besides, being the ex officio of Shariatpur General Hospital the civil surgeon was not aware of Hena's admission and treatment at the facility," read the report.

It also said had not the second autopsy been done, the cause of the death have remained unknown.

Meanwhile, the Shariatpur Superintendent of Police (SP) has prepared another report recommending departmental actions against two officials of Naria Police Station, Mirza Abul Kalam and Muhammad Aslam Uddin Mollah.

While preparing the autopsy report, Sub-Inspector Aslam Uddin mentioned some irrelevant issues and could not examine the body properly. Moreover, Inspector (investigation) Mirza Abul Kalam Azad did not refer to the incident of rape while lodging the case even after intensive interrogation of Hena

The Shariatpur SP also submitted his report before the HC on Thursday.

The first post-mortem done by the doctors of Shariatpur General Hospital on February 2 made no mention of injury marks on Hena's body. The doctors assigned for the postmortem were the hospital's Resident Medical Officer Nirmal Chandra Das, and medical officers Rajesh Majumder and Hosne Ara Begum.

However, the DMCH autopsy on February 8 said that the reason behind the death was haemorrhage followed by septicaemic shock as a result of wound from blunt object and were ante-mortem and homicide in nature.

The DMCH doctors who performed the autopsy are Zubaidur Rahman, assistant professor of forensic medicine, Firoza Wazed, assistant professor of gynaecology, and Najibur Rahman, assistant professor of pathology.
