1. The People's Republic of Bangladesh has received a Loan from the Export-Import Bank of Korea from the resources of the Economic Development Cooperation Fund (EDCF) of the Republic of Korea toward the cost of Bibiyana-Kaliakoir 400kV & Fenchuganj-Bibiyana 230kV Transmission Line Project and intends to apply a portion of the proceeds of this loan to payments under the contract for Design, Supply, Erection, Testing and Commissioning of Bibiyana-Kaliakoir 400kV Transmission Line on Turnkey Basis.

2. The Project Executing Agency, PGCB now invites sealed bids from eligible bidders for Design, Supply, Erection, Testing and Commissioning of Bibiyana-Kaliakoir 400kV Transmission Line on Turnkey Basis as defined in the bidding document (hereinafter referred to as "the Works"). The Works include:

- 400kV double-circuit three-phase transmission line on vertical formation double circuit lattice steel towers with 2 Bundle ACSR (Finch) phase conductor and one ACSR (Dorking) earthwire and one equivalent OPGW from Bibiyana substation to 400/230/132kV Kaliakoir substation. (approximately 170 kms length).

Details of the scope of work are specified in the bidding document.

3. Bidding will be conducted through Competitive Bidding (CB) procedures, single stage and two envelop specified in the Guideline for Procurement under EDCF Loans, and is open to all eligible bidders that meet the following minimum qualification criteria.

- This Invitation for Bids is open to only bidders from the Republic of Korea as defined in the Loan Agreement. A Bidder shall be deemed to have the nationality of the Republic of Korea if the Bidder is a national or is constituted, incorporated, or registered and operates in conformity with the provisions of the laws of that country.

- Bidders (All Partners Combined in case of Joint Venture) must have successfully completed, at least two (2) comparable contracts (Engineering, Management, Foundation, Erection and Testing & Commissioning of minimum 20km Route lengths 345kV or higher voltage double circuit transmission line in each contract) and at least two (2) project comparable contracts (Design, Supply, Foundation, Erection and Testing & Commissioning of 345kV or higher voltage double circuit transmission line 3km route length in each contract on turnkey basis) as a contractor within the last fifteen (15) years as on the date of opening of technical proposals. However, Partner in charge in case of Joint Venture must have required at least one (01) comparable contract in the above required two (2) turnkey projects

- Bidders must also have project management experience (experience of partner in charge in case of Joint Venture) to demonstrate their management capability in at least one turnkey project (contract amount should not be less than US\$ 30.0 million) outside their own country within the last ten (10) years as on the date of opening of technical proposals.

- Each Partner of the Joint Venture other than the partner in charge must have successfully completed at least one Contract (Engineering, Management, Foundation, Erection and Testing & Commissioning or supply of minimum 20 km 220kV or higher voltage double circuit transmission line) as contractor or subcontractor within the last ten (10) years as on the date of opening of technical proposals.

- Bidders shall provide Audited Financial statements or other forms of Financial Statements such as Balance Sheets/Financial Statements certified by a registered accountant and supported by copies of tax returns for the last two years as documentary evidence regarding Liquid Assets and Annual Turnover with their Bids. The minimum average Liquid Assets & Annual Turnover for the Bidder's organization or Joint Venture shall not be less than the following:

- (i) Liquid Assets: US\$ 10.0 million (Last year)
- 7) Annual Turnover: US\$ 45.0 million (Avg. of last two years)

The partner in charge in case of Joint Venture shall meet not less than 50% and each partner of the Joint Venture shall meet not less than 25% of the minimum criteria given above item 3. (i) & (ii).

4. The Works under this turnkey contract shall be completed within thirty (30) months from the effective date.

5. Bidders may obtain further information and acquire the bidding documents at the Power Grid Company of Bangladesh Ltd. (PGCB), the Institute of Engineers Bangladesh Bhaban (3rd Floor), IEB Ramna, Dhaka-1000, Bangladesh from 10:00 to 16:00.

6. A complete set of bidding documents may be purchased by interested eligible bidders on submission of a written application to the Company Secretary, PGCB at the above address and upon payment of a nonrefundable fee of USD 400.00 (United States Dollar four hundred only) or Tk. 28,000.00 (Taka twenty eight thousand only) in the form of Pay Order/Demand Draft in favor of the Power Grid Company of Bangladesh Ltd. The Bidding Document may be sent through a courier for an additional fee of BD Tk. 500.00 (local delivery) or US\$ 100.00 (International delivery) in the form of Pay Order/Demand Draft in favor of Power Grid Company of Bangladesh Ltd. shall not be responsible for any postal delay.

7. Bidders are to submit simultaneously two sealed envelopes, one containing the technical bid and another containing the price bid. Initially only the technical bids will be opened. The price bids will remain un-opened and will be kept in the custody of the Employer until the time of opening of the price bids.

8. All bids must be accompanied by a Bid Security of US\$ 1,000,000 (United States Dollar one million only) or an equivalent amount in a freely convertible currency and must be delivered to the Company Secretary, Power Grid Company of Bangladesh Ltd., the Institute of Engineers Bangladesh (IEB) Bhaban (4th Floor), IEB Ramna, Dhaka-1000 at or before 11:00 am Bangladesh Standard Time on May 11, 2011. The bid security must be included with the technical bid.

9. The technical bids will be opened at or before 11:05 am Bangladesh Standard Time on May 11, 2011 immediately thereafter in the presence of bidders' representatives who choose to attend.

10. The price bids will be opened in the presence of the bidder's representatives who choose to attend at the time and date and at the address to be advised by the Employer after approval of the EDCF of the evaluation of the technical bids.

11. PGCB will not be responsible for any costs or expenses incurred by bidders in connection with the preparation or delivery of bids including costs and expenses related to visits to the sites of installation of the Works.

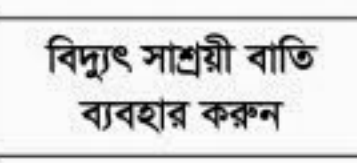

Having been authorized by the Government of the People's Republic of Bangladesh ("GOB"), Bangladesh Power Development Board ("BPDB") intends to select a potential sponsor (the "Project Sponsor") to develop a 50MW HFO Fired Power Plant at Bhairab near to 33/11kv Bhairab BPDB Substation, Bhairab (the "Project") on a site that will be arranged and owned by Project Sponsor. The project will be implemented on Build, Own and Operate ("BOO") basis for a period of 15 years under Quick Supply of Power and Energy Enhancement (Special Act) Law, 2010 (বিন্দুৎ ও জ্বালানির দ্রুত সরবরাহ বৃদ্ধি (বিশেষ বিধান) আইন, ২০১০).

The Project Sponsor will be selected through an international competitive bidding process from their (i) Qualification Statement & Technical, Commercial and Financial Proposal and (ii) Tariff Proposal submitted against the Qualification Document and Request for Proposal (Technical, Commercial and Financial requirement) and Request for Proposal (Tariff Proposal requirement) respectively. The selected Project Sponsor will be required to arrange the necessary financing and to execute the key project documents for the project.

BPDB seeks to qualify interested power project developers who have previous international (for local bidders local experience will be accepted) experience in implementing power generation projects, and invites interested developers to submit (i) Qualification Statement & Technical, Commercial and Financial Proposal and (ii) Tariff Proposal in accordance with the criteria set forth in the Qualification Document and Request for Proposal respectively. The Qualification Document and Request for Proposal will be available from March 21, 2011 at the BPDB website: <http://www.bpdb.gov.bd>. Interested developers intending to submit a (i) Qualification Statement & Technical, Commercial and Financial Proposal and (ii) Tariff Proposal to BPDB should check BPDB's website on a regular basis to ensure that they are familiar with any amendments or modifications to the Qualification Document and Request for Proposal, which amendments or modifications shall be binding on the bidders and their (i) Qualification Statement & Technical, Commercial and Financial Proposal and (ii) Tariff Proposal if such amendments or modifications are posted on BPDB's website not later than 72 hours prior to the bid date.

Bidders should submit to BPDB their (i) Qualification Statement & Technical, Commercial and Financial Proposal and (ii) Tariff Proposal, together with a non-refundable processing fee of US\$ 3,000 (or Bangladesh Taka 2,10,000) in the form of an international Bank Draft encashable at any scheduled bank in Bangladesh or in the form of a local Bank Draft/Pay Order, made payable to "Secretary, Bangladesh Power Development Board". The bidder shall also provide the bid security in the form of an irrevocable and unconditional bank guarantee in the format and language as provided in Annex D, Exhibit I, Attachment 1-2 (entitled "Form of Bid Security") of the Request for Proposal payable to BPDB upon presentation to a bank in Bangladesh at the rate of US\$ 10,000 per MW of the offered capacity. The bid security will be returned to the bidders not meeting the criteria as mentioned in the qualification document.

The pre-bid meeting is scheduled to be held in BPDB Board Room, WAPDA Building (1st floor), at 10:00am Dhaka on April 05, 2011. The deadline for submission of the bid is scheduled on May 04, 2011 (the "bid date"). Any requests for additional information and/or questions concerning Qualification Document and Request for Proposal shall be submitted in the following address in writing not later than 20 (twenty) days before the bid date.
