## Fire destroys betel on 200 Office assistant beats up students at school! acres in 5 Kushtia villages

Fire incidents destroyed betel on around 200 acres (nearly 600 bighas in local measure) of land in several remote villages of Daulatpur and Bheramara upazilas under Kushtia district on Thursday and Friday.

The incidents that also destroyed ripe wheat on large areas at the same locations caused damage to around Tk 17 crore belonging to over about 100 farmers.

The causes of the near simultaneous fire incidents are yet to be ascertained but the possibility of planned act to destroy the betel plantations cannot be ruled out, especially against the backdrop of recent torching of a number of betel plantations in Jhenidah and Barisal districts.

Bheramara upazila rushed to the spots on Thursday and Friday but the fire across large areas was too widespread to be tamed with their limited equipment,

A large number of locals along with the betel farmers also thronged the spots but they stood helpless before the blazing inferno, said villagers.

"Setting fire to burn off waste at corn fields is a usual practice of farmers," he said. Most of these betel leaf

farmers are marginal and some of them took loan from local branches of Krishi Bank and other sources to cultivate betel. Marginal farmers Hanif

Mondol, Mizan Ali and Nadim Islam said they are worried about repaying their loan and maintaining families after losing betel leaf on five bighas of land at Juniadah.

A number of farmers also took lease the land from others paying advanced money. They also incur a huge loss.

"I took lease of three biaghs land with an advanced payment Tk 18,000. I incur a total loss," said Kabir Hossain of Kuchiamora.

## Bomb injured Meherpur Theft of govt drugs councillor dies sparks protest councillor dies

in Bheramara upazila of Kushtia district.

Councillor of Meherpur municipality Mizanur Rahman Ripon who was severely injured in a bomb attack a week ago, died at a hospital in Dhaka on Friday night.

Another councillor Abdullah Bin Hashem and three others injured in the same incident in Meherpur town on April1, are still fighting for life.

Ripon was also general secretary of Meherpur municipality unit Jubo League.

Doctors and family sources said Ripon died at the intensive care unit of Apollo Hospitals in Dhaka at about 11:00 pm.

According to police, Ripon and Hashem were at Rajdhani Store, a cosmetics shop owned by Ripon at around 9:30pm when four people came there on two motorbikes and threw two bombs at them.

Besides the councillors, three employees of the shop-

- Nurul Islam, Nayan and Milon--also sustained injuries in the attack.

The injured were taken to Meherpur General Hospital where doctors sent Ripon and Nayan to Dhaka Medical College and Hospital (DMCH) as their condition deteriorated.

After two days of treat-

ment, they were shifted to Apollo Hospitals in Dhaka.

Nayan is still at the Apollo Hospitals, while councillor Hashem, Nurul and Milon are being treated at different hospitals.

Meanwhile, police are yet to find any clue to the bomb attack.

A case was filed with Meherpur Sadar police station on April 2. Abdul Halim, father of Councillor Mizanur Rahman Ripon filed the case.

The accused in the case are president of Meherpur

district Awami League (AL) Golam Rasul, general secretary Kazi Miajan Ali, the incumbent mayor of the municipality Mutasim Billah Motu and general secretary of district unit Jubo League

Police on Thursday arrested a woman with government allocated medicines for Hatibandha upazila health complex from Dowani in Hatibandha upazila.

Medicines including tablets, capsules and syrups worth about Tk 20 thousand were also seized from the possession of the arrestee, Benazir Begum, 26, wife of Delowar Hossain, a resident of South Goddimari village of Hatibandha upazila in the district.

Meanwhile, locals brought out a procession at Hatibandha yesterday demanding probe into the theft and punishment to the 'real' culprits.

On-duty police at Dalia Barrage caught the woman with the medicines when she was going to Dimla upazila of Nilphamari district for selling it, police said, adding that the woman said during interrogation that she took the items from her relative Sirazul Islam, storekeeper of Hatibandha upazila health complex.

Referring to the arrestee, police said she and two other women had been conducting the illegal business for the last two years. Two-thirds of the money from illegal selling of the medicines goes to the storekeeper while the seller gets the rest, they added.

Denying the allegation, storekeeper Sirazul Islam said, "I don't know the woman and I never take a single medicine from the store for selling in the market."

Hatibandha police station officer in charge Enamul Karim said a case was lodged against the arrested woman and police is investigating the matter on the basis of her statement.

When contacted Hatibandha Upazila Health and Family Planning Officer Dr Bimol Kumar Roy said, "Police has informed me of the matter. My office will conduct an inquiry and take action if any hospital staff is found guilty."

#### Three kids drown
