

# United States averts govt shutdown

A last-gasp deal slashing spending prevented a US government shutdown set for Saturday, ending -- at least for now -- a rancorous budget row between President Barack Obama and his newly empowered Republican foes.

Party leaders clinched the agreement, including some \$38.5 billion of extra spending cuts, after intense bargaining, barely an hour before the federal government effectively ran out of money at midnight Friday.

The showdown was just the first bruising engagement in a string of likely clashes between Obama's Democrats and the Republicans, boosted by a new crop of conservative Tea Party movement lawmakers, as the president fires up his 2012 re-election bid.

Obama boasted that cooperation born of



difficult compromises had yielded "the biggest annual spending cut in history" at a time when Washington faced a projected annual shortfall of \$1.65 trillion.

"Some of the cuts we agreed to will be painful. Programs people rely on will be cut back. Needed infrastructure projects will be delayed," the president said.

House Speaker John Boehner told his restive Republican caucus behind closed doors he had sealed an agreement with the White House to fund the government for the rest of the fiscal year ending September 30.

Lawmakers in both chambers raced to approve a stopgap funding measure before midnight to give negotiators until Thursday to finalize the overall deal.

The Senate passed it by voice vote, the House by a 348-70 margin at 12:39am local time Saturday.

## Two killed in Philippines plane crash

A small chartered plane crashed into a northern Philippine mountain park and burst into flames yesterday, killing two people on board, police said.

Four other people on board were injured and taken to hospital after the aircraft slammed into a forest track at the Camp John Hay resort that is used for pony rides, regional police commander Superintendent Leon Talleo told reporters.

He said the plane had just taken off from the nearby Baguio airport. The aircraft model involved was not immediately known.

Witnesses said tourists were the first to the scene.

Baguio city fire department sent firetrucks to put out the blaze, fire officer Jay Guiniaon told AFP.

## WIKILEAKS Israel ruled out Iran strike in 2005

Israeli defence officials ruled out a strike on Iran's nuclear facilities as early as 2005, US diplomatic cables leaked to whistleblower site WikiLeaks show, an Israeli newspaper said yesterday.

The documents given to the Haaretz newspaper by WikiLeaks detail conversations between US diplomats and Israeli defence officials, which suggested the Jewish state did not plan to target Iran's controversial nuclear programme.

One December 2005 cable said Israeli officials had indicated there was "no chance of a military attack being carried out on Iran," Haaretz reported.

Another telegram a month later, detailing talks between a US congressman and the then deputy chief of Israel's Atomic Energy Commission, offered a stronger suggestion that Israel considered a strike on Iran's facilities unfeasible.

## Unemployed Saudis protest to demand jobs

Dozens of unemployed university graduates and teachers staged rare protests in two Saudi cities yesterday to demand jobs and better wages in the biggest Arab economy, which is struggling to reduce joblessness.

Saudi Arabia, the world No. 1 oil exporter and a US ally, is an absolute monarchy that does not tolerate public dissent.

Over 20 protesters gathered outside the education ministry office in Jeddah while around 20 collected outside the ministry in the capital Riyadh, witnesses and participants said.

Despite its oil wealth, Saudi Arabia is struggling to reduce unemployment which reached 10 percent in 2010.

(confession of guilt) at a local mosque and forbade them to follow Lalon.

The incident happened on April 5.

The accused are Yunus Quari of Para Belgachi, Karim Bazari, Jinder Sheikh, Joyinal Sheikh, Abdul Malek Matubber, Riaz Shikder, Insan Faraji, Nazrul Kari, Mukter Sheikh, Fela who is also known as Felu Quari, Mosharraf Molla, Nuru Kha and Shahidul Kha.

"All those are ignorant of Islam. We've made them Muslim through the rite of tawba. We've taken their undertakings," said Felu Quari, justifying their act.

Munshi Mofazzel Hossain, officer-in-charge of Pangsha Police Station, termed the incident hei-

nous.

Meanwhile, hundreds of Lalon devotees of Pangsha and other areas demonstrated at Pangsha tempo stand demanding immediate arrest and punishment of the culprits yesterday.

Protesting the incident, cultural activists of Rajbari formed a human chain in front of Rajbari Press Club around 10:00am and handed a memorandum to Deputy Commissioner Syeda Sahana Bari.

Talking to The Daily Star, Mohammad Fakir said Musa Molla, a local arbitrator, and Felu Quari, an Imam of a mosque, were threatening him and his family members terming them Hindu for the last few months.

According to the case statement, at least 50 people

led by Yunus Quari of Habashpur entered Mohammad Fakir's house when the devotees were performing Lalon songs. The attackers vandalised the microphone and other musical instruments, and ordered the devotees to stop the programme.

Later, they took the 28 devotees to a nearby mosque.

Following an arbitration on the same day, the imam announced their decision to cut off the hair and moustaches of the devotees in a mass gathering, said Mohammad Fakir as he showed his lost hair and moustaches.

Police initially recorded a general diary which was transformed into a case yesterday.

interpretation of the policy only for political gains," said Al-Maruf.

Amini, in his booklet, termed anti-Islamic the policy's section-23.5 that talks about women's equal opportunity and participation in employment, wealth, market and business.

So is section 25.2, which seeks to give women full control over the wealth they accumulate through earning, inheritance, loans and market management, according to Amini.

The scholars, however, disagree with Amini.

"Any literate person will understand that the word 'wealth' in section-23.5 does not mean inherited wealth. Similarly, the word 'inherit' in section 25.2 does not imply equal share of property to women," said Maulana Mohammad Ziaul Hasan.

Besides, the women development policy is not a law, rather a guideline upholding the constitution and the existing law, said the scholars.

Al-Maruf said Amini deliberately twisted the meanings of words in the Quran. For instance, according to the authentic book of tafsir [interpretation of the Holy Quran] the Arabic word "qauwamun" actually means "guardian", who is to perform managerial job for the family. Thus a husband is usually in-charge of sustenance of his family. But Amini used the word as administrator, ruler and controller.

In his booklet, Amini said the husband is the ruler or controller of other family members, including his wife.

Al-Maruf referred to surah Ali Imran, verse 195 from the holy Quran that says: "Never will I allow to be lost the work of [any] worker among you, whether male or female; you are of one another."

The verse gives no scope for discriminating women. The Quran contains so many verses, which indicate that responsibilities and liabilities are reciprocal and obligatory to every individual, male or

female, he said.

Amini also misinterpreted the meaning of the phrase "eliminate discrimination between men and women" in the women policy.

"Here the phrase does not refer to inherited wealth. It rather means elimination of discriminations in wages and opportunities, and ensuring rights of women," said Misbahur Rahman, chairman of a faction of Islami Oikya Jote.

On Amini's claim that Allah has created women weak and relieved them of the responsibilities of all their family members including themselves, Islamic scholars said Amini made the remark either out of ignorance or to hide Islam's true essence.

Ruling out the claim, Al-Maruf mentioned verse 28 of surah An-Nisa that says, "I [Allah] have created human weak."

"Surah An-Nisa, verse 32 says, 'For men is a share of what they have earned, and for women is a share of what they have earned'," he said, explaining that the Creator has given equal rights to both men and women in earnings and expenses, which Amini and his associates missed out.

Amini has censured the women policy for suggesting inclusion of a child's mother's name along with father's name in any documentation and said, "This would encourage free sex and illegal child birth."

In reply, Al-Maruf said on the Judgement Day, Allah will call every human being after their mother's name. So what Amini fears is absolutely baseless.

Maulana Ziaul Hasan alleged that Amini has been protesting the policy to serve the purposes of a fundamentalist country.

Misbahur said Amini and his supporters are misinterpreting the Quran because they do not have proper knowledge of the holy book.

He said during the time of Prophet Hazrat Mohammad (SM), women made bags and

men sold them in market. Hazrat Khadiza was one of the biggest businesspersons in her time. She had 11,000 men including the Prophet working for her. She gave them capital and the men gave her a share of their profit in return.

Moreover, Hazrat Ayesha led the "battle of camel" where one lakh followers fought under her leadership,

said Misbahur Rahman.

He said Amini's claim that women don't have any responsibility in the family or economy is wrong.

Prof Abdul Mabud said Islam has given women the rights of economic activities. He called upon the government to sit with Islamic scholars to end confusion over the policy.

Prof Rais Uddin said

except for the right to inherit property, Islam has given more rights and honour to women than men.

Asked about Amini's claim that Islam has portrayed women as weak subordinates, Rais Uddin said in the Quran Allah has said, "Wife is like an ornament for husband. Likewise, husband is an ornament for wife."

## Blast kills Afghan tribal elders

AFP, Herat

A Taliban-style bomb attack blew up a vehicle, killing three Afghan tribal elders in the west of the country yesterday, police said.

The group were attacked in the western province of Farah, a troubled region packed with Taliban-linked insurgents and bandits waging a guerrilla war against the US-backed administration in Kabul.

"An IED (improvised explosive device) blast in Bala Buluk district of Farah province killed three and injured two civilians," said Abdul Rauf Ahmadi, police spokesman for western Afghanistan.

Provincial government spokesman Naqibullah Farahi told AFP that the victims were "local elders en route to Farah city from the district."

President Hamid Karzai strongly condemned the bombing and described the attackers as "the enemies of Afghanistan" a term Afghan officials use to refer to Taliban and other insurgents.

Afghanistan is in the grip of an increasingly deadly insurgency now into a 10th year. Led by Taliban leaders who were in power between 1996 and 2001, the insurgency is fighting to bring down Karzai.
