Rangpur court summons Inu

A Rangpur court yesterday summoned Jatiya Samajtantrik Dal (JSD) President Hasanul Haque Inu to appear before it by July 24 in a case filed against his derogatory remarks about late president Ziaur Rahman.

Chief Judicial Magistrate Nitya Nanda Barman passed the order after Advocate Badrul Islam Chunnu, joint convener of district BNP, filed the defamation case around 11:00am.

According to the complaint, Inu termed Zia as the fourth "mirjafar" (betrayer) of the country at a public meeting at Kataribazar in Rangpur on April 3.

Principal of Dhaka Ramkrishna Mission Swami Akkharananda died of old age complications in a city hospital yesterday. He was 83.

Akkharananda was admitted to the Apollo Hospital last month with diabetic, kidney and other complications and died around 10:00am.

Akkharananda also known as "Maharaja" would be cremated at Sabujbagh Crematory this noon, said an official of the Mission.

The president of Bangladesh Puja Utjapon Parishad Subroto Chowdhury and general secretary Mongol Chandra Ghosh, president of Mohanagar Sarbojaneen Puja Committee Biresh Chandro Shaha and general secretary Babul Debnath and general secretary of Bangladesh Chhatra Jub Oikya Parishad, Nirmol Kumar Chettarji expressed deep shock at his death.

Born in Satkhira in 1929, Akkharananda was the viceprincipal of Narendrapur Ramkrishna Mission in India.

He joined the Dhaka Ramkrishna Mission in 1974.

Five held for saving molester

Police arrested five people from Basupara in the city's Darussalam area last night for holding an arbitration to protect a man who allegedly molested a minor girl.

Sub Inspector (SI) Tariqul Islam of Darussalam Police Station said Masudur Rahman, 45, khadem of a local mosque, attempted to rape the seven-year old girl near the mosque when she was returning home after finishing her Arabic lessons.

Being informed, her family asked the mosque committee for appropriate action. The committee held an arbitration and fined Masudur Tk 2,000. This meager punishment made the locals angry. They then informed police, said the SI.

Fish traders murdered Rapist killer Taleb arrested

Two arrested

Two people were arrested yesterday in connection with the murder of two fish traders in Hamidchar under Chandgaon Police Station in Chittagong.

The arrestees Babul, 28, and Lokman, 27, were nabbed from Chittagong Medical College Hospital (CMCH) area, said police.

A group of Hamidchar's residents locked in a clash with a group from Bolihat area on Sunday over occupying a piece of land at Hamidchar to breed fish fries. Two people died and 15 others were injured in the half hour-long clash, during which gunshots were heard, said police.

Md Yusuf, one of the wounded, filed a case with Chandgaon Police Station on Sunday night naming 21 people and some 20 unidentified.

Officer-in-Charge Syed Abdur Rauf of Chandgaon Police Station told The Daily Star, "We are trying to nab rest of the accused."

The dead Abdus Sabur, 45, and his nephew Mohiuddin, 25, were residents of Hamidchar.

Of the injured, four were admitted to CMCH with injuries inflicted from gunshot and sharp weapons. Sabur, sustaining bullet injuries, died at CMCH while Mohiuddin's beheaded body was recovered from the spot.

Rapid Action Battalion (Rab) arrested Abu Taleb who raped and allegedly killed a student of class eight setting her on fire after she became pregnant for seven months from the capital's Rampura yesterday.

The victim Nilufa, 16, died on January 31 at the Burn Unit of Dhaka Medical College Hospital (DMCH) after fighting for her life for seven days.

Nilufa, a student of Matankur Paschimpara High School in Comilla, had been violated in June last year by Abu Taleb, 35, a neighbour, with help from Josna, a distant aunt of the victim, said Rab officials at a press briefing at Rab-1 office at Uttara after producing the arrestee before the press.

Comilla police arrested Josna on January 24 following the incident.

Lt Col Mohammad Rashedul Alam, commanding officer of Rab-1, said Taleb and Josna, also a neighbour, reached Nilufa's

home at Martaain Court under Comilla Sadar Dakkhin upazila on January 23 around 7:10pm and informed her that her father had met an accident while he was going to the mosque for Esha prayers.

As soon as Nilufa stepped out of her house, Josna clamped her mouth shut while Taleb, a father of two children, doused flammable liquid on her and lighted a match to her body fearing disclosure of their involvement in rape case, he added.

DMCH before Metropolitan Magistrate AEM Esmail Hossain on January 26 where she named Taleb and Josna as the culprits, he added.

According to a High Court order on February 23, Rab arrested the main accused Taleb.

Abu Taleb denied his involvement in the crime at the press briefing and claimed he was staying at a shop of nearby market when the incident happened. But he admitted sexual relationship with the victim.

Amini's comments tantamount to treason

Say members of civil society

Leading members of civil society blasted controversial leader of a faction of Islami Oikya Jote (IOJ) Fazlul Haque Amini yesterday for his "audacious' comments about the Women Development Policy.

"Amini's comments are very objectionable and tantamount to treason for denial of the constitution," noted educationist Prof Sirajul Islam Chowdhury said as politicians belonging to different parties earlier demanded his arrest for threat to use madrasas to paralyse the country.

He said Amini took a direct stand against the constitution which guarantees equal rights of all irrespective of their gender.

Several other distinguished people including academics echoed him saying the government should immediately act to contain religious bigots like Amini with iron hand in the interest of the country's peace, progress and prosperity.

Amini recently threatened to paralyse the country using 20,000 madrasas across the country if the Women Development Policy was not scrapped as his group was trying to spearhead a campaign against the policy calling it anti-Islamic, disagreeing with leading Islamic scholars' observations and government clarifications.

Prof AAMS Arefin Siddique said Aminis's comments regarding the women policy clearly aimed at creating disorder and anarchy in the country which is a "serious crime".

"There is nothing in the Women Development Policy that goes against the holy Quran and Sunnah. But, religious fanatics led by Amini are out to create disorder and anarchy by confus-

ing the people," Prof Siddique said. He said there were many madrasa students who uphold the spirit of the War of Liberation while the religious bigots had opposed it in 1971 in the

name of Islam.

"These elements are now opposing the women policy in the name of the religion again," he said.

Leading economist Qazi Kholiquzzaman Ahmad said nothing was there in the women policy that contradicted the holy Quran as claimed by the ultra right elements like Amini.

"It (policy) contains nothing which Dhaka University Vice-Chancellor could be cited to cause anarchy . . . it is the responsibility of the government to take steps so none can create an anarchic situation," he said.

Bangladesh Economic Association President Abul Barakat suggested the government to launch a massive campaign to disseminate the contents of the policy among the people so the "vested groups" could not mislead them.

"There is nothing in the policy which is against the holy Quran . . . I think the propaganda launched by Amini is the part of a campaign to frustrate the successes of the present government and stall trial of the 1971 war criminals," Barakat said.

MIG-29 PURCHASE Trial in graft

case resumes COURT CORRESPONDENT

The trial in the MiG-29 purchase graft case resumed

yesterday at a Dhaka court with the deposition of complainant, Abdullah Al Zahid, deputy director of the Anti-Corruption Commission (ACC).

Judge Mohammad Abdul Majid of the Special Court for Dhaka Division recorded statement of the complainant and fixed May 3 for the next hearing after the defendants' lawyers cross-examined him.

The four accused are Air Marshal (retd) Jamal Uddin Ahmed, former Defence Secretary Syed Yusuf Hossain, Air Commodore (retd) Mirza Akhter Maruf and former joint secretary Mohammad Hossain Serniabat.

Of them, only Akhter Maruf was present during yesterday's hearing while lawyers represented three others in their absence.

Earlier on April 6, this year the same court dropped all charges against Prime Minister Sheikh Hasina, who was also an accused of the case.

The High Court on March 9 last year quashed the case proceedings against her.

On August 12, 2008, the court relieved another accused, former army chief Gen (retd) Mustafizur Rahman of all charges in the

case, after he died on August 3. The proceeding against Unique Group Managing Director Nur Ali was stayed following a writ petition chal-

lenging the legality of the case. On August 20, 2008, the same court framed charges against Hasina and five others in connection with

The case was filed on December 11, 2001 with Tejgaon Police Station against Hasina and six others.
