### Sher-e-Bangla's contribution recalled

### Coast Guard gets three Navy ships

Bangladesh Navy handed over three of its ships permanently to Coast Guard at simple ceremony in the city yesterday, says an ISPR release.

The ceremony, attended by Navy chief Vice Admiral Zahir Uddin Ahmed and Coast Guard Director General Rear Admiral Kazi Sarwar Hossain, was held at Coast Guard headquarters at Agargaon.

The three ships of 61st Patrol Craft Ship (PCS) --Tawfiq, Tanvir, and Tamjid -- were made in China and commissioned with Navy in 1982.

The ships were used in combating pirates and ensuring security in Chittagong and Mongla ports and given temporarily to Coast Guard on July 17, 2005.

### 'Ban anti-liberation activities'

STOCK MARKET SCAM Legal notice on Ibrahim Khaled to quit Krishi Bank

A Supreme Court lawyer yesterday served a legal notice upon Khondker Ibrahim Khaled, asking him to resign from the office of chairman of Bangladesh Krishi Bank within 10 days for disclosing the contents of stock market scam probe report to the media.

Khondker Ibrahim Khaled, head of the fourmember probe committee, submitted the probe report to the finance minister on April 7. ATN Bangla, a private TV channel, aired his interview on this issue on April 7 and 8.

Advocate Md Abul Hashem in the notice said Khondker Ibrahim Khaled has made some objectionable comments regarding certain companies and individuals at different times in different electronic media.

"You (Ibrahim Khaled) deliberately and consciously got involved with character assassination of people and business organisations quoting from your so-called report and your such undesirable comments were not made in good faith and your terms of reference," the notice said.

It said that Ibrahim Khaled has intentionally disclosed the contents of the probe report, which is an absolute property of the government of republic, which is a violation of relevant laws.

Abul Hashem told The Daily Star that Ibrahim Khaled's earlier commented that steps should be taken against the people named in the probe report under the martial law. This is amount to inviting martial law in the country, Abul added.

He also said that he served the notice for the interest of people, and he will file a writ petition with the HC, seeking its direction on Ibrahim Khaled to resign from the post of chairman of Bangladesh Krishi Bank, if he does not do it within 10 days.

Advocate Syeda Afsar Jahan issued the notice on behalf of Abul Hashem.



The government should increase allocation in education sector, as this would be the best investment for a brighter future for the nation, said Education Minister Nurul Islam Nahid yesterday.

He said the government should allocate six percent of Gross Domestic Product and 20 percent of national budget for education sector in this regard. The minister was speaking at a launching

Primary and Mass Education Minister Afsarul Ameen hoped that the English version of the policy would be well appreciated in other countries like the main one which is broadly accepted among Bangladeshis. Describing the key features of the policy,

### Koko's lawyers for withdrawal of case

Lawyers of Arafat Rahman Koko, the youngest son of BNP Chairperson Begum Khaleda Zia, submitted an application to the Anti-Corruption Commission (ACC) for withdrawing or discontinuing the money laundering case filed by it against Koko.

The lawyers Mahbub Uddin Khokon, Bodruddoza Badal and Rajib Rouf Chowdhury placed the application to ACC Chairman Ghulam Rahman yesterday. According to the application, the case against Koko can

not be run as per the February 9 Supreme Court ruling over proceeding with the case under the Money Laundering Prevention Act, 2009.

## \$40m WB credit

The World Bank (WB) has approved US \$40 million credit for repatriation of Bangladeshi migrant workers escaping the ongoing conflict in Libya.

The fund is a part of the US \$74.1 million project to bring back and repatriate Bangladeshi workers from the troubled African country, says AWB release.

Another US \$29.5 million comes from different donors through the International Organisation for Migration (IOM), which will implement the project on behalf of the government. The government contribution to the project stands at US\$4.6 million.

The credits from the International Development Association (IDA), the WB's concessionary lending arm, carry a maturity of 40 years with a 10-year grace period and a 0.75 percent service fee. An estimated 70,000-

DESTROYING EVIDENCE

### 3 cops asked to face court on May 4

A Dhaka court yesterday asked three policemen to appear before it on May 4 for their explanation why they had destroyed evidence (alamat) of the Rehana Akhter Bakul murder case of Mymensingh district.

Judge Shahed Noor Uddin of the Speedy Trial Tribunal-1 passed the order after Special Public Prosecutor Abu Abdullah submitted a petition.

The policemen are Shahid Shokrana, court inspector of Mymensingh Chief Judicial Magistrate's Court, court subinspector Habibur Rahman, and court sub-inspector (retd) Ibrahim Khalil. The three policemen had earlier submitted a petition

they said the case was disposed of on July 26, 1998 and the accused constable Rafiqul Islam (husband of the victim) and his brother Nazrul Islam were acquitted of the charges. They submitted another petition for destroying evidence
