# Traders beat up mobile court chief in Sherpur

### All for action against dishonest fellows

UNB, Sherpur

Around 200 local traders of Nalitabari upazila beat up the assistant commissioner (AC-land) of the upazila in Gorkanda area of the town yesterday morning.

The agitated businessmen also damaged the jeep carrying AC land Md Shahinur Alam during the attack and besieged the UNO office at around 10:15 am.

Police said on Sunday, AC (Land) Shahinur conducted a drive at Dakkhin Bazaar of the upazila and

fined a few businessmen for using wooden scale instead of prescribed scale.

Yesterday morning, the AC land again went to the bazaar and found that the businessmen were using the wooden scale defying the order of the mobile court.

Later, around 200 traders intercepted the jeep of the land official in Gorkanda area of the town as he arrested a businessman identified as Aminul Islam.

The businessmen beat up the land matter.

official and damaged his jeep.

Local people rescued him from the clutches of the angry businessmen and took him to the UNO office.

Later, the businessmen also besieged the UNO office and demanded removal of the land official within 24 hours.

On information, Nalitabari upazila chairman Badiuzzaman Badsha and municipal mayor rushed to the spot and quelled the situation assuring the businessmen of looking into the

A team of Sirajganj police, with the help of detective branch of police, arrested Ruhul Amin Babu, a prime suspect, from Jirani Bazar area of Gazipur.


Police also recovered the mobile phone of Dr Baqui from his possession, added SI Monirul Islam of Sadar police station.

Babu was placed before the journalists here yesterday where he confessed to his crime saying that he along with two others killed Dr Baqui over a previous feud.

Earlier, on April 16, police recovered the body of Dr Baqui from a room of a government dormitory.

Although police could not immediately say the motive behind the killing but on that day they arrested Esha, a girl student of Ullahpara Hamida Pilot Girls' School and distant cousin of Dr Mirza in this connection and placed her on remand.

On the basis of her statement, police on Tuesday night arrested her husband Babu from Jirani Bazar area of Gazipur district.



#### BCL to enforce indefinite strike at HSTU today

Bangladesh Chhatra league (BCL) unit of Hajee Danesh Science and Technology University (HSTU) will enforce an indefinite strike at the university from today demanding removal of the vice chancellor (VC).

Earlier, the BCL yesterday enforced a 4-hour long strike protesting postponement of examination and demanding removal of a director of accounts department.

The agitating students also demanded an end to employees' political links with Jamaat and BNP.

At a protest rally held on the campus, the BCL leaders demanded immediate removal of Fahima Khanam, director of HSTU accounts department, for allegedly misappropriating Tk 70 lakh.

Fahima Khanam, however, outrightly refuted the charges against her.

The leaders at the rally alleged that university authorities appointed people from Jamaat-e-Islami and BNP which politicized the university activities.

They blamed vice chancellor Professor Afzal Hossain for his failure to check corruption in the university and demanded his removal within 24 hours. Otherwise, the BCL would enforce an indefinite strike from today, they said.

## 39 bombs recovered in B'baria town

Over 100 seized in last 35 days, says OC

Police recovered 39 homemade bombs in an abandoned condition from a field near Ashik Plaza in the town on Tuesday night.

Acting on a tip-off, a police team led by Md Mahfuzur Rahman, assistant sub-inspector (ASI) of Brahmanbaria Sadar police station, raided the field on the east side of Ashik Plaza around 11:40pm and recovered the bombs wrapped with red tape.

'To avoid possible explosion, we have kept all the bombs in three plastic water buckets on the police station compound,' said officer-incharge (OC) of Sadar police station Gazi Md Shakhawat Hossain said.

Although the recovered bombs looked like homemade hand bombs, the OC claimed them as cocktails.

The OC said that police recovered more than 100 'cocktails' in the last 35 days from several areas of Brahmanbaria town.

On April 7, police recovered seven 'cocktails,' a map of Bangladesh and several documents in an abandoned condition from one

under Brahmanbaria municipality.

On April 5, police found five cocktails in an abandoned condition at Kazipara Saydunnesa Madrassa.

On March 24, OC Shakhawat along with his team recovered 55 more

'coctails' from Bhadughar area of the town.

Acting on a tip-off, a team led by the OC himself raided a place near Bhadughar Railway Bridge and recovered 34 'cocktails' wrapped with red tape and found 21 other 'cocktails' at a sand field in Bhadughar area.

## Khulna brick traders on strike to protest brick price hike

Brick traders here went on an indefinite strike yesterday protesting 'abnormal' price hike of bricks.

"We have called an indefinite strike to protest the artificial crisis created by abnormally raising the price of bricks by brickfield owners", said Abdus Sattar Khalipha, president of Khulna Brick and Sand Traders' Association and a member of executive committee of Khulna city Awami League.

Purchase and sale of bricks, sand and brick chips shall remain suspended till prices are reduced to reasonable rate, he said.

"We have no other alternative to such hardline knowing fully well that this strike will create an adverse impact on development works", said Yakub Ali Khan Palash, general secretary of the same association.

The two leaders of the association said that a thousand pieces of good quality bricks which was sold between Tk 4,500 and Tk 5,000 early this year has now been raised to Tk 6,500.

Over a hundred traders belonging to our association have stopped buying bricks from any of the 55 brickfields of Khulna city and district in support of the call for indefinite strike, they said.

Besides, all these traders

have also stopped selling bricks from yesterday in support of the strike call, Sattar Khalipha said.

Leaders of the association alleged that brickfield owners are doing monopoly business by raising prices at their will and without any logical ground.

"We have to purchase per one thousand good quality brick at the rate of Tk 6,000 while LGED, RHD
