Bring to justice killer of schoolteacher Monjuri

Protesters in Gaibandha demand

Several hundred people including students, teachers, political leaders and freedom fighters formed a human chain on Saghata upazila parishad premises yesterday demanding immediate arrest and punishment of the killer of schoolteacher Monjuri.

The protesters later handed over a memorandum to Saghata upazila nirbahi officer (UNO) for placing it before the home minister.

rally said, Shahadat Hossain, husband of Monjuri Begum, 23, assistant teacher of Bonarpara Adrasha Govt Primary School and daughter of freedom fighter Mokbul Hossain, killed her by suffocation at dead of night on April 22 in his inlaws' house and fled with their two-year-old son.

On that day, Shahadat, a resident of village Dhamuir Haor in Naogaon district, had come his father-in-law's house at Bonarpara.

Police are yet to arrest Shahadat six days into the incident despite filing of a

The accused is moving freely and threatening the victim's family for withdrawal of case, family sources said.

Those who spoke at the rally are AHM Golam Shaheed Rangu, Saghata upazila chairman, Master Abdullah Akanda, former BNP president Fajilatunnahar Parul upazila vice-chairman, Moyen Prodhan Labu and Ferdoushi Begum.

College teacher gets RI for torturing wife

A court here yesterday sentenced a government college teacher to three years rigorous imprisonment (RI) for torturing his wife.

Convict Humayun Kabir Jewel was an English teacher of Rajshahi New Government Degree College when the incident took place in September last year.

He was transferred to Sonagazi Government College in Feni following unrest in the city demanding his punishment.

Afzal Hossain, the first tribunal judge of the Women and Children Repression Prevention Court in Rajshahi pronounced the verdict.

The court also fined Jewel Tk 1000, in default, to undergo another six months imprisonment.

According to the prosecution, Jewel mercilessly beat up hiswife Farhana Rubaiya Jhuma at their house in the city's Hoseniganj area on September 14 following her refusal to bring dowryofTk15lakh.

Seriously injured Jhuma was admitted to Rajshahi Medical College and Hospital.

She later lodged a case against Jewel with Rajpara police station on September 23, 2010.

Jhuma in her case alleged that Jewel had an extramarital affair with another girl. He was torturing her for several months in the name of dowry. On the day, he attempted to murder her, said Jhuma's lawyer Dil Sitara Begum Chuni.

Students of a registered primary school in Koroichura Union under Madarganj upazila of the district attend classes under the open sky as the tin-roofed school was razed to ground during storm that lashed the area on Sunday night.

Abdur Rouf, headmaster of Dakkhin Koroichura Registered Primary School, said local donors built the school with bamboo poles and tin sheet roofing in 1983. The school got government registration in 1994, he added.

Poor students from Mahishbathan, Vangbari, Dhulirband villages under Koroichura Union and Gupalpur village under Gunaritola Union are studying at different classes of the school. There are only four teachers, including the headmaster, for around 250 students.

Though some officials of donor agencies and LGED had visited the school several times, no concrete school building is yet to be built, the headmaster said, adding that local lawmaker has remained indifferent to the need.

Transport owners and workers in Meherpur yesterday enforced an indefinite transport strike demanding ban on Easy Bike, a battery run carrier.

The strike is a sequel to Monday's clash between bus workers and Easy Bike owners in Judge Court area in Meherpur town.

Meanwhile, local administration imposed Section 144 on gathering at Sahid Shamsuzzoha Park in the town as both

groups called a meeting there. Transports in all routes in Meherpur remained off the road since morning.

The strike was called off the next day following a request of district administration. The district administration called a meeting with both the groups.

Four houses and six shops were gutted in Sylhet and Brahmanbaria on Wednesday.

Valuables worth about Tk 2 crore were damaged as four houses were gutted in a fire, which broke out at Goyaipara in Sylhet city early Wednesday, reports UNB.

Local people said the fire broke out at a house own by four brothers -- Mohiuddin, Moinuddin, Sadek and Abdul Munim -- at about 2:30am.

On information, fire fighters rushed in and doused the flame at about 6am with the help of local people.

However, the cause of the fire could not be known immediately. Mohiuddin said they saw their houses on fire and soon 21 rooms of four houses were completely damaged.

Mohiuddin suspected that his uncle and his sons following a land dispute might have set their houses on fire dousing kerosene oil.

The affected brothers estimated the extent of loss from the fire at Tk2 crore.

In Brahmanbaria, fire gutted six shops and valuables at Nasirpur village in Nasirnagar upazila on Wednesday.

Police said the fire originated from an electric short circuit at a battery shop and soon engulfed the adjoining shops at Nasirpur Market at noon.

On information, fire fighters from Brahmanbaria Sadar station rushed to the spot and doused the flame with help of local people.

The affected shop owners claimed that the extent of loss from the fire could go up to Tk 10 lakh.
