

Ravaged during the onslaught of super cyclone Aila on May 25 in 2009, the iron bridge near Chapli Bazar in Dhulashar union under Kalapara upazila of Patuakhali district has remained without repair or replacement, much to the distress of the locals.

Bridges damaged by Sidr, Aila in Kalapara yet to be repaired

Thousands of people are suffering as 10 bridges in Kalapara upazila under Patuakhali district have remained useless after they were damaged by super cyclone Sidr on November 15 in 2007 and Aila on May 25 in 2009.

The bridges include Madhukhali bridge, Nishanbaria bridge, Gazibari bridge, Banatipara bridge, Majhergram bridge, Anantapara bridge, the bridge in front of Dhankhali College, Pakkhipara bridge and Londa bridge.

superintendent of Purbo Madhukhali Dakhil Madrasa, said, students of the institution are suffering a lot as the bridge on Madhukhali canal near the madrasa was damaged during Sidr.

"Students' attendance has reduced as they have to cover a few kilometres in addition. Several times I personally requested the staff at LGED office in Kalapara to take step to repair the bridge but to no effect," he said.

People of seven villages in the upazila are greatly suffering as Pakkhipara bridge on the alternative road Maulana Abdullah, between Kalapara and

Kuakata was damaged in Aila and plying of public transport stopped on the road. People crossing the road on motorcycles and on foot have to cross the river by boat. A few passengers were injured in several boat capsizes in the river.

Locals and school going students are suffering a lot as the bridge over Chapli canal has remained useless since it was damaged during Aila, said Anwar Hossain, headmaster of Chapli Islamia High School in the upazila.

Locals made a sako (bamboo bridge) on Londa canal as the damaged bridge is yet to be repaired.

Local communication is badly disturbed as many bridges that were damaged during Sidr and Aila are yet to be repaired, said Abdul Maleg, chairman of Khaprabhanga union parishad in Kalapara upazila.

When contacted, LGED engineer Moniruzzaman said, "We sent a proposal urging immediate step to repair the five damaged bridges and build two culverts two years ago but higher authorities are yet to approve it. However, work has started to construct a girder bridge on Pakkhipara canal."

One person was killed and at least 700 houses were damaged as nor'wester lashed Moulvibazar, Rangpur and Nilphamari districts on Monday night and early yesterday.

In Moulvibazar, a day labourer was killed and over 100 houses were damaged as nor'wester swept over Dolubari, Bhunobir, Shasan, Boulashir and Mirjapur villages in Srimongal upazila on Monday night.

The dead was identified as Musabbir Miah, 65, of Dolubari village. He died as his thatched house collapsed on him during the storm. Electric poles and a large number of trees were also uprooted at the stormhit villages.

Our Rangpur correspondent reported that about 500 houses were damaged during a storm that hit four villages under Gangachara and Rangpur Sadar upazilas early yesterday.

The affected villages are Utoom Hajirhat, Khalea, West Birabari, and Debipur..

Rangpur Sadar upazila nirbahi officer said the storm blew away roofs of Uttom Hazirhat Fazil Madrasa and Zafarganj High School. He said the local administration is distributing relief materials among the affected people.

SCHOOLBOY MIZAN MURDER

Fellows demand punishment to killers, arrestee sent to jail

Several hundred students of Bera High School brought out a procession in the upazila headquarters yesterday demanding punishment to the killers of Md Mizanur Rahman, a class IX student of the school.

"The school authority will organise a human chain and hold a condolence meeting on the school premises on Thursday protesting the killing of Mizan. Teachers, students and guardians will participate there," said Md Ali Asraf, the headmaster of the school.

The court yesterday sent to jail Sumi Khatun, arrested in connection with Mizan murder.

"Sumi has given some important information about her relation with Mizan and related incidents. We have also found some clues to the murder," said Sub Inspector Md Tarek of Bera police station, also the investigation officer (IO) of the case.

The arrestee gave her confessional statement to the court, the IO said.

He, however, declined to reveal further 'for the sake of investigation'.

'Give constitutional recognition to plain land adivasis'

Indigenous leaders at a rally held here yesterday demanded immediate implementation of their seven-point demand including constitutional recognition of indigenous people of plain land.

Jatiyo Adibashi Parishad (JAP) organised the rally around 11:00am at Alupatty in the city at with its president Anil Marandi in the chair. Rajshahi lawmaker Fazle Hossain Badsha also attended the rally and expressed his solidarity with the demands of indigenous people.

Other demands included inclusion of indigenous communities in the census, their reserved seats in parliament and local government units, establishment of separate ministry and land commission for indigenous people of plain land.

Speakers said the gov- land. ernment has taken an initiative for constitutional recognition of indigenous people living in hill areas. members of indigenous communities living in plain land had played a brave and bold role during the Liberation War of Bangladesh in 1971.

They lamented saying, still they are termed as 'small ethnic groups,' not as specific communities.

They said, some 30 lakh indigenous people of over 45 indigenous communities like Santal and Orao live across the country. Of them, 15 lakh indigenous people of 38 communities now reside in 16 districts of Rajshahi and Rangpur divisions.

They lamented saying, the government is reluctant to acknowledge the true identities of indigenous communities living in plain
