BPDB seeks to qualify interested power project developers who have previous international (for local bidders local experience will be accepted) experience in implementing power generation projects, and invites interested developers to submit (i) Qualification Statement & Technical, Commercial and Financial Proposal and (ii) Tariff Proposal in accordance with the criteria set forth in the Qualification Document and Request for Proposal (Technical, Commercial, Financial and Tariff requirement) respectively.
