## men near UK nuclear plant

British police arrested five men under anti-terrorism legislation close to a nuclear plant, but said Tuesday the case appeared to be unconnected to the death of Al-Qaeda chief Osama bin Laden.

Officers stopped the men in a vehicle near the Sellafield nuclear site in Cumbria, northwest England, at around 4:30 pm (1530 GMT) on Monday.

They are all of Bangladeshi origin but live in London, a police source told AFP. On Tuesday, counter-terrorism police raided properties in the British capital in connection with the arrests.

"Police officers from the Civil Nuclear Constabulary conducted a stop check on a vehicle close to the Sellafield site in west Cumbria," said the statement from Cumbria Police.

#### Dozens dead as Ivorian troops clash with militia

Dozens of bodies littered the streets of an Abidjan neighbourhood yesterday as fighting continued between Ivory Coast troops and the remnants of a militia loyal to deposed leader Laurent Gbagbo.

The clashes highlight the West African country's struggle to restore security after a violent power struggle between Gbagbo and his rival Alassane Ouattara, who won a November election and is now president.

"We have seen many dead. We recovered 40 bodies over two hours, but we were forced to stop because he had no room left in our van," said Franck Kodjo, an official at the International Committee of the Red Cross, adding at least five corpses were from yesterday's fighting.

The world's largest cocoa grower nation tipped toward civil war after Gbagbo refused to cede power to Ouattara, triggering a conflict that killed thousands and displaced more than a million people and only began to ease with Gbagbo's arrest last month.

A commander for the Ivorian army, known as the FRCI, said the remaining pro-Gbagbo fighters in the Abidjan neighbourhood of Yopougon were mostly Liberians who had crossed the border in the election dispute's aftermath as soldiers for hire.

Efforts to disarm them have so far failed.

However, some rules of the proceedings could be amended to protect the rights of the accused, he observed.

"It's our established right to try the war criminals. Please allow Bangladesh to follow its judicial system... We assure the trial will be transparent," said Lt Gen (retd) M Harun Ar Rashid of Sector Commanders' Forum.

The trial will be held in the standard best to the country's judiciary, he said, adding: "We only need international support for the trial to be held. All observers will be welcome, but no interfer-

Liberation War Museum Trustee Mofidul Hoque said the international community has to be engaged more vigorously in supporting the war crimes trial because the genocide has not earned its recognition.

"While trying the war criminals, we must try protecting the victims," he added.

Bangladesh is a special case where the trial is being held under a domestic law and judiciary, which should be an inspiration for the international community, said Liberation War Museum Trustee Sarwar Ali.

Ruling Awami League lawmaker Saber Hossain Chowdhury said a sense of impunity developed over the years as the war criminals were not tried for decades; rather they were rewarded following the assassination of Bangabandhu Sheikh Mujibur Rahman, the father of the nation, in 1975.

"Therefore, the trial is very important. If we cannot complete the trial this time, we cannot do it in future," he said, adding: "The international community must not be our roadblocks."

Former adviser to caretaker government Rasheda K Chowdhury said the fact that war crimes took place must not be negotiated. The international community can suggest, but finally it is Bangladesh that will decide the course of actions.

"While fairness in the trial is imperative, we also want fairness in the attitude of the international community," said Md Abdul Hannan Khan, coordinator of the investigation agency of International War Crimes Tribunal.

The Daily Star Editor and Publisher Mahfuz Anam said, "People have committed unimaginable crimes and we as a nation have waited for years impatiently for some sort of justice. Now through a democratic process, we are again on the track."

"We were the first victims of ethnic cleansing," he said, adding that Bangladeshis were looked upon as inferior Muslims and one of the reasons behind mass rape was that they wanted to create a new race -- men from Pakistan and women from Bangladesh.

"We don't want to take the argument on sovereignty or emotion. We want to base the argument on facts and justice," Anam added.

Maj Gen (retd) KM Shafiullah, former ambassador Humayun Kabir, Transparency International Bangladesh Executive Director Iftekharuzzaman, Stamford University Associate Professor Syed Masud Reza, among others, also spoke at the programme moderated by Prothom Alo Editor Matiur Rahman.

The gang, who went there in a white microbus, looted Tk 3 lakh, gold ornaments weighing eight to 10 tolas and six cell phones, said Kishore Devnath, Rajendra's nephew.

Half an hour later, the robbers exploded cocktails to make their way out as locals came in their pursuit.

The mob, however, managed to stop the microbus, blocking the highway at Boleya Bazar.

Introducing themselves as policemen of Birganj Police Station, gang members asked the locals to let them go. As the latter did not comply, they fired three gunshots, locals said.

The villagers caught five of them while the rest escaped. The five were confined to a room in Rajendra's house. People set fire to the

him. Around 8:30am, Kaharol OC Shahidullah went there with eight policemen and became engaged in a furious argument with villagers, who at one stage overturned the pickup truck that had carried the OC and his team.

As the law enforcers fired rubber bullets at the crowd, villagers caught the cops and also confined them to the same room and torched the vehicle.

"...a set of 10 amendments to the ACC Act which include a number of procedural changes but also three changes which, if passed into law, would circumscribe the ACC's effectiveness," the WB said in its halfyearly report titled Bangladesh Economic Update.

The three proposed amendments are requirement of permission prior to file case against any public servant, the provision of introducing punishment for giving false information, and curtailing ACC's authority to appoint its secretary independently.

The cabinet chaired by Prime Minister Sheikh Hasina approved the amendments in February maintaining secrecy and keeping even the commission itself in dark about the amendments.

Currently the amendments are under scrutiny of parliamentary standing committee on law and order and awaiting an expected passage in the parliament where the ruling party enjoys two third majority.

The WB said alongside developments on telecommunication policy and policy responses to stock market volatility, the development on ACC Act amendment is one of the major cause of concern.



abouts. Last week, WikiLeaks had revealed that a US diplomatic dispatch told the Americans that "many" inside Pakistan knew where bin Laden was.

The document stated that "In Pakistan, Osama Bin Laden wasn't an invisible man, and many knew his whereabouts in North Waziristan, but whenever security forces attempted a raid on his hideouts, the enemy received warning of their approach from sources in the security forces."

Other documents

released by WikiLeaks also seem to indicate that the United States possibly got a clue about bin Laden hiding in Abbottabad three years ago from information gathered by interrogators at Guantánamo Bay, the controversial US detainment facility where terror suspects are lodged.

Cables from 2008 released by WikiLeaks talk about the interrogation of a Libyan, Abu al-Libi, who had apparently been with Bin Laden in Afghanistan. In 2003, Libi was asked to become one of bin Laden's messengers, the document indicates.

The document says, "In July 2003, detainee Libi received a letter from [bin Laden's designated courier, Maulawi Abd al-Khaliq Jan. The detainee was told to take on the responsibility of collecting donations, organising travel and distributing funds for families in Pakistan...The letter stated the detainee would be the official messenger between [bin Laden] and others in Pakistan...In mid-2003, the detainee moved his family to Abbottabad and worked between Abbottabad and Peshawar."

Abu al-Libi was captured in Pakistan in 2005.
