## BCL, JCD men bar CCC tender dropping

Two listed Chittagong City Corporation (CCC) contractors barred a tender dropping schedule for two hours yesterday at Nagar Bhaban in Chittagong.

The CCC tender was for procurement of electrical equipment for Halishahar Sub Station worth Tk 42 lakh.

CCC sources said contractors Shabuddin, activist of Jatiyatabadi Chhatra Dal, and Saifullah of Bangladesh Chhatra League were barring other contractors from dropping tender documents into the tender box around 9:00am on the Bhaban's second floor.

On information, Mayor M Manjur Alam sent his personal secretary Abdur Rahim to the spot. Rahim said the contractors assaulted him when he went there.

"When I informed other CCC officials, both fled," he added. CCC Secretary Shamsuddhoa said he went to the spot around 11:00am but saw nothing. But after opening the box half an hour later than the scheduled time, they found a tender of "Engineers and Construction Company" complaining in this regard, he added. CCC sources alleged the two contractors were very close

to Councillor and President of CCC Standing Committee on Power Md Giyas Uddin.

Md Giyas, however, denied and complained that the alleged contractors were using his name to save themselves.

Parliament goes into session on May 22

Parliament goes into session on May 22 at 4:00pm.

President Zillur Rahman yesterday convened the parliament session, said a release of the parliament secretariat.

It will be the ninth session of the current parliament that went into its inaugural session on January 25, 2009.

The Business Advisory Committee, led by Speaker Abdul Hamid, will sit to decide the business of the ensuing session.

The meeting will also settle on whether this session will merge with the budget session, which usually begins in the first week of June.

The parliamentary special committee on constitutional amendment may place its report in the House during this session, with a set of proposals for bringing about changes in the republic's charter.

## Court accepts case against Allow teachers in Tarique, Giasuddin

A Dhaka court yesterday took into cognisance of the charges against BNP Senior Vice-Chairman Tarique Rahman and his business partner Giasuddin Al Mamun in a money-laundering case.

The court also asked Tarique, elder son of BNP Chairperson Khaleda Zia, to appear before it on May 19.

The hearing on charge framing will be held on the same day, the court said.

Judge Mohammad Zahurul Haque of the Senior Special Judge's Court passed the order after hearing arguments from Attorney General Mahbubey Alam and defence counsel barrister Rafique-Ul Huq.

Earlier the court rejected a defence petition for adjournment of deliberation on the charges against Tarique.

During the hearing, Rafique told the court that they had earlier filed a review petition with the Supreme Court (SC) against its earlier judgment.

In the judgment delivered on February 9 this year, the SC ruled that the proceedings of money laundering case against Tarique cannot run under the Money Laundering Prevention Act 2009, as the alleged offence took place before its enactment.

It, however, said the trial can proceed under the Money Laundering Prevention Act 2002, as the reported incident took place after its enactment. The review petition is now pending hear-

ing. So, the defence lawyers prayed for the adjournment until disposal of the review petition, Rafique said. Opposing the defence plea, Mahbubey

Alam said that there was no legal bar to taking into cognisance the charges against the accused as the defence lawyers could not obtain any stay order from the higher court.

On July 6 last year, the Anti-Corruption Commission (ACC) pressed charges against the two for laundering Tk 20.41 crore in between 2003 and 2007.

# UP poll contest

HC asks EC

The High Court yesterday directed the Election Commission to allow 48 teachers of different non-government schools and colleges of 26 districts to contest in the Union Parisad (UP) polls.

Responding to a writ petition, the court also issued a rule upon the EC to explain within four weeks why its restriction on the school and college teachers to contest in the UP polls should not be declared illegal.

The HC bench of Justice Mirza Hussain Haider and Justice Md Nuruzzaman came up with the order and rule after holding hearing on the petition jointly filed by the 48 teachers.

They filed the writ petition on May 2 challenging the EC decision on the restriction. The teachers are under the monthly payment order (MPO).

In the petition, they said that over 100 teachers have already been elected in the recently held UP elections.

The EC on different dates in April informed their stance on the restriction to the media.

Advocate ABM Nurul Islam appeared for the petitioners.

### Bidi workers want alternative jobs

Some workers of bidi (hand-rolled cigarette) factories yesterday demanded alternative employment if the government wants to discourage smoking and close bidi factories by imposing high tax.

Speaking at the discussion, one of the workers Chameli said many are forced to work in biri factories due to absence of an alternate employment opportunity in local communi-

Advocate Nilufar Banu, researcher of RDC, quoting her keynote paper, said, "We the organisers of research and development collective are not in favour of smoking or use of tobacco. We also want smoking to be discouraged. "But we do not want these workers to become unem-

ployed and cigarette factory owners to find more profit from

the government's policy to discourage smoking." RDC General Secretary Prof Mesbah Kamal chaired the discussion where another worker Bacchu Miah of Shatkhira; Bangladesh Bidi Sramik Federation General Secretary MK Bangali; and its joint secretary Abdur Rahman also spoke.
