A top UN envoy will this week become the first senior official from the world body to visit Myanmar since the dissolution of the junta and the appointment of a nominally civilian government.

Vijay Nambiar, the chief of staff to UN Secretary General Ban Ki-moon, was expected to hold talks with government members, while opposition figurehead Aung San Suu Kyi also planned to meet the envoy.

"Nambiar will come to Myanmar this week. He's likely to meet with government officials and the opposition," a Myanmar official told AFP yesterday.

Official sources in Naypyidaw said new President Thein Sein was not scheduled to meet Nambiar, but foreign minister Wunna Maung Lwin would meet him onWednesday in the capital.

Assad tightens grip on Syria's restive third city

Government forces backed by snipers on rooftops tightened their grip on Syria's third city on Monday, rights groups said, after President Bashar al-Assad sent in tanks in a sharpening crackdown on protests against his rule.

A human rights campaigner in Homs said snipers deployed in several residential neighborhoods as the sound of gunfire died down in districts of the city that tanks stormed on Sunday.

"There are snipers visible on rooftops of private and public building in al-Adawiya, Bab Sebaa and al-Mreijah neighborhoods. Hundreds have fled from three villages just to the southwest of Homs where tanks had deployed," the campaigner said.

Homs, the hometown of Assad's Westerneducated wife Asma, lies in the middle of an agricultural region on the highway between Damascus and Syria's second largest city Aleppo. One of Syria's two oil refineries is in Homs.

The Syrian Observatory for Human said.

Rights said three civilians were killed on Sunday in Homs, a merchant city of one million people 165 km (100 miles) north of

Damascus. Activists said the authorities had widened a shutdown of Internet and phone

services. Syrian authorities have banned foreign media from reporting from the country.

Security forces dispersed a small prodemocracy demonstration in the center of the Damascus on Monday, arresting opposition writer Ammar Mashour Dayoub and several students, the Syrian Observatory for Human Rights said.

In the capital's district of Barzeh, 20 people were arrested in another demonstration, a resident of Barzeh said.

In the south, tanks deployed around the towns of Inkhil, Dael and Nawa, widening a sweep into the strategic region that borders Jordan and the Israeli-occupied Golan Heights.

CHINA LANDSLIDE Death toll rises to 12

The death toll from a raintriggered landslide at a quarry in south China has risen to 12, and rescuers say they have seen no signs that 10 others still missing are alive, state media said yesterday.

The landslide on Monday buried a workers' dormitory and the surrounding area under hundreds of thousands of tonnes of mud in Luojiang village, near the tourist city of Guilin in Guangxi region, the Xinhua news agency said.

Police, firefighters and other rescuers were digging with the help of eight excavators to find the missing workers.

Local official Tang Chaobin said rescuers had found no traces of life under the rubble but would nevertheless continue the search until all of the missing were found.

The Afghan government yesterday called on Taliban leaders to join peace talks initiated by the government or face the same fate as Osama bin Laden, who was killed by elite US commandos last week.

Opening a two-day conference discussing efforts to broker peace, Afghan Vice President Mohammad Karim Khalili said the talks were an opportunity for the Taliban to embrace peace.

"The peace and reconciliation programme initiated by the Afghan government is a good opportunity for the Afghan armed opposition, specially their commanders, to stop the destruction (of Afghanistan)," said Khalili.

"Otherwise eventually they will face the same fate as Osama bin Laden," he added.

Khalili reiterated that bin Laden's killing in Pakistan showed that Afghan claims were correct that al-Qaeda and Taliban leaders enjoyed support from elements in Pakistan. "The killing of Osama bin Laden, the leader of al-Qaeda,

gives us hope that the voice of the people of Afghanistan is now being heard," he said.

Thailand's election countdown began on Monday when the government se July 3 for what promises to be a tough battle, after the king endorsed a decree to dissolve the lower house of parliament.

The vote comes at a hugely sensitive time for Thailand, a year on from an army crackdown on opposition "Red Shirt" rallies in Bangkok. Clashes between troops and protesters left more than 90 people dead, mostly civilians.

Suranjit Sengupta, cochairman of the parliamentary special committee on constitutional amendment, termed the judgment a "historic and landmark".

"Through the verdict some people [SC judges] have made it clear that they have no interest in state power," he said applauding the chief justice for the verdict.

"The caretaker government system was a temporary solution and it can't run for ever."

According to him, politicians will now have to find a "new formula" for holding of parliamentary elections in future.

"I personally respect the judgment of the Supreme Court," said HM Ershad, chairman of Jatiya Party (JP), the key partner of ruling ALled grand alliance, in his immediate reaction.

He said the judgment is the reflection of his party's suggestion to the special parliamentary committee to amend the constitution.

"I told the committee that the judiciary turns controversial if the chief justice is made the chief adviser to the caretaker government and the Supreme Court today [yesterday] observed the same," added the former president.

He said all the major political parties would nominate a person to be the chief

adviser in future.

He however questioned the consequences if the two major parties -- AL and BNP -- do not reach a consensus. "History says the two parties don't reach an agreement."

The Workers' Party of Bangladesh welcomed the SC judgment and said it is an important verdict considering the prevailing situation. This judgment has made it easy to find out an alternative to the judiciary involved in the caretaker government system, said Rashed Khan Menon, president of the party, in his immediate reaction.

He said all the political parties would now have to find an alternative through discussion and consensus under whom or which system the elections should be held. Menon added the BNP-

Inu, also a lawmaker, said considering the prevailing political situation of the country, the next two elections should be held under the caretaker system.
