Having experience in successful completion of at least 02 (two) high-rise buildings of above 10-storied and at least 03 (three) basement and minimum area of 150,000sqft including civil, sanitary, electrical metro-mechanical HVAC system works amounting not less than Tk 50 crore in a single tender in govt/semi-govt/ autonomous/ private organization of Bangladesh during last 5 (five) years.

3. Having turnover on project cost by last 3 (three) years must be minimum 50.00 crore.

4. Having experience for consecutive 3 (three) years in construction capacity of residential and commercial complex consisting of minimum 150000sqft which should be certified by PWD/REHAB/related consulting firm along with copies of design approved by the govt. authorities.
