

The EC drafted the law titled Electoral Campaign Expenditure (public fund) Act, 2011, to introduce state funding system and "stop the influence of black money" in the

national polls.

The proposal says the amount of money a party will get will be fixed based on its last poll performance. This means a political party may get a maximum of Tk 25 lakh for each constituency it won in the previous elections.

Independent candidates who won in the last elections will also get state funding in the next polls, according to the draft law.

In defence of the law, the EC said it is necessary to create opportunity for all, poor or rich, to contest the polls and to stop use of black money in the elections.

The EC said it would have opinions of political parties from June 7 on the draft and some other crucial proposals to bring changes to the electoral law, Representation of the People Order (RPO).

Other proposed changes include increasing election expenditure of a candidate to Tk 25 lakh maximum from Tk 15 lakh and empowering **SEE PAGE 19 COL 5**

No new tax on BO account holders

No new tax will be imposed on beneficiary owners' account holders and tax identification numbers will also not be made mandatory for them in the next fiscal year.

Shrimp farming deals major blow to South

Coastal land in Aila-hit areas turns barren due to salinity

Ahammad Ali Gazi sighed as he surveyed his salt-covered land that once produced rice.

"This is the land where my family grew rice for years," said Gazi, a 60-year-old farmer at Gabura in Satkhira district close to Bay of Bengal. "Today, there is nothing but salt. Nothing else grows here," murmured Gazi, wiping sweat from his sun-burnt face.

The farmer has only himself to blame.

Nearly three decades ago, Gazi, like many farmers in his area, quit

rice farming to opt for shrimp cultivation that earned them more money.

Money Gazi has earned. His earning from the business continued until cyclone Aila hit the southwestern part of the country on May 25, 2009.

The entire region was washed away. All the shrimp enclosures were gone.

For about one and a half years, the area remained under saline water until the breaches Aila had created were repaired towards the end of last year.

The saline water has receded after the repair but Gazi is thun-

derstruck to find that years of shrimp cultivation has brought saline water and salt to his three acres of land making it unfit for any crop. He wonders how many years it might take for the land to recover from the damage, and regain the soil fertility to grow crops like rice.

Lured by short-term gains, farmers like Gazi, who mulls beginning with shrimp business once again, overlooked the longterm losses from shrimp farming: damage to land fertility, drinking water, and environment. But Gazi and others like him

Yunus worried about GB future

Tells The Daily Star it's not wise to amend law to ensure govt control

Nobel laureate Muhammad Yunus has warned that Grameen Bank could run into deep trouble if the

government amends the law to take control of the microfinance bank founded by him.

"If those amendments [proposed by the review committee] come and the government penetrates the bank, it will not survive very long," ProfYunus said in an exclusive interview with The Daily Star, the first after his resignation from Grameen Bank as managing director this month.

"I'm anxious about its safety," he said.

Yunus said there should not be any attempt to amend the 1983 ordinance that governs the microfinance bank unless it is recommended by the board.

A government-appointed review committee has recently suggested amendments to the Grameen Bank ordinance, even though it found no financial irregularities in the operation of the bank.

Unused foreign aid set to stand at \$12b

Unused foreign aid in pipeline may cross \$12 billion mark at the begin-

ning of the next fiscal year mainly due to failure of ministries to implement foreignfunded projects. The amount was \$9.4b on July 1 last

year, according to Economic Relations Division (ERD) statistics.

To make up the budget deficit, the government accepts low cost foreign funds. Of this, a sizeable amount is left unutilised every year, a high official of the finance ministry told The Daily Star.

The unused amount goes back to the pipeline as it is not consumed as per schedules of different projects, he added.

Though the foreign aid has increased much, the government is not being able to utilise it properly, admitted Finance Minister AMA Muhith during a prebudget view exchange meeting with the members of Economic Reporters' Forum

last month. Several ministries in the current fiscal year have already surrendered allocations of foreign funds worth 12 to 100 percent in
