Georgia opposition protests enter fifth day

AFP, Tbilisi

Protests aimed at ousting Georgian President Mikheil Saakashvili entered a fifth day yesterday although turnout dwindled as several opposition parties stayed away.

Some 200 activists maintained their vigil outside the public television studios in the ex-Soviet state's capital yesterday morning, where they have blocked a main road and set up a makeshift stage.

Accusing Saakashvili of authoritarianism, opposition party leader Nino Burjanadze has promised that yesterday will "determine Georgia's future" and is vowing to occupy another central square in Tbilisi.

But amid bitter divisions within the opposition, a rival party has cancelled plans to boost the demonstrations by holding what it promised would be an Arab-style "Day of Rage".

Looking increasingly dishevelled after round-theclock protests since Saturday, many of the activists are armed with sticks after brief clashes at the weekend.

They have put up large posters highlighting the alleged injustices and failures of the Saakashvili government, including the country's disastrous defeat in its war with arch-foe Russia in

"We will further step up these attacks to avenge Osama bin Laden's martyrdom," Taliban spokesman Ehsanullah Ehsan told AFP by telephone from an undisclosed location.

"These attacks will continue until the US drone strikes and ongoing Pakistani military operations are stopped in the tribal regions," he added. The Peshawar bombing

will likely highlight doubts about the security forces' ability to protect not only themselves but major cities, and fuel a longrunning debate about the security of the country's nuclear weapons.

Five policemen and a soldier died in yesterday's explosion, a relatively low toll given the enormity of the blast, but officials said the building normally had only a skeleton staff at the time of the attack shortly before 5:00am.

Another police official, Shafiullah Khan, said six people died and rescuers were looking for up to three people still trapped under the rubble, with 36 already taken to hospital with

injuries. Peshawar is the gateway to Pakistan's northwestern tribal belt on the Afghan border, where US drone strikes routinely target Taliban and al-Qaeda operatives.

The razed building housed the police Criminal Investigation Department and was located in the Peshawar Cantonment area just 150 metres from the US consulate. The area houses military families and security is normally tight.

Police said the attack was carried out with a small truck containing at least 200-250 kilograms of explosives, and that body parts were hurled more than 300 metres away from the blast.

Last Friday, the Taliban bombed a US consulate convoy in Peshawar, killing one Pakistani and wounding 11 other people in the first attack on Americans in Pakistan since bin Laden's killing in the town of

Abbottabad. On Sunday, heavily armed Taliban gunmen stormed a naval base in Pakistan's biggest city Karachi, destroying two US-made surveillance planes and killing 10 personnel in a 17-hour stand-

That was the worst assault on a military base since the army headquarters was besieged in October 2009, and piled further embarrassment on the armed forces three weeks after bin Laden was found living under their noses.

The meeting discussed on ways to check issuance of fake licence, ensure proper training for drivers and build awareness on road accidents among the drivers.

There are 15 lakh registered vehicles in the country while the number of genuine licence given out is around 10 lakh and the rest are all fake licences, said meeting sources.

BRTA has the capacity to train and deliver 3,500 licences a year, but the real demand is much higher,

sources added. The meeting was attended by Communications

Secretary Mozammel Huq Khan, in the chair, Labour and Employment Secretary Shafiq Alam Mehdi and BRTA Chairman Ayubur Rahman Khan.

A large number of fake licences are being issued at the BRTA-run centres, which is a big reason behind frequent road accidents in the country, said ministry officials.

The meeting decided that police and BRTC officials will jointly carry out drives against the fake licensees.

Representatives from home, education, and expatriates' welfare and overseas employment ministries were also engaged in the discussion to produce skilled drivers and meet their demand abroad.

Around 70,000 drivers have so far gone abroad with jobs and many of them are facing difficulties for carrying fake licences, said representative of expatriates' welfare and overseas employment ministry.

Plane crash in India kills ten

Ten people including all seven onboard a small civil chartered aircraft were killed when the medical ambulance flight to Delhi from Patna crashed into a densely-populated residential area near Faridabad, about 30km from here, due to bad weather last night. Faridabad's Sub

Divisional Magistrate Pradeep said the incident occurred when the P-12 turboprop aircraft belonging to Delhi-based Air Chartered Services India Pvt Limted crashed in Jawaharnagar locality shortly before landing at Indira Gandhi International airport in Delhi.

Two persons were also injured in the crash.

The persons who lost their lives on the ground are believed to be residents of the houses hit by the plane.

According to Delhi airport sources, the airplane lost control and nosedived from a height of about 8,000 feet 15 minutes before landing. There was strong gusty wind due to a dust-storm at the time of the crash.

The plane caught fire as soon as it crashed on two houses.

The airplane was ferrying critically ill patient to Apollo Hospital in New

Besides the two pilots, two doctors and two medical attendants accompanying the patient were on board.
