Judge Mohammad Zohurul Haque of the Senior Special Judge's Court yesterday passed the order after Koko's lawyer Sanaullah Miah submitted a petition seeking adjournment of the hearing as he had done earlier.

In the petition, the lawyer said the HC on June 9 last year issued a rule upon the government to explain why the proceedings of the case should not be declared illegal after filing of a writ with the HC challenging the legality of the case.

The hearing on the rule is still pending at the HC. So, he prayed for an adjournment of the hearing, the lawyer said.

The court yesterday also told the defence lawyer that it would frame charge against Koko, if they fail to submit any HC order by June 26.

But Additional Public Prosecutor Shah Alam Talukder appealed to the court for framing charge against the accused.

The National Board of Revenue (NBR) on March 1 last year filed the case against Koko for evading income tax on his income of Tk 52.39 lakh for fiscal years from 2002-2003 to 2006-2007.

Last year, Prime Minister Sheikh Hasina accused microcredit organisations of sucking the blood of poor, apparently pointing the finger at Grameen Bank.

But in an interview with the BBC's Lesley Curwen, Yunus said, "I would say she has been badly advised. She did not have proper information. If she had, she would not have that idea about Grameen Bank."

The microcredit pioneer wished if he had the time with her to explain and show her what Grameen Bank actually is, the situation would have been completely different since the prime minister is an intelligent person.

The founder of Grameen Bank said he wished he could have a very smooth and pleasant transition. "That is what I was looking for, as it is a huge organisation with 8.3 million people [clients] nationwide and 25,000 staff."

He said nobody wants to do anything that rocks and shakes Grameen Bank, which he has been running for the last 34 years.

Yunus said the sudden resignation could make people very nervous. "This is a bank not like other banks. This is a bank which is based on trust. Everything is done on the basis of trust."

Yunus said the accusation of being a blood sucker created a lot of tension in the country, as the government is very cautious in dealing with Grameen Bank.

He also shrugged off claims that Grameen Bank charges exorbitantly high interest. "The review committee [formed to report on Grameen Bank activities] came with the conclusion that we have the lowest interest among all microfinance institutions in Bangladesh," he said.

# BNP to revamp Dhaka city unit

The BNP high-ups have decided to expand the newly formed convening committee of BNP's Dhaka city unit to accommodate more leaders and remove intra party conflict centring the new committee, said party insiders.

They said more leaders will be included as joint convener of the committee but the decision will be implemented after the party Chairperson Khaleda Zia's return from the US as she will finalise the names of new leaders for the committee.

Asked about the possible expansion, the unit convener Mayor Sadeque Hossain Khoka, also vice-chairman of the party, yesterday said the committee will be expanded in different ways and everything will be done as per direction of the chairperson.

Meanwhile, Khoka took an initiative to minimise gaps with his intra-party rival former mayor Mirza Abbas and his followers. The party activists are considering such initiative a good sign for the crisis riddled city unit.

The newly appointed city

convener already talked to Abbas, also a member of party's national standing committee, over phone and visited his ailing mother at a city hospital last week.

During the visit, Abbas congratulated Khoka for being nominated as the chief of city committee, said close aides of both the leaders.

On May 15, the main opposition party announced the 21-member convening committee with Khoka as convener for the city unit, which was running without any committee since June 2008.

The BNP chairperson could not announce the committee for the last two and a half years due to the internal conflict as the unit was absolutely divided by two factions led by Khoka and Abbas.

There is an allegation that few names had been dropped out from the list after Khaleda's departure on May 14 but pro-Abbas leaders accepted the committee due to firm stance of the chairperson. Even Khaleda enquired from the UK whether any one in the party opposed her decision.

meetings mentioned that in case of some projects, allegations of corruption and fraudulence were raised to the development partners during the tender process.

Corrupt practices of the bidder in collusion with others in the purchase process were proved in the World Bank-funded Clean Air and Sustainable Environment Project, and the ministry concerned had to go for a re-tender.

In the case of Dhaka-Chittagong Roader Development Project, allegations of similar practices were raised to the development partner, which resulted in changes to the bid document and floating of a fresh tender.

Besides, complaints were made about fraudulence in the tender process of Emergency 2007 Cyclone (Sidr) Recovery and Restoration Project. A study on the project also took two years.

Finally, allocation of foreign funds for the three projects in the current FY was slashed to 50-66 percent during revision of the Annual Development Programme (ADP).

Implementation of projects with faulty designs is also delayed as the designs need changes.

The review meetings identified that lack of knowledge of the officials concerned about Public Procurement Act (PPA) and relevant rules and procurement guidelines also

delays project implementation.

Projects which got allocation of excess funds included Avian Influenza Preparedness and Response Project, Construction of Siddhirganj Power Plant and Urban Public and Environmental Health Sector Development Project.

Besides, designs of these projects were changed and project documents were faulty, resulting in delay in their implementation process.

The review also found that concurrence of the development partners in procurement plan formulation and approval is not taken before the start of a fiscal year although it can be done.

And delay in land acquisition and court stay orders delay project implementation in many cases.

The ERD official said the ministries have been told that on completion of the formalities regarding foreign aided projects, the ministries or other agencies concerned have to keep direct contact with the development partners. If any assistance from the ERD is required, it has to be informed immediately.

The planning ministry is going to prepare new guidelines for project approval and implementation, which will come into effect next year. The guidelines will seek to address the problems identified at the review meetings, said the official.

Sensing the drive, however, another teacher Subol Chandra of Sonahat Degree College fled Rangpur last night, said police.

Subol was appointed as an examiner by Dinajpur Education Board, said Rangpur Superintendent of Police (SP) Saleh Mohammad Tanvir while briefing the press yesterday.

After contacting the examinees over phone, college teacher Ashraful and his colleague Subol came to Khalea with the 88 answer scripts under their possession, said the SP.

They gathered at least 50 of the 88 examinees at a house in the village and allowed them to rewrite their answer scripts in exchange of Tk 3,500 each, he added.

Asked, Ashraful said many examinees wrote their mobile numbers in the answer scripts during the English 2nd paper board exams on April 12 in the expectation that the examiners might call them with a mercy deal.

He said one local Aminul Islam, who was also arrested, and his friends helped him arrange the accommodation and later demanded Tk 3 lakh for the help.

When he denied giving

the money, they informed the DB police of the incident, said Ashraful.

Police also arrested the house owner Rizvi Ahmed, who was an acquaintance of teacher Swapan.

A case was lodged with Kotwali Police Station in Rangpur under Public Examination Act, 1980. The arrestees were sent to Rangpur Central Jail upon their bail rejection by a Rangpur court yesterday.

During the second phase of the raid on Thursday afternoon, Rab busted a Huji den at Kalma of Ashulia and recovered 16 handmade bombs, 24 cocktails and a hoard of bomb-making chemicals.

The arrestees had arrived at Savar to join four other Huji operatives at a rented house in Ashulia. Commander Mohammad Sohail, director of Rab Legal and Media Wing, said at a press briefing yesterday.

Huji kingpins planned to carry out subversive operations by forming a covert alliance with some political parties, he said based on the information Rab gathered during remand of former Huji leader Rahmatullah alias Sheikh Farid.

In response to a petition, the HC also issued a set of directives to the authorities to stop use of harmful chemicals in ripening and preserving fruits and sale of those ripened fruits.

On May 10 last year, the same court passed similar directives following a writ petition filed by Human Rights and Peace for Bangladesh.

The city markets are flooded with various summer fruits, including mangoes, jackfruits, litchis, pineapples, watermelons, papayas and bananas, many of which are artificially ripened with toxic chemicals.

Experts say, multiple health complexities including problems in the kidneys, heart and liver could develop and diseases like ulcer and gastric can form if people eat fruits ripened by carbide, ethephon or ethylene oxide.

Expressing concern, the court yesterday came up with the directives following a supplementary petition to the original writ petition filed by the same organisation.

Citing newspaper reports, the new petition prayed to the court to revive its last year's directives to stop the use of harmful chemicals in fruits. It said the use of harmful chemicals stopped last year after the HC directives but those directives are not being properly enforced now.

A mobile court reportedly recovered a huge quantity of contaminated fruits from a market in the capital and destroyed those a few days ago, it said.

An HC bench yesterday ordered Bangladesh Standards and Testing Institute (BSTI) and Rapid Action Battalion to continuously monitor fruit depots in Dhaka so that contaminated fruits cannot be stored or sold.

The bench of Justice AHM Shamsuddin Chowdhury Manik and Justice Gobinda Chandra Tagore asked for everyday tests of fruits at wholesale depots in the capital.

It also ordered the chairman of the National Board of Revenue to take immediate steps to monitor spots through which fruits are imported in the country.

It directed the deputy inspector general of police in Rajshahi to deploy police forces in the commercial mango orchards to stop the use of chemicals for ripening mangoes.

It asked the food and home secretaries to form a committee comprising representatives of those ministries to make recommendations for the government in this connection. It asked the secretaries to report to the court within 15 days.

The secretaries were also asked to constitute vigilance teams to monitor the fruit markets.

Furthermore, the HC directed the inspector general of police to take steps for filing cases against people responsible for the use of chemicals in fruits and asked him to report to the court within 15 days.

On May 10 last year, the HC also issued a rule upon the government to explain as to why it should not be directed to take effective measures to protect public health by stopping the use of chemicals on fruits and why their inaction in this regard should not be declared illegal.

The rule is, however, still pending with the HC, petitioner's counsel Manzill Murshid told The Daily Star yesterday.

During the hearing yesterday, Manzill told the court that fruits such as apples, mangoes, grapes, bananas and papayas play an important role in maintaining good health of citizens. But some corrupt and dishonest traders are using chemicals like carbide to ripen them and formalin to elongate their shelf life.

He said the mangoes are reportedly being artificially ripened with chemicals. On June 1, 2008, the HC in a verdict directed the government to set up a food court in every district and appoint sufficient food analysts and inspectors in all districts within two years to prevent food contamination.

The court had also directed the government to inform the court by July 1, 2010, about its progress in complying with the directives. The government has not implemented the HC verdict till date, Manzill said.

# Toxic ships

Coast. The same year its Greek owner changed the name to Gulf Jash.

The Gulf Jash with an IMO (International Maritime Organisation) number of 8309816, now off Vietnam, is believed to be carrying toxic chemicals, including mercaptans that attack the respiratory system, hydrogen sulphide that damage the central nervous system and caustic soda having a wide range of health effects on humans.

Global Marketing System (GMS), a US company specialised in brokering of vessels for demolition, has confirmed the sale of Gulf Jash but refused to disclose its final destination.

The NGO Platform on Shipbreaking, a global coalition of human rights, environmental and labour rights groups, raised a worldwide alarm on May 24, saying the ship contains tonnes of hazardous asbestos, PCBs, toxic paints, fuel and chemical residues.

Jenssen Ingild, coordinator of the platform, said Probo Koala contains toxic substances dangerous to environment and Bangladeshi workers who work without protective measures.

The vessel is the symbol of illegal toxic trade throughout the world and Bangladesh must say no to it, she added.

Syeda Rizwana Hasan, chief executive of Bangladesh Environmental Lawyers' Association (Bela), told The Daily Star over the phone from China yesterday that following a tip-off from international watchdogs, her office has warned the Bangladesh authorities about the sale of Gulf Jash to an unspecified Bangladeshi

Officials of the Department of Shipping, one of the several departments in Bangladesh that issues no-objection certificate to scrap ships, were unable to confirm anything about Gulf Jash.

**2006 ABIDJAN CRISIS**

A Dutch-based oil and commodity shipping company Trafigura Beheer BV had chartered Probo Koala for caustic wash, a controversial process for treating a product to remove impurities. The company needed to reduce high mercaptans sulphur levels in low grade cokernaphtha.

As land facilities did not allowed, Trafigura decided to carry out the dangerous operation on board the vessel.

At one point, Trafigura attempted to get rid of the toxic residues in Amsterdam. The Dutch government asked Trafigura to pay for the cleaning costs.

At this stage, the company chose to offload its toxic wastes in Abidjan.

The gas caused by the release of these chemicals is blamed by the UN and the government of Ivory Coast for the 2006 health crisis.

The dead are Sujan, 12, son of Julhush Uddin and Naosher, 13, son of Rustom Ali of Kuickkhira village under Shandhanpur union.

The incident happened around 6:00pm near the field firing range during an army training when some boys including the dead and the injured entered the restricted area, said Mominul Islam, officer-in-charge of Ghatail Police Station.

The injured were taken to the Combined Military Hospital (CMH) at Ghatail. An Inter Services Public Relations (ISPR) press release said the explosion occurred as the boys tried to break some abandoned parts of some bullets they collected from the firing range for "financial gain".

They entered the "danger area" paying no heed to the warnings, it added.

The army administration gave assurance of bearing the treatment cost of the injured and providing other financial assistance.

Police arrested Picchi Masud, Jewel Jamadder and some other bigwigs several times, but they managed to secure bail, he added.

The accused are securing bail as police fail to frame strong charges against them, observed Ibrahim Hossain Babul, former general secretary of Chittagong Bar Association.

He suggested framing charges under the Special Powers Act, 1974 to ensure the criminals are not freed until the trial is complete.

A Chittagong Port-bound van carrying 17,000 pieces of T-shirts in 555 cartons was hijacked from the city's Pahartali area on May 20, SM Tanvir Arafat, assistant commissioner of Double Mooring zone police, told The Daily Star.

The van was found abandoned at Bayezid area on that afternoon while Pahartali police picked up the driver and five others at night. They recovered the stolen goods worth Tk 50 lakh from a house at Chandgaon residential area.

In another incident on April 15 a van left Incom Trade International Depot at Patenga with 51 bales of cotton for Sadia Spinning Mills at Bhaluka of Mymensingh.

"It may take one week maximum to submit the charge sheet, and I think nothing is going to be changed, as it was prepared after four years of investigation," Majid, also an Awami League lawmaker, told The Daily Star.

A reliable government source on condition of anonymity said the charge sheet is likely to be placed before Hasina prior to its submission before the court, reports our Sylhet correspondent.

The prime minister will go through it, the source said, adding, the government has no intention to make any changes in the charge sheet.

Former state minister for home Lutfozzaman Babar and thirteen others have been included in the supplementary charge sheet, Investigation Officer (IO) Rafiqul Islam said on Wednesday.

"I won't accept the charge sheet if it's not revised and names of the masterminds behind killing are not incorporated," Asma Kibria, widow of the slain AL leader, said yesterday.

She reiterated her call on the government to take assistance from foreign experts to identify the actual culprits.

Talking about the delay in submitting the charge sheet, Home Secretary Abdus Sobhan Sikder said it will be submitted soon.

IO Rafiqul Islam could not be reached over the phone despite repeated attempts for comment.

Sources say he was called to Dhaka by the "higher authorities who were embarrassed" following Asma Kibria's statement denouncing the charge sheet.

The Criminal Investigation Department (CID) was to submit the charge sheet in the sensational murder case on Wednesday. But it deferred the filing as Asma Kibria expressed dissatisfaction over the charge sheet, Majid said.

Kibria was killed in a grenade attack on a rally in Baidyer Bazar in Habiganj on January 27, 2005.

Abdul Mazid Khan filed two cases with the Habiganj Police Station the next day.

that Unesco is going to set up Shaheed Minar, said her Press Secretary Abul Kalam Azad.

your news you stated that Mr Chowdhury 'threatened to exact revenge on the investigators of the International Crimes Tribunal yesterday [May 10] during interrogation over his involvement in crimes against humanity.' SQ Chowdhury is not yet 'implicated/accused' as a war criminal under the International Crimes (tribunal) Act, 1973, it said.

It said there was no basis of 'The Daily Star's' comment. "Moreover, had Mr Chowdhury threatened the investigators, that would have been an offence in itself which none of the investigators raised officially against him. Therefore, the mouth-watering heading of the news and the contents in the first paragraph is entirely false and manufactured," added the rejoinder.

The rejoinder claimed that the information of misbehaving with the members of the investigation agency is also not correct and denied that SQ Chowdhury addressed any of the officials as tumi (an informal way of addressing someone); neither did he behave like a "mad man" or told any of the investigators "I will get you someday". **OUR REPLY**  
The Daily Star correspondent inserted no personal comment in the story. All of it had originated from the investigators. Some of the information was shared officially by the investigators, while the rest derived from sources preferring anonymity.

Abdul Hannan Khan, coordinator of the investigation agency told reporters on record that SQ Chowdhury shouted most of time during interrogation and lied while replying to investigators' queries on his involvement in crimes against humanity.

Hannan also told reporters that interrogators extracted valuable information about his involvement in some of those crimes against humanity.
