

RECRUITMENT 'SCAM' AT DINAJPUR MEDICAL Principal's room ransacked, two teachers assaulted

Agitated job seekers and their hired goons yesterday went on rampage at Dinajpur Medical College and Hospital (DJMCH) as some candidates were not selected in the recruitment test for the posts of third and fourth class employees, sources said.

The gang assaulted at least seven people including two professors, ransacked a few rooms and damaged the furniture.

The DJMCH authorities recently recruited around 30 people to various posts, list of which was officially published yesterday.

An employee of the DJMCH, seeking anonymity said local Awami League leaders submitted a list to the principal of DJMCH, but majority of their choice were not entertained.

Faruquzzaman Michael, organisational secretary of district AL, however, refuted their involvement, and alleged that the candidates who bribed the hospital authorities only got the jobs.

Sources at DJMCH said Dr Buland Akter Tagar, assistant professor of ENT department and Prof Moudud Hossain of surgery department and Dr Ahad Ali, general secretary of Bangladesh Medical Association (BMA), were assaulted. Others include staffs Md Mokhlesar Rahman, Mirza Salam, Arif Akter and Ali.

Witnesses said a gang of 10 to 15 gathered in front of the medical college in the morning.

They entered DJMCH administrative building around 10:50am and

started looking for principal Prof Dr Hamidul Haque Khandakar.

However, sensing trouble, the principal took shelter in the store-room.

The gang first entered the principal's room and locked in an altercation with Dr Buland Akter Tagar, Dr Prof Moudud Hossain and Dr Ahad Ali over the recruitment issue.

Sources said, during the heated exchange, the gang was demanding return of money paid to the authorities for providing jobs to their candidates.

As the DJMCH authorities refuted their claim of receiving bribe for providing jobs, the gang ransacked the room of the principal and damaged furniture. During the 10 minutes rampage, they damaged furniture also in a few other rooms.

Contacted, Md Abdul Kalam Azad, accountant and a secretary of DJMCH said that two factions of district BMA went on rampage. He declined to elaborate and switched off his cell phone.

However, Dr Shahidul Islam, president of Dinajpur BMA said the organisation is not divided. "So, the claim of DJMCH authorities is ridiculous," he added.

This correspondent tried to contact the principal of DJMCH over cell phone but he was not receiving any call.

Hasan Shamim Iqbal, officer-in-charge of Dinajpur Sadar police station said no case was lodged till filing of this report yesterday afternoon. "However, we have deployed necessary force in the area to avert further trouble," he added.

A man 'killed' his younger brother in Gopalganj while another was sentenced to death for similar offence in Bagerhat on Monday.

A man was killed allegedly by his elder brother following a family feud at Madhur Nagra village in Kotalipara upazila of Gopalganj on Monday.

The deceased was identified as Hiru Mollah, son of Abul Hossain Mollah of the same village, reports UNB.

Officer-in-charge of Kotalipara police station Tota Miah said, Hiru Mollah locked in an altercation with his elder brother Kamal Hossain over a trifling matter Monday morning.

At one stage, Kamal Hossain hit in the head of Hiru with a hammer, leaving him critically injured.

Hiru Mollah died on the way to the hospital. After the incident Kamal Hossain went into hiding.

Police sent the body to Gopalganj Sadar Hospital for autopsy. A murder case was filed with Kotalipara PS in this connection.

In Bagerhat, a court sentenced a man to death on Monday for killing his younger brother over land dispute in 1999.

The convict was identified as Iliaj Sheikh, son of Asmot Ali Sheikh of Chandipur village in Moreganj upazila.

According to the prosecution, elder brother Iliaj hacked his younger brother Sheikh Oliur Rahman to death following an altercation over the possession of a land on March 23 in 1999.

Victim's another brother lodged a murder case with Moreganj police in this connection.

After examining the records and witnesses, additional district and session court judge Md. Belayet Ullah handed down the verdict.

The convict was tried in absentia.

Water crisis in most areas of Moulvibazar town

60 pc locality has no supply line while tube wells are inoperative

Water crisis grips the residents of Moulvibazar town as 60 percent of the municipality area is outside pipeline water supply coverage while tube wells in most places remain inoperative due to fall of underground water level in the dry season.

"I deposited the money for demand note three years ago, but waiting for a water connection till now. Water supply pipe line was installed in their area many years ago. But the municipality authority is not interested to give new connections," Syed Motahar Ali, a resident of Paschim Dharkapong in Moulvibazar town.

Many residents of the area applied for water connection 10 to 12 years ago, but they are yet to get it, he said.

Several residents of Barhat in the town said in absence of water supply

pipeline they have to depend on tube well water but their tube wells are not functioning as underground water level has fallen during the dry season.

Tube wells in the female students' hostel of Moulvibazar Government College have also become inoperative due to receding of underground water level.

"Only 40 percent area of the town has been brought under pipeline water supply system. Source of water for the people in other areas of the town is shallow and deep tube wells," said Bijoy Krishna Deb, superintendent of the water supply section of Moulvibazar municipality.

"The pipeline water supply has not reached the western side of Saiyerpur under ward No-1, Sunapar and Borobari under ward No-2, Raghunandanpur and Nawagaon under ward No-3, Barhat under ward No-6, Dharkapong and

Mostofapur under ward No-8 and Barkapong and Shekhergaon under ward No-9," he said.

New supply lines are being installed and replacement of damaged old lines is being done under a water supply and sanitation project that started in 2009. The project will continue till 2012.

Besides, an initiative has been taken up to install a plant for purification and supply of surface water at an estimated cost of Tk 9 crore 86 lakh, he said. The plant to be set up at Matarkapong will purify water from the Monu River and it will be supplied through pipeline to the town dwellers.

After its full implementation, pipeline water supply will cover 90 percent areas of the town, the official added.

The Asian Development Bank has approved the project for purification and supply of surface water in Moulvibazar town, said Mayor Fayzul Karim Mayun.

MUNSHIGANJ POLL Ballot box snatched, rifle looted from police

Criminals looted a rifle from police during a poll-related clash which left a policeman and Ansar member on Latfadi High School premises in Sirajdikhan upazila on Tuesday night.

Locals said several hundred supporters of union parishad chairman candidate Hafez Fazlu, equipped with sticks and sharp weapons attacked Latfadi School poll centre and snatched ballot papers and ballot boxes.

As police attempted to resist the attackers and recover the ballot boxes, the criminals attacked police and mercilessly beat up a policeman and an Ansar leaving them seriously injured.

Police official Mosleuddin confirmed the incident. He said they recovered bullet but the rifle could not be retrieved.

Power plant plan

The government has decided to set up a 15 megawatt capacity power plant at a cost of Tk 120 crore in Hajiganj upazila of Chandpur district during the 2011-12 financial year.

Major (retd) Rafiqul Islam MP told BSS that the scheme was approved by the Cabinet at a meeting recently.

He said the work of the power plant project would start next month and it is expected to be completed within a year.

After implementation of the project entire Hajiganj and Shahrasti upazilas will be covered by electricity.

Six Huji militants jailed in Khulna

A court has sentenced six militants of banned Harkat-ul-Jihad to rigorous imprisonment in a case filed against them under Explosive Substances Act.

Md. Sekandar Ali, Judge of the Khulna Divisional Speedy Trial Tribunal delivered the judgment at 5:30 p.m. on Tuesday.

The six convicts are Ali Ahmad, Jahangir Alam, Omar Faruque alias Laden, Abdul Quddus, Abul Kalam Azad alias Bulbul and Md. Amirul Islam.

Ali Ahmed was sentenced to suffer 20 years of RI and fined Tk 20,000, in default, to suffer more two years RI while Jahangir Alam, Omar Faruque alias Laden, Abdul Quddus, Abul Kalam Azad alias Bulbul and Md. Amirul Islam.

All the six Huji militants were present at the court judgment.

The prosecution story in brief is that Rapid

Action Battalion-6 and police in a joint special operation in Jhenidah, Jessore and Kushtia districts arrested Huji militants Jahangir Alam, Omar Faruque, Abdul Quddus, Abul Kalam Azad and Md. Amirul Islam on October 29 in 2007.

Later, Rab and police arrested Huji leader Ali Ahmad on the same day from his house at Teordaho village under Jhenidah Sadar upazila and recovered 15 grenades from his possession.

S. I. Abul Kashem of Jhenidah Sadar PS filed a case in this connection as complainant under the Explosive Substances Act.

Chargesheet of the case against six accused was submitted on November 29 of the same year.

The case was later transferred to Khulna Speedy Trial Tribunal on December 21 last year.

The judge recorded statements of 15 out of 21 prosecution witnesses during the trial of the case.

DEATH OF TRAINEE TEACHER ANAMIKA

Superintendent of PTI hostel sent to jail

Superintendent of Sunamganj Primary Training Institute (PTI) hostel Abul Quasem Miah was sent to the jail hajat after judicial magistrate Md Abdul Halim rejected his bail prayer in Anamika case yesterday.

Abul Quasem was arrested Tuesday afternoon after Subol Das, father of Anamika Das, a government primary schoolteacher also a trainee, filed a case with the Sunamganj Sadar PS, accusing the government-run PTI chief of killing his daughter.

He alleged that the superintendent had raped Anamika before killing and later hung her from the ceiling fan.

The hanging body was recovered from Room 402 of the PTI hostel Saturday last.

The deceased and her sister Dipika Das, also a schoolteacher, were staying at the institute hostel because of training.
